Dear Mrs. Peel:

We have now gotten the revised documents of the Committee for Consideration of Greater Unity in final shape. A copy of this report is being enclosed herewith for your study.

In presenting this matter to the various mission boards, the various members of the Committee here who are concerned with the presentation have felt that the first presentation must be made to the constituent mission boards before any attempt is made to ask the individual college trustee boards to give consideration. It has been possible for us to talk this matter over with Mrs. Diefendorf, and she feels that it will be best to present these documents first to the group in the Woman's Foreign Missionary Society who are particularly related to China questions. Then a little bit later, additional documents would be sent by Mrs. Diefendorf to the remaining membership of the Foreign Division. This would be done in ample time, so that study could be made prior to any meeting that might be held during General Conference at Atlantic City.

The presentation would be made at a meeting of the Woman's Foreign Missionary Society at Atlantic City, at which time Mrs. Diefendorf suggested that Dr. Eric North, who is Chairman of the Committee, be present to discuss the questions arising from consideration. Mrs. Diefendorf has promised to write you an additional letter explaining the method of presentation from her viewpoint. Since Mrs. Diefendorf is here where we can confer with her frequently, it seems wise for us to follow her suggestions, which we are very happy to do.



I am sending this letter to you in Philadelphia by special delivery in response to your question regarding the election of Hwa Nan College representatives for the coming year. All the members of the Hwa Nan Board so appointed by the Women's Foreign Missionary Society automatically become members of the Associated Boards.

The appointments which need to be made by the Hwa Nan Board are those related to the standing committees of the Associated Boards, and should be nominated from among the members of the Hwa Nan Board. For each committee there should be one regular representative nominated, and one alternate. The committees of the Associated Coards are as follows:-

Executive Committee
Committee on Finance
Committee on Promotion
Committee on Christian Character, Staff and Curriculum

Aside from the Hwa Nan Board, there are certain appointments to be made by the Woman's Foreign Missionary Society to other college boards in which the Society is cooperating; such as, Ginling College, Cheeloo University, Yenching College Committee, etc. I have had an opportunity to talk all these matters over with Miss Robinson, and I think she is fully informed about the appointments which need to be made. I have also talked to her over the phone today and have told her of your question. She will be in a position to confer with you about any item that is not entirely clear.

Thank you very much for the copy of the Hwa Nan report to the Board of Regents of the University of the State of New York. This completes the set of reports from the various colleges which are sent to Albany each year, and we are very happy indeed to have this for the completion of our files.



Excerpt from letter received March 17th from Mrs. W. P. W. Williams, Foochow, describing the fire at Hwa Nan on Sunday, February 9, 1941 which completely destroyed the main building of the college - Payne Hall.



"....at 5:10 p.m. Lek So called my attention "Look, look, fire burn house, very big," and there was Hwa Nan in flames. David and I tore over with the most awful pain inside. Needless to say, for the fire must have been going about an hour by then, the crowd was enormous, and I've no idea how many fire-brigades were at work. When hours later they decided that no more could be done, and all that was possible was to prevent Trimble Hall and the other dormitory from catching fire, they called off all the men and said 'we are only leaving 8 brigades, but they will prevent the fire from spreading' so you will gather there was no lack of helpers.

It broke out in the roof, as to the cause I will say nothing for I do not know what has been discovered, and to repeat rumours is no help. People must have worked like mad, for when we arrived there were masses of books and furniture on the lawns, how they got out so much I can't think. It was largely from Trimble Hall, but there were hundreds of books rescued, chairs and tables and pianos, but I think I heard Beth say that pracically nothing from the second storey had been saved. You perhaps know that many of the Chinese had brought along their treasures in trunks and put them into the attics, and when Beth said that she could take no responsibility, they had replied they felt sure that H. N. would be safe. One woman Emily told me had lost 30,000 dollars' worth of heirlooms. And as to Hwa Nan's loss in microscopes and equipment of all kinds, that you can picture for yourself.

Miss Trimble sat on the lawn calm and serene, and watched that building blaze till long after dark. Her indomitable courage and quiet acceptance of the disaster were an inspiration to us all. She said 'Hwa Nan has lost nothing eternal. It is only a building. Thank God no lives are lost. But indeed we do thank God for Christians like her who live out their faith in God, and refuse to place security in money or material things. Lucy had just come out from the city, and the shock to her was terrific. But Isbelieve that she too is seeing in this calamity which God did not prevent, as He of course could have done, a tremendous opportunity for Hwa Nan to serve China. China's trouble like England's. is greed, which comes from placing security in money, and all that money can buy. IF Hwa Nan staff can face this loss, public and private, and let Christ give them victory over it, I believe they will grip their students in a way that will last. For the students are at an age when impressions go deep, and if they glimpse the vision of what real genuine Christianity means, they will see that to have security in God, is to be able to face loss and disaster like this, and never turn a hair. Godconfident, God-sure and God-conscious. I know you will pray that it will be used by God to help all China through these students, and then we shall all bless Him for not preventing this fire.

I woke twice in the night to see the blaze still bright, so it must have lasted at least ten hours, and nothing was saved of the building; you know how they draw water from wells and empty it into trucks and then pump it up - pretty futile for dealing with such flames. It was the most marvellous spectacle I've ever seen. Both dormitories have escaped by the mercies of God. Ethel has come down of course, You will hear from others I'm sure, but I felt I should write a bit about it - and yet we do need to keep things in proportion, and when we remember Europe and all that Germany and England are suffering now, this is but one college.

My dear Dr. Garside: I am sure that you must have received Bishop Gowdy's message regarding the tragic loss that has befallen Hwa Nan. It was an overwhelming blow, from which we are still staggering. Daily we remember new things that have been lost, both school and personal. It was all a very hard terrifying experience, but it has taught me in a new way, how one may rely on one's friends, and what power they have to

lift one up to the Father. Someway in the midst of all my sorrow and discouragement, I had a sense too, of so many of my friends in the United States sharing the burden with me even though at that moment-you did not know of our disaster.

I am thankful to be able to have our Board of Directors Meeting before Bishop Gowdy left. We held it just two days after the fire- and I was thrilled and lifted by the forward look of them all- and by their planning for a new and better building on the walls and fundations of the old. They took it all as a beginning-not an end, and they did encourage me so. Bishop Gowdy will be able to give you all the details that we know. Nothing new has come to light and the cause for it all remains unknown. But they and many of my friends have helped me to turn this desperate tragedy into a challenge and an opportunity, and we pray that we may not fail the Father in whatever new plan He has for Hwa Nan, as we are all very sure that even this dreadful destruction cannot long mar His pattern for the college.

Of course we realize the college is neither in its buildings or in its financial status, but both are pretty necessary. You will be seeing the new budget soon and I am sure you will do all you can to have it passed for us. We are very grateful for all what you and the members of Associated Boards and Hwa Nan Board of Trustees have done for us in the past. We are confident that your support and interest will be continued.

The plans for the new building are under construction, and rough estimate of the amount of money necessary ofr the re-building was included in our budget. They are planning to make the new building higher and most important of all to make it fire-proof, so that the tragedy of February ninth need

never be repeated or feared.

Details of living beside this wecked building and of gathering up the threads of our pattern again, are being gradually worked out. Some of it is a sorry business, but beyond the petty details shines the vision of a better Hwa Nan, and so with lifted eyes, we "press on ".

I am going back to Yenping immediately. I had expected then to proceed to Yungang to attend the Provincial Assembly- but since here in Foochow some of the friends have so urged me to go to Shanghai to the East Asia Conference instead. They feel that it is a real opportunity to put the college before the united church here, so I am a bit undecided. I must first go back to Hwa Nan and arrange some matters there before going to either place. The school term has started off well in spite of the handicap of the dean's illness, and I am hoping for an undisturbed term of work.

You will soon be receiving my annual report and certain letters telling tof happenings here. From them you will learn more about all that has befallen us. Please know, that although the blow was terrific- we are facing forward and Hwa Nan is very much alive and very much depending on all her friends in the States. This brings to you my sincere greeting and my very good wishes.

He is now asking us to clear up his uncertainty, so I am writing to you in order that we may have a clear understanding between us. We can handle the blanks and send them on to Hwa Man, with the request that they return them to us, and we will send you a copy; or we will send the blanks to you and let you handle the matter of sending us a copy when the information comes in.

Whichever way you desire to have it taken care of will be quite satisfactory to us, and I will inform Mr. Soper so his records will be straight.



I have at long last finished the set of cards for St. Paul, Minneapolis and Duluth for you and have shipped them by express today. The Eastman Company has a store in the same block as Mr. Fuller's office and he would be able to get the film there.



When consideration was given to the allocation of the amounts to the several colleges concerned, the following action was taken:

\*AB-1220 VOTED that the amounts to be requested of the individual Boards of Trustees be referred to the Executive Committee of the Associated Boards for determination in the light of the allocations made to each college from the Sustaining Fund of 1941-42 and in accordance with the principles used for the years immediately past, with the understanding (a) that the total requested is to be the same as for 1940-41; (b) that pending the final assignment of costs to the individual Boards, in order to supply the necessary support for the Associated Boards, each Board will make payments for the first menths of 1941-42 on the same basis as for the current year, subject to adjustment in accordance with the final assignment of costs.\*

The appropriation made by your Board for 1940-41 was \$1,541.00.

It is hoped that the Hwa Man College Board of Trustees will be able to approve the request made in this action. You will note that a restudy of the shares for the different colleges is to be made soon.



Enclosed herewith are the minutes of the meeting of the Committee on Finance of October 17. These minutes were approved by the Executive Committee on November 10.

Notification has been sent to President Wang, particularly in relationship to action F-1279, section (f), with an explanation of the action and a statement that the funds are to be paid through the regular channels. Mr. Evans tells me that your Board considered, at its meeting the other evening, the request of the Associated Boards which is included in action F-1281 for the share in the Associated Boards' budget of 1941-42. This, you will note, is \$2,255. I think he also called your attention to a credit of \$48.29 resulting from action F-1284, section (b). This credit is on account of unused balances in the 1940-41 budget, and will be put on our books against the appropriation for 1941-42, thus reducing the payment by that amount.
