--- Wille case -1ecember 14, a young chinese soldier of 88 division came here for medical aid, he been woundet in the left arm by bullet, very serious, case -2-December 16, a chinese soldier og 18 division came here, he been in a party of 3, that had surrenderet and given up their arms to the japanese. but the japanese decidet to kill them, while the two of hes pals were killed, he escaped with a minor head wound, by faking dead. case -3-December 16, a chinese soldier of 41 division arrived here for help, he been woundet in the shoulder 10 days before, and gone without medical attendance since. case -4-December 17,a chinese soldier of the cummunication unit came here, woundet by bullet in left arm on Dec. 13, case -5-December 18, a woundet chinese soldier was brought here, he toll us the following story. He was a soldier of the standard division of Nanking, on december 13, he with 8 others had surrendered to the japanese, they were keept prisoners for 3 days without food and water, then they, together with other soldiers and civilians, about 200 in all, were made to walk to a place near purple hill outside Nanking, tthere they was lined up in 3 long rows for exsicution by machineguns, this soldier let himself fall down like been shot and acted dead when the firing was stopped, then the japanese poured some sort of acid all over the dead bodys, and set fire to to it, some of this acid was poured on this soldiers legs, as this outrage was done late in the afternoon, it was allready dark when the japanese had finised this, so in cover of darkness this soldier crawled away and came he here, As this is written, hes wounds are not yet healed, this acid inflicting a very painfull and difficult wound. to cure. case -6-December 19, a soldier of 87 division, woundet in two places, came here. case -7-December 23, a young soldier with two wounds, one serious, (fractured skull) came for medical aid, he toll us the following story, he was a orderly to a captain of the 87 division, on December 13, during the battle he found himself cut off alone in no mans land, near Tai Ping Men, suddenly confronted with japanese soldiers , he surrendered, papers in hes care was confiscated whereupon a soldier with a sword hit him several times on the head and neck he fell down unconcius, regaining hes sence later he found himself alone and able to walk. after 10 days of hiding by day, walking at night he came here. case -8-December 24, a soldier of of the canton army. 106 division arrived, woundet in the neck and shoulder by bullets. case -9-December 16, a chinese farmer came and asked if we could come to hes village about 5 kilometer away, we went, and there we found a young farmer with hes head nearly cut off, we gavi him first aid and had him brought here so we could look after him. Hes family toll us this story, on december 13, he with rest off hes family had come to our refugee camp to seek shelter, two days later he with other men had gone back to their village to fetch some rice, there they meet several japanese soldiers, searching for chinese soldiers, they said this young farmer was a soldier, and therefore he should die, so with a sword they attemted to cut hes head off, but hes high thick coat collar took some off the force from the sword, the japanese left him to die. This young farmer died on Jan. 1st. 1938 case -10-January 2, a chinese women 46 years of age was brought here by her husband, he toll us this story, he with hes wife, two sons, one of 16 years and one of 11, have their home in a village near the Hangchow, Nanking highway, on december 10, the husband and eldest son was taking prisoner by japanese soldiers, to perform manual work, she herself with the youngest son

case -10- cont. stated at home, on the evening of december 12, 4 japanese soldiers came to her house, they were drunk and demanded young women, outraged over not finding any, the shot and killed her young son, also shot at her one bullet hitting her left leg above the knee, breaking the bone, then the soldiers sat her home in fire, she managed to escape the flames, she spent several days in the open unable to mowe, until her husband returned without the eldest son, hes whereabouts unknown, her husband was unable to help her, no medical help could be obtained anywhere, about newyear the heard that they could get some help here, so her husband with the aid of several farmers carried her here, hovever by that time infection had set in so heavy, that there was 'nt much we could do, she died on january 19. case -11-January 3, chinese soldiers came, two of the 87 division one of 58 division, two was woundet, they told us this story, on december 15 they were captured by japanese soldiers, they together with many hundreds other prisoners was lined up on the embankment of yangtse river in Siakwan, Nanking, for execution by machineguns, this 3 men escaped the bullets and acted dead, the following night the crawled away and found a dugout in which the hidet, there the stayed until 1st of january, in their search for food they had found several handgrenates, which they had keept, on new years day 3 japanese soldiers entered their dugout, finding themselvs trapped, they throwed the grenates, killing two og the japanese. and then fleed, finally arriving here. case-12-January 7, two chinese farmers, father and son, came for aid, both had many head wounds, caused by swords, they toll this story, they are staying in our refugee camp, the night before they had gone back to their village to fetch some foodstuff, there the meet some chinese bandits, that wanted to rob them of the food, when trying to defend this the robbers using a sword attached. case-15-January 10, an old chinese farmer came, woundet in the shoulder and right hand by bullets, he said, that on the same day early in the morning many japan japanese soldiers came to hes village demanding pigs, chicken, he told them xx that they did not have any more left, then one soldier just fired one shot after him, wounding him, and killing a farmer standing hehind him. case -16-January 10, a young chinese women came, she said, that while working behind her house, she heard the cry, " japanese are coming" so she ran to hide, a soldier must had seen her for a shotswas fired, one bullet wounding her hand case -17-January 14, one old chinese farmer came for aid, he toll us this story, on the same day aerly in the morning several japanese soldiers came to hes house and asked for girls, he offered them vine and cigarets, which they tok, but girl he could not help them with, as there was none, but they insisted on him to furnish them with girls, so on hes knees he again told them he could not, wherefor they soldiers started to shot, two bullets hitting him, one trough the lung, and one trough hes sex organs. case -18-January 14, a small boy, 5 or 6 years of age was brought here, his father told this story, while at home, japanese soldiers came into their farm, to loot foodstuff, as they could not catch the chicken, they used handgranates to kill the chicken, one handgrenate explodet near this little boy, seriously wounding him all over the body, tearing out one eye, etc. as hes condetion was grave, much infection had set in, I decidet to bring him to Nanking by our motocar, arriving at the chung san men, I was refused entry, so I begged the gaurd to send the child to the hospital for me, also that they refused to do, and when they ordered me to leave, I left, but I di not give up, I went around the city to the tai ping men, where I at high speed went past the sentry and no actempt was made to stop me, so I went to the American Univ. hospital, where Dr. Wilson took care the child, case -19-January 14, farmer woundet in lefthand same time and place as child.

case -20-January 15, one young chinese farmer woundet in the head, came for aid , he said, that on the 12. while walking on the highway, he was arrested by jap. soldiers and ordered to find young girls for them, as he failed to do so, they soldiers beat him up case 22-Janusry 15, a farmer boy came, as he is not able to hear, he wrote us this story, while walking across a field he was shot at, one bullet going trough hes left arm, japanese soldiers on the highway had propably called him. case -23-January 16, one chinese farmer with a bullet in hes left arm, shot on jan.12 case -26-January 25, a chinese merchantcame, he said that on thr morning of the same date two japanese soldiers came to hes house in search for women as they did not find any, they slashed hes face with a bayonet in several places. case -28-January 21, one chinese farmer was brought here, he said that on jan. 13 he was on hes way home from our refugee camp, to fetch some rice, about 3 miles from hes villages he was suddenly shot upon by japanese soldiers, without any reason, one bullet entering above the hip going trough hes whole body, wounding vital organs, making it impossible for him to walk, he spent several days and night crawling on the road toward our refugee camp, he was found in a pityable condetion by relatives in search for him, all skin, flesh, baring the bones was woring off hes toes, knees and hands by dragging himself along on frozsan ground. case -29-Janusry 23, a chinese farmer came for aid, he told us this story, on the afternoon of jan. 22 several japanese came to hes house, asked for kerosene, as he did not have any, they ordered him to collect plenty of firewood and straw, and to arrange it within hes house, after doing so, the made him ignite it, therby causing hes whole home to burn down, while the japanese soldiers stood back laughing, before leaving they slashed him across the face with a bayonet, knocking out several upper teets and cutting hes face and lip. case -30-January 24, a chinese farmer with a woundet hand came, on the day before some japanese soldiers came to hes house demanding chicken, he held up hes hands as a sign that he had none, wherfor they shot him with a revolver. case -31-January 25, an old chinese women came, been woundet by japanese on december 16, one bullet in the left arm, breaking the bone case -32-January 25, on jan. 23 several japanese sailors landet from a boat in the yangtse river and went in search og young women, at one house they found an old women 64 years of age, as they did not find any young girls at her house they before leaving, shot at her, one bullet completely scattered her right ankle, , she was given first aid by someone, said to be an ex-sailor of the chinese navy, next day was brought here. case -33-January 26, an old chinese farmer, 64 years of age was brought here, on dec. 16 he was shot in the right leg by japanese soldiers, completely breaking the bone case -34-January 27, a young chinese farmer was brought here, he is staying in our refugee camp, on the day before he bee on hes way back to hes village to fetch some foodstuff, for some unknown reason, he was attack by a japanese soldier, this soldier cut him with a sword, inflecting serious wounds in hes head, arm, hand and side of hes left body.
