# M I N U T E S Fukion Christian University BOARD OF MANAGERS MEETING July 25, 1921 - Kuliang - Mr. Jones' Cottage.

present: Bishops Keeney and Hind, Dr. Gowdy, Revs. Williams, Talman, and Smith, and Messrs. Jones, Christian, Lacy, and Newell.

Chairman, Dr. Gowdy.

Prayer was offered by Bishop Keeney.

Minutes of Board of Managers for past year were read and approved.

Minutes of the Board of Trustees in New York were read by Pres. Jones.

Report of Finance Committee was read and approved.

President Hones read his report reviewing the growth of the University for the year. The report showed the University to be in a healthy condition, with a fine spitit on the part of both the faculty and the students. The report was accepted.

Report from the Assistant Treasurer, Mr. Blakney, was presented by President Jones. Owing to its incompleteness it was suggested that the report be circulated upon its completion.

Report of the Language Committee was read by Mr. Lacy and accepted.

The matter of the Union Language School was presented by Pres. Jones. The Committee, Messrs. Williams and Jones, was continued with the addition of Dr. Beard.

The matter of the affiliation of University teachers with the Missions was presented by Pres. Jones and the recommendation of the Committee, that the status quo be continued for another year, approved.

The budget for the proposed College of Education was read and discussed. It was voted to approve and to forward it to the Trustees.

The matter of providing for theological education in Fukien Christian University was discussed. Veted: to leave the matter for decision until after the Tri-Mission Conference.

Adjourned to meet again at 2 P.M.

In addition to those present in the morning, Rev. F.T. Cartwright was present for part of the session.

Pres. Jones presented the matter of the University providing a sub-freshman course for graduates of government and mission schools who have not had sufficient English to meet present requirements, but the Board dad not favor opening such a course this year.

Voted: to approve the course of study as printed in the catalogue of 1921.

Voted: to approve the plan of providing quarters for the workmen at Hui Gie, leaving it to the Finance Committee to receive estimates for the same, the cost to be charged to the building account of the University.

Vord: that Mr. Jones be our representative at the opening of the Peing Union Medical College, September 15, 1921.

wted! to approve the action of Pres. Jones in asking Dr. William I. hamberlain, President of the Board of Trustees, to represent the University at the inauguration of James Rewland Angell as President of Yale University.

Voted: that we ask the faculty to appoint proper representatives to the National Christian Conference.

Voted: that since the entire membership of the China Medical Board is to be in China this fall we invite them to visit Foochow during their stay and that Dr. Gowdy, President Jones, and Secretary Newell be a committee to draw up such an invitation and arrange for the visit.

Veted: that the above committee, with the addition of Mr. Williams, act as a Committee to present the case of Fukien Christian University to the Educational Commission (Prof. Burton, et al.)

Mr. Jones reported that according to the units provided by the different Missions, the representation of the Missions for 1921 is as follows: M.E.Mission - 3, A.B.C.F.M. - 3, C.M.S. - 1, and the R.C. in A. - 1. The coopted members for 1921 are as follows: Bishops Hind and Keeney, and Rev. W.P.W.Williams. A vote of approval was given.

Voted: that the University take over Mr. Lin's debt of not over \$900.00 at 6%, with the understanding that \$40.00 per month be held back from his salary until the amount is paid, and that his life insurance policy be held as security.

Voted: that we rent Mr. Nga Ung Siu's house for five months in the fall of 1921.

Voted: that we do not require Mr. and Mrs. Marian to go to Peking for their first year's language study.

Voted: that the matter of getting a Mandarin teacher for the Language School be left to the Language School Committee.

Voted: that the treasurer's books be audited from the beginning of the institution and that we ask Messrs. Bissonnette, Bosch, and Knoll to act on the committee.

Voted: that in the case of teachers supported in conjunction with the C.M.B. Mr. Jones bring the matter of the loss in exchange on salaries and allowances to the attention of the C.M.B. and request them to assist in meeting the loss.

Voted: that Mr. Beeman's furniture allowance be paid at the rate of 2 to 1.

Voted: that the expense of durniture repairs be borne by the individuals themselves.

Voted: that the matter of the rental of the University launch, "Fu-chu", be referred to the Finance Committee for recommendations.

y,ted: that in the case of Mr. Bedient's baby which died a few days after birth we pay the allowance for one month.

Voted: to appoint Mr. Knoll as Assistant Treasurer for the year 1921-22.

Voted: that the records of the Executive and Finance Committees be entered in the minute book of the Board of Managers.

Voted: that we unite in asking the C.M.S. to continue their grant of \$1,111.11 gold.

The approval of the Budget for 1922 by the A.B.C.F.M. and the M.E.M. was reported and also the plan of the Yenping Mission to become a participating mammam Mission as seen as finances permit.

Voted: to refer to the Executive Committee the matter of approving and forwarding to the Trustees the names of the graduating class of 1922.

President Johns read letters from Secretary Baylis of the C.M.S. and Secretary Deuchar of the Australian Branch in re the appointment of Mr. and Mrs. F. C. Martin to the University.

Voted: that in the matter of Mr. Neff's teaching in the University we accept the proposal of the A.B.C.F.M. that they retain Mr. Neff as a missionary and continue his salary and that of the \$1,400 Mexican due Mr. Neff as per agreement, the University pay \$1,000 Mexican to the A.B.C.F.M. and \$400 Mexican to Mr. Neff.

Officers for 1921-1922 were elected as follows:

### FUKIEN CHRISTIAN UNIVERSITY

#### BOARD OF MANAGERS

## AUGUST 22,1022

The meeting of the Board of Managers of Fukien Christian University was held at Kuliang at the home of President Jones, August 22nd, from 9 o'clock to 12 and from 2.30 to 5. Those present were Bishop John Hind(CMS), in the chair, Rev.W.L.Beard, D.D., (ABCFM), Mr.Herman Renskers, (RCA), Rev.G.H. Uong, (MEM), Mr.K.C.Ding, (ABCFM), Bishop F.T.Keeney, (MEM), President E.C.Jones, Mr.H.V.Lacy, (MEM), and Mr.G.M.Newell, (ABCFM).

Prayer was offered by Dr. Beard.

The minutes of the previous meeting were read and approved. The circular votes of April 20,1922 and June 23.1932, were read and approved.

President Jones first reported regarding the work of the Department of Missionary Training and it was voted that the work of this department continue another year. It was further voted that a committee of three be appointed to act as advisers to this department. Rev.G.H. Uong, Bishop Hind, and Dr. Beard were appointed on the committee, with President Jones to act as convenor for the committee.

President Jones next gave his report of the work of the University, which showed that the institution was having a good normal growth. Not only had students and faculty increased, but the students were coming from many more high schools than previously. Mr. Mills report on the new buildings was also read and accepted.

The treasurer's report was then read and, subject to auditing, was accepted. It was voted to authorize the president to make inquiries regarding accredited auditors, and report the matter to the Finance Committee for action.

The recommendations of the China Educational Commission affecting the work of the University were next taken up and the following motions were passed.

Par.203. Voted that the president and secretary write the Board of Trustees regarding the possibility of unifying the appeals for funds in the U.S. and Great Briain for the different institutions in China.

Voted that the executive committee arrange for a conference of Chinese leaders preparatory to a financial campaign in China in the interest of the University, and that the executive committee be empowered to take and further action nedessary.

Voted that we approve attempting to bring the agricultural work being done in the Province under the Bureau of Extension Work of the University.

Voted that we approach the Board of Managers of the Union Theological School with regard to the possibility of their supplying a teacher in theology for the University.

Voted that we add to the budget already adopted an item of

Bd.of Mgrs. Minutes 49.

\$2000.00 for a Chinese business manager.

Voted to authorize the secretary to write to the different / missions working in the Province, and send a duplicate of the letter to the home boards, asking them to consider the possibility of their appointing a pepresentative of the staff of the University: namely, Amoy, R.C.A., E.P.M., L.M.S.; Shaowu, A.B.C.F.M.; Hinghwa and Yenping, M.E.W.

Voted that with regard to the employment of Mr. Stephen Wang as religious work secretary, the matter be left with the president to make further inquiries and report to the executive committee.

Voted that we approve the purchase of a launch for the use of the University for approximately \$1000. Mex.

Voted that in conformity with the request of the Trustees, we ask our Mission treasurers to pay the Aglaries and other expenses of their representatives on the faculty through the University treasurer.

Voted that we ask the president to write a letter of condolence to the relatives of Dr. John F. Goucher expressing our sense of grief at the loss to the University and to us personally of so staunch a friend.

Voted that the matter of publishing a book on Character Analysis by Mr.Blakney be referred to the executeive committee.

Voted that we appropriate the amount of \$50.00 toward the dental expenses of Mr. and Mrs. Blakney.

Votem further that we ask the Trustees to give us a ruling on the payment of such expenses.

Voted that Mr.H.L.Lin be re-engaged for the year, 1922-1923.

Voted that the finance committee together with Messrs. Uong and Ding draw up a scale of salaries to present at the next meeting.

Voted that we pass a vote of thanks to Mrs. Mills for assistance in the department of construction and engineering.

The following officers were elected for the ensuing year:

Voted that we ask the Trustees to become a holding body for property belonging to the Union Normal and Middle School.

Voted that the matter of co-opting more members be left to the finance committee, together with Mr. Renskers, to prepare names to present to the next meeting.

After prayer by Mr. Uong, the meeting adjourned.

## FUKIEN CHRISTIAN UNIVERSITY

Minutes Board of Managers Meeting, March 31, 1923.

The Board of Managers of Fukien Christian University met at the home of Dr. Gowdy. Bishop Hind in the chair. Prayer was offered by Dr. Beard. Others present: Bishop Keeney, Mr. K. C. Ding, Rev. G. H. Wang, Dr. Gowdy, Mr. E. C. Jones, and G. M. Newell.

Bishop Hind stated the object of the meeting to be, primarily, the electing a temporary head of the University, in view of the early departure of President Jones for America on account of ill-health and also the home interests of the University.

After careful consideration, it was finally voted to invite Dr. Gowdy to be acting president during the absence of Mr. Jones.

Further voted that the Acting-President, the Dean and the Assistant Treasurer constitute the Administrative Committee of the University.

Voted that the Assistant Treasurer take over charge of the warehouse and act as purchasing agent for the University.

Voted that we approve the following askings as our needs to be presented in the finance campaign for F.C.U.:

Meeting of board of managers of F.C.U.

Meeting of the Board of Managers of Fukien Christian University, held at the home of Rev. John wowdy with Bishop Hind in the chair. Bishop Keeney led in prayer. Others present were Rev. G. H. Wang, Rev. W. L. Beard, Dr. Gowdy and G. M. Newell.

The correspondence was read by Dr. Gowdy, being a letter regarding the qualifications of Mr. F. P. Metcalf, our latest appointee to the teaching staff of the University.

The question of furloughs was next considered, and owing to the fact that six of the teachers are due to have their furloughs at the same time, it was voted that we approve of Mr. & Mrs. Beeman taking their furlough beginning with February, 1924.

wade by President Jones with Mr. Beeman regarding his salary and allowances while on furlough: Salary \$200 increase over the \$1200 received while on the field and house rent up to \$50 per month. Traveling expenses both ways, graduate study fees, medical attendance free, and a re-fit allowance of \$200 when returning to the field. The salary to be increased \$100 after the first six years and children's allowances as follows: \$100 the first ten years and \$150 per year from then until 21 years old. (The first outfit allowance was \$500).

voted that we appoint Mr. Beeman as our representative to the meeting in Shanghai of College Presidents and representatives.

Voted that in the event of having more regular a students than we can accommodate this coming fall, we approve of postponing the opening of the Normal Course for one year. In receiving new students first preference shall be given to regular students and second to sub-freshmen.

Meeting adjourned.

After prayer, the Minutes of the last three meetings were read and approved.

A letter from Mr. Moss, stating that the budget for the

year had been approved, was read.

A letter from the Student Republic of F.C.U was read, and it was voted to reply as follows: - After careful consideration of the matter contained in your letter of June 8, 1923, it was decided that since Mr. Neff's term of service with the University closes this term no further action is called for from this Board. Furthermore, we have information that Mr. Neff has asked leave of absence from his Mission.

Dr. Gowdy reported the matter of Mr. Mills continuing with the University, and it was voted that the Acting President, the President of the Board of Managers and the Secretary be a Committee to report this matter to the Trustees, and to say to them that it is our conviction that our contract with Mr. Mills should not be continued longer than the present term of service at most.

voted that we continue the payment of Mr. Bah's salary

to his wodow for the rest of the year,

voted to put into the budget for next year an estimate for the publication of Mr. plakney's language study book. Also that Dr. Beard and Mr. Wang be a Committee on Publication for the same.

voted that we ask the board of rustees to try and get Mr. Ling Ging Eung for the department of Social Science. (History and Economics.)

Voted to ask pr. peard to work with the committee of the Faculty to verify the estimates involved in the proposed change in the University Launch, and for this committee to proceed with the changes as seems best.

Voted that, in response to a letter from Mr. Dlakney, that the lectures he gives in connection with the Language School be omitted for the fall term.

Voted to support the action of the faculty of June 12, "To recommend that the coming of the Physical Training man for the University be delayed until the fall of 1925.

The meeting was adjourned after prayer by Nev. wang.

# Minutes of the Board of Managers of Fukien Christian University. Aug. 3, 1923.

The Annual Meeting of the Board of Managers of F. C. U. was called to order by Bishop Hind at his residence on Kuliang at 9.15 o'clock. Those present were: Bishop Hind and Rev. W. P. W. Williams of the C. M. S. Mission; Rev. W. L. Beard D. D., Mr. K. C. Cheng and G. M. Newell, American Board Mission, Rev. John Gowdy D. D., and Rev. H. V. Lacy of the M. E. Mission, and Rev. S. Day R. C. A. Mission, Amoy.

After prayer by the chairman, the minutes of the last meeting were read and approved.

- Manufacture - Manufacture

Dr. Beard then read a letter from Rev. E. S. Cobb of Tokio, Japan, stating it was very hard to get the kind of man we wanted, for Evangelistic work among the Japanese in this port and to teach Japanese in the University.

The secretary reported the receiving of a cable-gram
from President E. C. Jones saying that he was sending in his
resignation to the board of trustees. It was voted that we wish to
express to him our gratitude for his years of devoted service to
the interests of the university, and our deep sympathy for him in his
serious illness. We believe he is largely responsible for the present
high reputation which the University enjoys. We earnestly hope he
may quickly recover his health and soon be ready for many more years
of service in China. The acting-president's report and the actingdean's report were next read, and it was voted to accept same and
have them published as Buletine No. 8,1000 copies to be printed.

The treasurer's report, and the budget for '23 - '24 were referred to the finance committee for approval.

Mr. Kellegg's communication, regarding the continuation of his work while on furlough was read, and it was voted to ask the trustees to make an appropriation sufficient to engage Mr. Orin Main to carry on this work in seri-culture during the year 1924-1925.

Voted that the Board of Managers place themselves on record as heartily in favor of members of the faculty who are directly engaged by the University joining one of the constituent missions. Further, it is clearly understood that such men are not subject to appointment by their missions.

Voted that we authorize the President to find a Chinese pastor for the University.

Voted that we ask the M. E. Mission to consider the possability of appointing Rev. E. P. Hayes to the department of Theology of the University.

Voted to reiterate our urgent call of Feb. 15th, for 3 an Renskers to join the staff of the University in rtment of Education Mr. Herman Renskers to join the staff of the University in the department of Education.

Voted to authorize the President to find a Chinese teacher for the department of Physics.

At this point Bishop Hind placed the name of Dr. Gowdy before the board in nomination for the presidency and Dr. Gowdy immediately withdrew during the discussion and action which followed.

Voted that we unanimously nominate the Rev. John Gowdy D. D. to the board of trustees, for the president of F. C. U. and that we report this action to Bishop Keeney, hoping that in the event of his election by the trustees he will take the neccessary action and appoint him to the University.

Voted, further, that we ask Dr. Gowdy to continue as acting president until the formal action is made.

Voted, further, that we extend to Dr. Gowdy our heartiest thanks for his self-sacrifice in taking up the duties of actingpresident in adition to his other duties, and we assure him that his services at this critical period have proved most beneficial to the university and acceptable to the Board of Managers.

Voted, that we cable this action to the trustees and ask them to take immediate action and cable reply.

Voted, that we ask Mr. Day, Mr. Cheng and Mr. Williams to serve as a committee to go and conduct Dr. Gowdy back to the mosting.

The following resolutions from the M. E. Mission were received and placed on file: - "As one of the contributing missions in the support of F. C. H., we wish to reaffirm our belief in the necessity of positive Christian ideals and standards in the curriculum and teaching of the University, and we also urge that every possible means be used to keep the students in touch with the churches and practically related to their progress and activities.

We request our representatives on the Board of Managers to bring the above resolution to the attention of Board of Managers and also to keep the mission informed from time to time in regard to the Christian at mosphere in the University."

The following officers and committees were elected for the year 1923-1924.:-

President, The Rev. Bishop John Hind D. D. Secretary Mr. G. M. Newell, A. B. C. F. Treasurer, Rev. W. L. Beard, D. D. A. B. C. F. M. A. B. C. F. M. Asst. Treasurer, Mr. H. A. Bedient, F. C. U.

Executive Committee: - the above officers together with

Messrs. Cheng and Wang. Finance Committee: The President, Dr. Board, Rev. W. P. W. Williams, and Mr. Wang.

That Dr. Gowdy, Bishop Hind, and Dr. Beard be appointed a committee to act with a lillar committee of three to be appointed managment of the University. Such classes and involve changes in our constitution.

The erection of the Science Building will be stopped, but in doing this, we believe we are imperilling our relations with the China Medical Board, and also running a serious risk of injuring the future of the University.

We, therefore, ask the Board of Trustees to recall Drand Mrs. Gowdy to America with a view to securing funds to tide over the present emergency.

Also, we ask for a cable in reply to this request for the recall of Dr. and Mrs. Gowdy.

VOTED: That we approve the plans as submitted by the Construction Bureau for the President's residence.

After prayer by Rev. Wang, the meeting adjourned.

VOTED: Also to permit Professor Ch'en to defer payments on his present loans from the University, on condition that the Loan now to be negotiated with the bank have prior claim and be paid off as promptly as possible.

VOTED: To ask the Board of Trustees to add to the amount now included in President'Gowdy's campaign askings \$500.00 Gold, to make up the deficit on Residence No. 9 and to add servants quarters to Residence No. 7. This action is taken on the grounds that Professor and Mrs. Martin by taking Residence No. 7 as their residence will give the University an additional residence, available at once.

VOTED: That in view of the diversity of size of residences, to ask the Faculty to take up for reconsideration the existing rules regarding the relation of furniture to Faculty members and residences.

It should be realized that some of this money for endowment is not immediately available. The C.M.B. gift of \$35,000.00 has already been spent on the science building, and is to be repaid from the \$75,000.00 subscribed for that purpose. This is being paid at the rate of \$15,000.00 per year, of which two payments have already been made. Moreover, the income from endowment that is available will, during the next three years probably be used by the Trustees towards the \$22,000.00 of the debt which was not subscribed, so it will be 1929 before we begin to realize what it means to have an income from endowment. Therefore, in spite of the fact that the campaign was in a measure successful, the years immediately before us will be very lean.

It should be understood that the China Medical Board gift of \$35,000.00 had been promised before this campaign began and during the past year was transferred from the science building to endowment for the science departments."



"Dr. Sutton has spent most of his time thus far on the lesson sheets which Prof. Blakney prepared. He will plan to take up the 600 character book and devote his time from now on to this.

"Mrs. Sutton has nearly finished the Blakney Lesson Sheets and has read in Romanized some Bible stories. She will plan to take up the 600 character book and the Bible Picture Book in Romanized.

"Professor Beeman has finished the Blakney Lesson Sheets and has made a collection of Chinese Idioms. He will plan to take up the 600 character book. Ex Het willialso learn to our write find the characters from the radicals and to write the characters of the 600 character book.

"Professor Farley has worked collecting Chinese poems and Nursery Rhymes of Fukien. He has done quite a bit of original work in this line and has translated many poems and rhymes. He has in mind the publishing the results of his work sometime in the future. The committee heartily approve of his continuing this work, and hope he can ge given time to devote to it.

"The committee would suggest that the Board of Managers consider the advisability of asking language students in the future to study Mandarin instead of the Foochow Dialect.

Faculty Moeting

March 17, 1927.

The Faculty met at the Home of President John Gowdy, at 8:30 A.M. on March 17. Present: Messrs. Gowdy, R. Scott, W. Y. Chen, C. J. Lin, Martin, Kellogg, Beeman, Blakney, Metcalf, Farley, Beach, and H. H. Chen for a brief time.

Mr. H. H. Chen, pleaded a previous engagement, and was asked to give a short address on his opinions concerning Registration.

After considerable discussion of the whole situation for some time it was Voted:That we recommend to the Board of Managers that Fukien Christian University be
adopted at once to a new organization which shall make it a Chinese College,
with Christian atmosphere, under Chinese Administration.

The following items designated Group I were voted seriatim and then as a whole:

- Group I V:- That the Faculty recommends to the Board of Managers the following items:
  - No. 1. That the Board of Managers secure a Chinese President for Fukien Christian University at an early moment. (unanimous.)
  - No. 2. That the Faculty reaffirms the recommendation that the number of Chinese teachers on the Faculty be considerably increased, and in order to give the Chinese President a free hand, if it becomes necessary to decrease the number of foreign men on the Faculty, we declare ourselves in readiness to hand in our resignations, on the appointment of the new president, to take effect immediately or at his discretion. (unanimous.)
  - No. 3. That the Board of Managers ask the Trustees of Fukion Christian University that the property and equipment be rented by the Trustees to the Board of Managers for a term of years at a nominal sum.

Adjourned to 2:00 P.M. Present: Messrs, Gowdy, R. Scott, Farley, Kellogg, C. J. Lin, Martin, Beeman, Metcalf, Boach.

- No. 4. That the Trustees be invited to send a deputation of at least 2 of their members to assist in the general reorganization with power to act. (suggested one be a lawyer.)
- Group II On Registration. The following were Voted seriatim and en bloc as Recommendations to the Board of Managers:
  - No. 1. That all religious courses be elective, beginning next semester. (one dissonting vote)

- No. 2. That the Board of Managers constitute itself thru the contributing bodies, with a majority of Chinese members with a Chinese Chairman.
- No. 3. That the Board of Managers find a Chinese President at once.
- No. 4. That the Board of Managers write to the Educational Authorities of the Government at Wuchang stating that we wish to register and asking for the Regulations of Registration.
- No. 5. That a copy of this letter to the Wuchang Educational Authorities be presented by the hand of a Chinese member of our Board of Managers to the Fukien Educational Authorities.
- No. 6. That the Board of Managers cable to the Trustees for discretionary power to Register.
- No. 7. That the Article 5, of the Peoples Government of Kuantung's Regulations for the Registration of Private Schools, re the liquidation of property in case of closing a school, be carefully investigated.
- No. 8. We believe that Registration is necessary to our continuance, and desirable, and ask the Board of Managers to take these steps, and any others which may be required toward Registration.
- V. That a new Committee on Registration be appointed to meet with the Registration Committee of the Student Republic. The Committee to be Messrs. R. Scott and C. J. Lin.
- V. We ask our Pegistration Committee to report to the Student Republic Committee that the Faculty has considered the Regulations of the Peoples Government of Kuantung for Registration of Private Schools and have practically unanimously recommended all of these articles to the Board of Managers.

Further reports will be forthcoming when the Board of Managers meets and officially acts in this matter.

All the above votes were unanimous except Group II No. 1 had one dissenting.

Voted: That with regard to the Property of the University the President be asked to communicate with the Board of Trustees.


Voted: That the Board favors registration with the Government and hereby instructs the Secretary of the Board to make application to the local Government authorities for registration.

Voted: That the Chairman of the Board cable the Board of Trustees for discretionary power on registration.

Voted: We would agree that all courses in Poligion may be made elective provided there is nothing in the regulations otherwise which would impair the Christian character of the institution.

Voted: Agreed to constitute the Board of Managers with a majority of Chinese members.

# FUKIEN CHRISTIAN UNIVERSITY FOOCHOW, CHINA.

April 11, 1927

Dear Dr. North:-

Since I wrote you the long letter last week about the situation at the University, we have had a joint meeting of the Faculty and Managers. I dont think we accomplished very much, though the Faculty learned that no amount of pressure will stampede the Managers into action. We have since learned that a new set of registration regulations have been in process of preparation and the Managers will do nothing until these are ready. I agree with them in this. Quite apart from registration the Faculty thought the Managers ought to yield to the popular clamor for a Chinese administration either President or Commission. The position in which I find myself is intolerable so I have begged the Managers to free me but they positively refuse. So I suppose I must stay. These new regulations are out and I succeeded in getting a Chinese copy from the printer's but they are not yet translated. I shall have them translated at once and put them before the Managers for consideration.

The rules for the required observance of the weekly Sun Yat Sen memorial service are published and they are very stringent. The whole educational system within the University has to be partyized. There must be an organization of the Kuomintang in the institution and its members will see to it that all the requirements are met. This is to me intolerable for it places the students in a wrong attitude towards their teachers - that of spies. The government can require the dismissal of any administrator or teacher. It would be very easy for any disgruntled student to get a following and lodge a complaint and have a teacher removed.

My own attitude has been that I would vote for registration. I question very much whether it is possible to maintain a Christian institution under these conditions, but one cannot say a priori it is impossible. Only experiment would demonstrate. I do not mean that I would vote for registration, no matter what the conditions, and it may be that these new conditions shall modify my attitude. I shall send you a copy, also a copy of the Sun Yat Sen memorial service regulations. If I can be freed from my work here I shall take an immediate furlough, for which I have received permission from Bishop Brown and go home that I may lay the whole matter before the Trustees. Since we would go on furlough it would be at no expense to the University. It is not possible to write fully and explain everything.

One of your letters just received, that of March 2, suggests I get in touch with Dr. Edmunds of Canton. I have all the Canton data before me here. The Faculty would favor that, the Managers not; they think Lingman has gone over to the enemy and sold her birthright! In case I could not get away. For three months I have been trying to get away to go north but some crisis suddenly arises and I cannot leave. Everything is quiet locally and the moderates are in control, so we do not fear anything here, but we do not know how the Shanghai situation may affect us. Letters from some members of our mission who are there, including Lacy, say that they consider intervention almost inevitable. But then everybody in Shanghai is seeing "red" these days, and I must admit with good reason.

Things are quieting down at the University. The leader of the trouble is moving his family away from the University as I write. This is a relief, for he had intimated he would not move. His cause has failed and has involved him in a great loss of face. He considers himself a martyr for his country. Many of his adherents have fallen away from him and two days ago one of his three leaders wrote a letter of apology to us confessing his error and asking if he could be taken back next term. So, most of those who were active with him are leaving and it is a great relief to be rid of them so easily. Of course they will continue their propaganda from Foochow but I think they cannot do us much harm. This victory is entirely due to our group of loyal students, and they have spent time and money lavishly, and it is undoubtedly true they have saved the mission schools of Foochow, for a time at least.

If we have to close, it will be some time before we can open and my judgment, after very mature deliberation, is that the staff should be sent home to get other work as soon as possible. When the University is re-opened there should be considerable changes in the staff and that would be more easily accomplished in that way than in any other way. Of course we shall do what the Managers decide if there should be opportunity to call them together.

March 30, 1927.

Dear Dr. North:

We have been passing through a very serious crisis in the University during the past ten days, and I fear the end is not yet.

Friday, March 18, was a holiday and our students went to Foochow to take part in a patriotic parade. The faculty spent the whole day in a faculty meeting, once more going over the requirements for registration. We were under great pressure from the students and it had become evident that if we did not attempt to register the students would leave. We accepted all of the conditions of registration, making a reservation on the one that said property would be liquidated if we closed, asking the Board of Managers to investigate this. We took the conditions which had been issued by the Canton government in December.

I went to Foochow the next day and arranged for a mooting of the Board of Managers to be held Tuesday, the 22nd.

For some time one of our teachers, Mr. C-H-H had been growing radical. He is a graduate of the Anglo-Chinese College, also of our University, and Mr. Jones sent him to the Government University in Peking for two years of graduate study on a fellowship. While in Peking he came under the influence of Chancellor Tsai who is really the originator of the anti-Christian movement, and of Bertrand Russell. His first year of teaching here was my year at home, 1924-25. When I returned I saw the change in him and talked with Dean Scott about it, and we agreed on a deliberate campaign of patience and kindness to try to win him back. The Board of Managers have thought he ought to go, but I asked for patience. It is evident I was wrong and he should have been dismissed long ago. In February Chancellor Tsai was in Foochow and gathered about him a little group who had all had their finishing education in Poking, nearly all at Yenching, so they have become known as the Yenching group. These were naturally outstanding leaders, and that is why they were sent to Peking, so it is not strange that they held influential positions here. They were trained with that in view. One had become the head of our Union Normal and Middle School, another (a girl) the head of Wen Shan (American Board) Girls' Middle School, one a teacher in Hwa Nan College, besides our Mr. C-. Chancellor Tsai took this group with him to Amoy where he thoroughly indoctrinated them so they came back here with the declared purpose of breaking up all the mission schools, particularly those in which they were located.

On Saturday the 19th, it became apparent there was a split in our student body, the radicals following Mr. C- with the openly expressed purpose of closing the University and handing the property over to the government, and the conservatives, who were keen for registration, but who said, "give the faculty and Board of Managers a chance." On Sunday morning the radicals began to sign up the students under threats. One boy who refused to sign came at once and told me what was being

done. I called the faculty together and we got busy with the loyal group. By their methods of intimidation and making their adherents sign a very strict oath, the radicals succeeded in getting a large number of followers. On Monday, the 21st. they brought down from Foochow (Mr. C- did) two officials who made most violent anti-Christian speeches to the students. As soon as these finished, the conservatives introduced the Commissioner of Education. They had planned, when he finished, to have questions asked from the floor, the answers to which would prove the radical propaganda to be lies. For example, the radicals told the students that the government had decided to take over our University for a Sun Yat Sen Memorial University. As soon as the Commissioner finished, one of the students rose and asked if the government intended to take our property. The chairman, a radical, objected and said that questions could not be allowed, making quite a speech on the subject. As soon as he paused, the student repeated his question to the Commissioner, thus forcing an answer, and the reply was that the government had no thought of touching private property. Other questions followed until the radicals had not a leg to stand on. Being unable to do anything else, they put out posters villifying the Commissioner. That evening they forced a meeting of the student body. Dean Scott attended this meeting and his presence precipitated a crisis. The radicals objected and the Dean offered to withdraw. The matter was, however, discussed and put to a vote, 53 - 44, in favor of the radicals, which showed them to be in control. The conservatives then began to filibuster and kept it up for about two hours before the radicals succeeded in getting their motion before the house, which was, "Moved, that we, the students of Fukien Christian University, invite the government committee on the reconstruction of education to come and take possession of the University property which the students wish to hand over to them." Then action could not be postponed any longer, just as the chairman was about to put the motion the lights went out, turned off by the conservatives so that they could not be turned on again all night. Then the conservatives left the hall in a body except the chairman (a conservative) and one other who stayed to see that the chairman should not be injured. For about an hour and a half the chairman held his own against the 53 radicals, refusing to put any motion because a quorum was not present. They tried in every possible way to cajole and to deceive him but it was no use, he held his ground. Finally Mr. C-, the teacher got up and resigned from the leadership of the party, thinking a conservative chairman would be so glad of the chance to get rid of him that he would call for a vote. The chairman saw the ruse and knew if he put that motion he would have to put others, so again refused. Finally Mr. Cwrote a note to the conservatives promising to compromise if they would come back. This showed they had won a victory, which they had not fully realized before, so they refused to return.

Meanwhile things had been moving to a head in the other schools in Foochow. and the battle was transferred there, the stake being the mission schools. Hwa Nan dismissed their radical teacher, Wen Shan has got rid of theirs but the school is closed. I understand the Union Normal and Middle School is also closed. On Thursday of last week this radical element staged what proved to be an anti-Christian parade. They caught a young Church of England clergyman, Chinese, a returned student and put him on their platform with a big cap on his head, a rope around his waist and his hands tied behind his back. They asked him if he was a Christian, to which he said, "yes". Then they said they would free him if he would renounce his faith to which he replied, "I will never renounce my faith, you may kill me if you want to." So they led him through the streets in their procession but finally let him go. They subjected him to great humiliation, slapping his face etc. He did not receive any serious physical injury. The next morning I dismissed Mr. C- giving him until March 31 to move. That will be tomorrow. I am told he does not intend to move. It would be a serious matter to use force, so I scarcely know what I shall do. I am told the recalcitrant students also will not move, that is, the

leaders. Their number has steadily dwindled until they are almost down and out, but a handful cling together, enough to make trouble, while the conservatives have grown in number and strength and confidence. This is something new in China, a belligerent conservative body, determined to oust the radicals and succeeding. It has been worth all it cost.

Now a word about the Board of Managers' meeting of the 22nd. I put bofore them the recommendations of the faculty concerning registration. They did not wish to take action beyond saying they were in favor of registration. They have said that repeatedly, but the time had come when something had to be done. However, I could not persuade them. I know the University would close in five minutes after I got back if I had nothing to report. I could not bear to think of thus going back on that group of loyal students who had fought so valiantly and had saved the mission schools and who had contended that the faculty and Managors should have a chance. Finally when nothing olse would do, I demanded immediate accoptance of my resignation. They begged me to take it back. I refused; I would never return to the University as President unless they took some action. I did not demand favorable action, but merely that they should say "yes"or "no". That forced the issue and they approved. It has done no good, however, for they will not proceed to carry out what they decided. We have another Managers' meeting on Monday of this week the 28th. The latest regulations ask for a Commission form of government instead of a President. The members of the Commission must all be Chinese, but may have foreign advisers. They would not accopt it, or at any rate did not, so we are just where we were. I am being ground to powder between the faculty and student. on one side and the Managers on the other, and I cannot stand it much longer. Two nights this last week I have had almost no sleep, and very little the other nights. I am having most difficult and delicate things to do these days that require calmness and poise, and I am being unfitted to do such things. This morning I had to dismiss our Chinese librarian, one of our own graduates and it required a great deal of finesse. I am told that Mr. C- will refuse to leave the University and just how to get him out I don't know. I promised to stay here until December 16 on the supposition that an honest attempt would be made to find my successor and that is not being done. I myself had W- H- in mind as a possibility, but now no one from Yonching would be considered for anything in any mission school here. This is very unjust to Yonching for I am sure the leaders of this revolt are not the normal output of the institution. Recently there was an anti-Christian outbreak in Yen Ping and two of our leading church workers, one of them a returned student, had to flee for their lives. The leader of this was also a Yenching man. It is this peculiar combination of circumstances that has made people feel as they do about Yenching. I do not think W- H- would come, but in any case he would not be considered.

In connection with the proposed re-organization, I have been asked by the Board of Managers to consult with you about the property here. If the re-organization results in a Board of Managers, of which the majority is Chinese, the present Managers are anxious to safeguard the property. They proposed that a normal rental should be charged (not a nominal rent as in Canton) and that the check should actually be paid and then returned to the Board in addition to its regular contribution from the Trustees. It would be necessary to draw up a lease and it should be done by your attorney in New York. If the tenant is to take care of the property, then the rent should accordingly be less. In any case, it seems to me the tenant should care for the property if the rent money is all to be paid back. What the Board of anagers wants is to have the Trustees send two of their number out here, authorized to help in the re-organization and make whatever adjustments may be necessary. They should come with power to act, and they should come this summer. I do hope such a commission will be possible. But in any case a lease, agreeable to you, should be drawn up. It seems to me it ought to be able to be broken by either party on six

months notice, and be made for only a year at a time. The property is valued at about \$600,000.00 Mex., including land, buildings and equipment.

I do hope there will be prompt action as we shall otherwise not be able to hold together.

Just as I am finishing this letter word has come of a new development. Are C-, failing in what he proposed to do to the University, has taken up an anti-foreign campaign, the kind of thing that is very popular just now and easily worked up, and last Sunday had a meeting in the city in which forty different organizations were said to be represented - labor unions, etc. This is the biggest thing he has yet attempted. A group of our loyal students went up to Foochow as soon as the word reached here, to get in touch with the government officials and with the newspapers. The whole situation carries with it possibilities of serious danger.

The Board of Managers voted also that in addition to sending you a copy of the Bylaws as amended and the proposed agreement between the Board of Managers and the
Board of Trustees, that an explanatory letter should be prepared, in order that
you might know more in detail the reasons for the proposed changes. It is also
understood that long before you receive this letter, Dr. Gowdy, formerly President of the University, and Dr. Beard, formerly Chairman of the Board of Managers,
will have had an opportunity to present in person the situation as it was when they
left the field. In this way, it is hoped that the Board of Trustees may be table
to understand a situation which is still in process of rapid change, which tous here
opens up great hopes for the future of the University, but which requires prompt
and decisive action on the part of all concerned.

IN dealing with the commlex and difficult problems of the University, the Board of Managers has had continually in mind three guiding principles:

First and foremost, the Christian character of the University must be safeguarded. The Board of Managers is itself made un largely of church leaders. There was no hesitancy or indecision as to the out and out Christian declaration of purpose. Nor has there appeared any tendency to minimize the Christian character of the school in applying for registration. Since this was the main point stressed in the letter of April 29, 1927, from the Trusters, and since the Board of Managers believed that proper safeguards were provided, they felt justified in taking the first step in registration, namely, the registration of the Board of Managers as a legal body.

The second point which had to be kept in mind was, naturally, the government requirements for registration. Here the main change made necessary is that control of the school should be predominantly Chinese and should be located in China. It was in no spirit of grasping for power, but rather with a keen consciousness of the heavy responsibilities involved, and with a conviction that this is the only way in which the University can be carried on, that the Board of Managersfinally agreed to undertake the full responsibilty for management of the school. It was frankly recognized that the Board of Managers cannot at present assume full financial responsibility without the assistance of the Trustees; it seems guite as evident that under the present conditions, or any conditions likely to arise in the near future, the Trustees can only hope to see the Unive sity work continued by giving over the actual management to some body largely Chinese.

The third point which the Board of Managers had in mind was that control should be vested in a body which should actually represent the churches. Whether this is wise or not, the future can determine. You will at once recognize that it is quite different from the new constitution of Canton Christian College. All we can say is that after long consideration we felt that this was, on the whole, the best method of insuring the steady growth and Christian character of the University.

In the light of these three principles, you will have little difficulty in understanding why we are herewith submitting two documents for your approval instead of one. The By-laws with the statement that we are working in rented property and that the Board of Managers takes responsibility for the raising of current expenses will go in to the Government. If the Trustees are willing to join with us in this difficult, but in our opinion hopeful experiment, we believe the outlook is good for Fukien Christian University to fulfill the function which its founders originally intended.

The important changes in the By-laws are:

- (a) The putting of relations between the University and the Truste's into separate agreement and appointment of President, etc., by the Board of Managers already referred to.
- (b) Making the unit of cooperation here on the field the Church rather than the Mission, and
- (c) The alternative of an Administrative Commission instead of a President.

The first is inevitable under government regulations; the second seems, to say the least, highly desirable; the third concerns an administrative matter with regard to which we will have to conform to the Government regulations which are not yet quite settled. (The present local regulations call for a Commission; the national regulations provide for a President; we rather expect that eventually the latter will prevail).

The proposed Agreement is intended to safeguard the interests of the Board of Trustees and includes for the most part the important items in the old By-laws, which are not included in the new. It is, of course, to be expected and hoped that the Board of Trustees will themselves secure competent legal advice and suggest any changes that may seem desirable. It is sincerely hoped, however, that any such changes will not make necessary further delay in proceeding with registration, etc., here, as in the opinion of the Board of Managers such delay might be very nearly fatal to the University.

You will understand that the present Board of Managers, the present Administrative Commission, and the present Faculty are united in their judgment that the University should register this summer. The first step, namely, the registration of the Board of Managers, has already begun. Natually, the formal application for registration of the University itself cannot be long delayed. If the Board of Trustees felt unable to approve of proceeding with registration, we should doubtless by this time have received a cable closing the school; we, therefore assume that in the spirit of your last letter, and with the added light that Mossrs. Gowdy and Beard were able to throw on the situation, that you are willing to have us proceed. Nevertheless, we would be glad to receive a cabled approval upon receipt of this letter.

In closing, we wish to emphasize again that the long hours spent by the Board of Managers in revising the By-laws and in working out the proposed Agreement given altegether in the spirit of working together to conserve the

Christian purpose and prospects of Fukien Christian University and to build the Kingdom of God here in Fukien. The heavy burdens the Board of Managers are assuming and the new and difficult experiment which they are under taking are only made bearable by the conviction that they are called on by God to undertake them. With His help we cannot fail in the high aims for the University which we share with you.

"The Board of Managers and the Board of Trustees of Fukien Christian University exists:

"The object of the University exists:

"The object of the University is to provide higher education for youth in China under influences which will develop Christian character and personality to meet the deeper needs of society."

(Chapter I, Article II of the University By-laws) and therefore make the following agreement to make clear the basis of cooperation.

PROPERTY:

The land, buildings, apparatus and other equipment, mohies, securities, and invested funds which have been or may in the future be secured by the Trustees are recognized as belonging to them in trust for the University. A schedule for all such property is attached hereto (see inventory list).

The Board of Managers requests the Trustees to rent all land, buildings, apparatus and equipment to it for a period of three years, beginning August 1, 1927, at an annual rental of 5% of the value of the property, such lease to be renewable by mutual agreement at the end of that time.

The Trustees shall have the right, with a notice of one year, to abrogate the rental contract whenever they deem that their property is not being used for the purposes for which the University was founded.

The Board of Managers undertakes to keep said property in good condition, including ordinary repairs for the time of the lease.

For the sake of clarity, property held for any Mission Board by the Trustees will also be dealt with through the Trustees and not direct with the Mission or Mission Board.

## CONTRIBUTED FACULTY MEMBERS:

Members of the Faculty who are provided for by the cooperating churches in accordance with Article VII of the University By-laws, are dealt with exclusively through the church organizations. It is sincerely hoped that the Mission Boards will assist the church organizations to maintain their full quota and, if possible, increase the same.

## RUNNING EXPENSES AND FUNDS:

The Board of Trustees continues to transmit to the Board of Managers the annual amounts contributed by the cooperating churches, the income from all the property in its possession, the interest from endowment funds, and such other funds, in whole or in part, as the Trustees may deem expedient, or as may have been donated for special purposes.

The Board of Trustees shall have power to withhold the payment of any of the aforementioned funds in case there shall be a departure on the part of the Board of Managers from the principles enunciated in Article II of the University By-laws.

## DEGREES:

Upon registration with the Chinese Government, the Board of Managers will have authority to grant degrees approved and stamped by the Government. For the present, and until this matter may be adjusted satisfactorily, the Board of Managers requests the Board of Trustees to continue to recommend University graduates to the Regents of the University of the State of New York for suitable degrees.

## REPORTS:

There shall be regular transmission of information and reports about the affairs and financial conditions of the University to the Board of Trustees.

## AMBINDINES:

The relation between the Board of Managers and the Board of Trustees shall not be changed except by mutual consent, that is, it is not to be amended as a part of the By-laws, but to be considered as a contract.

  - (b) That we ask the Executive Committee to immediately get full information about the experiences and means of other universities in China in raising money from the Chinese, and
  - (c) That we ask them to report the findings of the above immed-, iately to the Board of Managers at a special meeting.
- M-510 VOTED: (a) That we ask the faculty to work out a course leading to the A.B. degree, requiring only a minimum of instruction in English and to report to the Executive Committee who shall have power to carry this into effect.
  - (b) That at the same time it is our intention that the present standard of English should be maintained, and
  - (c) That it is our judgment that we need our existing foreign teaching staff for the time being.

#### CAPITAL FUNDS

M-511 VOTED: That we request the Board of Frustees in New York to provide M\$6,000.00 for the removal of graves in the University compound and for the purchase of certain strips of land needed for new buildings.

#### REVISED BUDGET

M\_512 VOTED: That we adopt the revised budget for the fiscal year ending July 31, 1928.

## APPRECIATION TO DR. GOWDY

- M-513 VOTED: That we request our Secretary to write to Dr. Gowdy expressing our appreciation for his invaluable service now being carried on in America for the Managers and the University.
- M-514 VOTED: That we extend to Mr. C.J.Lin and members of the faculty and their wives our vote of thanks for their hospitality.

It was agreed that the question of co-education and other problems not thoroughly discussed at this meeting should be taken up in the next meeting in Foochow.

## Minutes of the Executive Committee of the Board of Managers

## of the Fukien Christian University

## in the M. E. Office Building

## 2 P.M. Dec. 10, 1927

Members present: Messrs. Lin Yu-Shu, (Chairman) Lin Pu-Chi, (Secretary) Havighurst, (Treasurer) Lin Ching-Jun, E.M. Norton, and Wang Chien Ho.

The meeting was presided over by the Chairman.

The Rev. Mr. Havighurst was asked to say the opening prayer.

Motions passed as follows:

## 1. Letter to the Board of Trustees.

M-515 VOTED: (a) That in the memory of the Executive Committee, the following motion was passed by the Managers at their annual meeting on Nov.14, but somehow or other got deleted from the copy of the secretary's minutes, and should therefore be incorporated in the annual minutes as originally adopted.

"That a letter be written to the Board of Trustees in New York City, reassuring them of the earnest desire of the Chinese people to maintain such an institution as F.C.U. which is the crowning point of Christian education in this province, and to solicit the continual co-operation and financial help of the American people, who have in the passed years, so generously contributed for the building up of this University."

- (b) That the three following gentlemen Messrs. Lin Yu-Shu, Chairman of the Board of Managers, Lin Pu-Chi, Secretary, and Lin Ching-Jun, Chairman of the Administrative Commission, be requested to sign this letter to the Trustees as representatives of the Board of Managers.
  - 2. Faculty's plan of the Degree of A.B. through the use of the Chinese Language as medium as far as possible.

M-516 VOTED: That the Executive Committee accept in principle the proposed plan of the Faculty in regard to the Degree of A.B. through the use of the Chinese Language as far as possible;

That the Faculty be requested to go on in their preparation of the plan; and

That it is the hope of the Executive Committee that the proposed plan may be put in execution in the Fall of 1928.

## 3. The cuestion of Co-Education.

M-517 VOTED: That the Executive Committee accept in principle the proposed means of the Faculty for carrying out Co-education in the F.C.U., but meanwhile feel the grave difficulties that lie in the way at present to put it in practice, and would therefore advise that the proposition be laid on the table.

## 4. Raising Funds from Chinese Sources.

Considerable time was spent for the discussion of the problem of raising funds from Chinese sources. Views were expressed of the importance of cultivating the friendship of those prospective contributors, both in this city and elsewhere, by keeping them informed of the work of this University and by inviting them to visit the campus; and of the formation of a Board of Supporters (Chinese characters) or Honorary Board of Managers, (Chinese characters) which is a method much used by both private and public institutions in China. The need of a Chinese dean to take full responsibility for internal administration and discipline was much felt.

M-518 VOTED: That the Administrative Commission be requested to advise and report to the Board, means for raising money from Chinese sources.

Gentlemen: -

The undersigned have been instructed by the Executive Committee of the Board of Managers of the Fukien Christian University to sonvey to you a resolution of the Managers at their annual meeting held on November 14 as follows:-

Resolved, that a letter be written to the Board of Trustees in New York City, reassuring them of the earnest desire of the Chinese people to maintain such an institution as the Fukien Christian University, which is the crowning point of Christian education in this province, and to solicit the continual co-operation and financial help of the American people, who have in the passed years so generously contributed for the building up of this university.

The Managers are fully aware of the fact that in recent years, there have been anti-Christian attacks on institutions supported by foreigh funds, but these attacks have invariably been conducted by a very small group of people, who bear personal grudge against these institutions, or who cherish very mean and selfish ambitions. In certain cases they are people of extreme nationalistic tendencies, and radical atheism. But the Chinese people as a whole are quite level headed, they see plainly the good work that these institutions do to China, they are same enough to give unbiased judgment on Christian schools. They want them to be maintained and supported as long as possible. China has a very long and complicated programme of education, which the Government cannot possibly carry out, without the help of a vast number of private schools and mission schools. The Chinese people as a whole do appreciate the sympathetic co-operation and generous contributions that the American people have given in the past, and they do desire that they be continued. On your side, there may have been rumours and misrepresentations to the disadvantage of mission schools out here, but let us solemnly reassure you that they are untrue. We do pray that you will steadfastly continue to do the good work that you have been doing for the youths of this Land, and for Christ; and may God grant you success even more than before.
