# CHANGE IN ROSTER

The Board noted the election of Mr. Nga Geng Guang by the Church of Christ in China of the Mid-Fukien Synod to succeed Rev. Lin Yu Shu

Dr. Wang Chien Ho was elected Chairman of the Board, and C. J. Lin Secretary pro tem.

# APPROVAL OF MINUTES

M-634 VOTED, to approve the minutes, as distributed, of the last meeting on Nevember 8, 1930.

# ADDRESS BY DR. FAIRFIELD

The Chairman extended a hearty welcome to Dr. Wynn C. Fairfield of the Board of Trustees, and asked him to address the Board.

Dr. Fairfield expressed his satisfaction of the work done at Fukien Christian University, and praised the fine and earnest Christian spirit of the faculty. "Fukien Christian University is the most encouraging thing I have seen in China this time." He assured the Managers the continued cooperation of the American Board. He said, "Though the American Board had too many children to look after, we shall support Fukien Christian University to the limit of our ability."

### REGISTRATION WITH THE MINISTRY OF EDUCATION

The communication from the Nanking Ministry of Education, with regard to the granting of charter to our college of arts It was and science, was read.

M-635 VOTED, to acknowledge the receipt of the Government's communication to register us as a college of arts and science before we strengthen our school of education or the establishment of a third college, and to use the name of Fukien Hsieh Ho Hsueh Yuan (和立福建協和學院) in official communication with the Government.

### CO-EDUCATION PLAN

President Lin reported the faculty plan for co-education.

It was to build a new residence on an appropriate location on the campus which should have accommodations for two or three single-lady members of the staff (Dean of Women and Miss single-lady members of the staff (Dean of Women and Miss sher) and about twenty-five girl students. When the girls student body should increase so as to call for a larger dormitory, the proposed residence would be used for the social center of the girls as well as for the living quarters of the dean of women, single-body teachers, and other members of the staff without children. It was also reported that Mr. Wiant of the Fukien Construction Bureau had been working on a general layout of the future women's unit. The preliminary asketch of the new residence was passed around among the Managers. Considerations were given to the desirability of having the University setting a standard for co-education. and the means of meeting the current expenses. The action of the grustees on this matter (T-919) on November 18, 1930 was also read. No formal vote was taken.

# URGENT LAND PURCHASES

The urgency in purchasing a few pieces of land connected with the University campus and needed for future development was brought for discussion. The Board, having in previous meeting informally instructed the President to negotiate for the purchases, now

M-636 OTED, to borrow from the anticipated gain on gold ex-change of this year a sum of five thousand dollars (\$5.000) local currency for the purchase

of several pieces of land near the compus.

### APPROVAL OF PROFESSOR BEEMAN'S FURLOUGH PLAN

Professor Beeman of the Department of Chemistry will leave on furlough on June 27 From Hongkong wis Suez, arriving New York on September 5. Oberlin College is considering to give him the Charles M. Hall Research Fellowship in Chemistry for 1931-32, which carries a stipend of \$2,000 gold with the obligation of about one-fourth time teaching. He plans to print his thesis, and will go to Chicago to receive his Ph. D. degree in February, 1932. It was

M-637 VOTED, to approve Prof. Norvil Beeman's 1931-32 furlough plan.

# THE WESTERN STAFF AND MISSION BOARDS' APPOINTMENTS

President Lin and Blahop Gowdy both reported their correspondences with the New York Office and their respective conferences with the Western members on the staff with regard to the latter's assignment to the various cooperating Mission Boards for appointments. It was thought that the Trustees meant to ask the cooperating Boards to take over the Western members now on suff as their regular missionaries, and that the University would pay to the Mission Board concerned the present salary and allowances of the teacher or teachers thus taken over. It was

M-638 VOMED, to express the Managers' favor of presenting the Western members on the University staff to the cooperating Mission Boards for appointments as their respective missionary teachers to the University, provided the Trustees can make financial arrangement without encroaching on the regular University budget.

# PRESIDENT'S LEAVE OF ABSENCE

M-639 VOTED, to approve President's leave of absence from the University in order to attend Dr. Butterfield's conference on rural reconstruction movement in Nanking on March 9, and the Council of Higher Education meeting in Shanghai on March 17.

The meeting adjourned.

### PRESIDENT'S REPORT ON RECENT TRIP

The President then made a verbal report of his recent visit to Nanking to attend the Conference called by the China Christian Council in the Capital to meet Dr. Butterfield and Dr. Warnshuis. Fukien Christian University was among the five colleges which were invited to participate in the Conference. The discussion was on the rural church problems and leadership training for rural service. Fukien Christian University's work and future plans were favorably considered. No resolutions were passed. The Conference proved to be very profitable to all who attended it.

After the Nanking Conference, the President went to Shanghai to attend the annual meeting of the Council of Higher Education. No serious changes were effected with regard to the correlated program. The annual meeting of the China Christian Educational Association elected President C.J.Lin president for 1931-32.

### VISIT OF THE LAYMEN'S INQUIRY COMMISSION

The recent visit of Dr. E.M.Knight and other members of the Laymen's Inquiry Commission to Fukien Christian University was also reported.

# BUDGET FOR 1931-32

The budget for 1931-32 was explained as to its new form and rate of exchange at three to one. A copy of the budget having been distributed to the members of the Board for study about two weeks before, it was

M-641 VOTED that the budget for 1931-32 be adopted.

### SUPPLEMENTARY BUDGET

The supplementary budget was then taken up and carefully considered. It was

M-642 VOTED that the supplementary budget which calls for \$85,750 local currency for urgent new needs, as presented by the president, be adopted. The order of the different items is however not necessarily an indication of their comparative urgency.

### UNIVERSITY TREASURERSHIP

There was discussed the problem of the treasurership at the University, and it was noted that Mr. James H. McCann, the present acting treasurer, would leave for the north shortly, and another person must be found to take his place before Mr. R.W.McClure's return to Foochow. It was

- M-643 VOTED that the Board request Rev. Henry V. Lacy of the Methodist Episcopal Mission to kindly serve as acting treasurer of Fukien Christian University, beginning May 1, 1931.
- M-644 VOTED that the Board of Managers of the Fukien Christian University heartily thank Mr. James H. McCann for his services as Treasurer of the University, and do wish to put on record their deep appreciation of his unfailing energy and great devotion to his work on behalf of the University.

Gift of Chinese Library - terms of Acceptance.

The President reported that the negotiations regarding the actual handing over of the Chinese Library, the gift of Dr. Ding Baik Cleng (tutor to the lest Manch: Emperor) were about to be completed, having gone on for over a year, and entailing the necessity of several visits to the ancestral home of Dr. Ding. The library consists of over 34,000 volumes some of which are most rare, and valuable.

Terms of acceptance. The President then submitted to the consideration of the Board, a letter he had prepared accepting the gift of the library, in which letter were stated the terms of acceptance.

1. The University gratefully accepts the Chinese library, the gas of Mr. Ding Baik Cieng, and propose to have it placed in the University and to have all the books belonging to it catalogued and numbered wit the other books of the University so as to form permanently a part of the University library.

- 2. These Chinese books are to be placed in a special alcove in the University library, to be called "The Ding Baik Cieng Alcove".
- 3. We propose to hang on the wall a framed photograph of our benefactor Mr. Ding Baik Cieng and a scroll inscribed in his own writing.
- 4. We propose to secure a sum of \$3000 by subscription, with which institute a prize to be called "Ding Baik Cieng Chinese Culture tize" the prize each year to come from the interest of the fund.
- 5. Whenever the eldest son of our Benefactor (through whom the Brosident made all necessary arrangement regarding the presentation of the Chinese Library to the University, and who resides in the ancestral home near Foochow) comes to read in the University library, he is to be the official guest of the University.

### Reduction of Grants from the Miss on Buards

After some discussion it was clear that the favorable exchange on gold has been the one thing that has embled the University to go on with her work financially, that added to her other financial difficulties has now come the reduction in grants from the various missions and Churches concerned. It was therfore

M.695 VOTED to send a letter to the C.M.S. through Bishop Hind and another through the Board of Trustees pleading for further consideration of the question before withdrawing their support. (The President to write this letter.)

Then there followed a careful discussion regarding cooperation between Hwa Man and Fukien, as mentioned in the Correlated Program. A number of means of cooperation were discussed as keing quite practical, but as this Board has many times in the past expressed its readiness to consider any means of cooperation with Hwa Man, it was thought advisable not to approach the Lawa Man authorities again with any specific recommendations until they show some interest in considering with us the ways and means of cooperation.

M 716 VOTED that we report to the Council of Higher Education at its next meeting our readiness to consider any practical means of cooperation that will be acceptable to Hwa Nan.

#### Rural Extension Service

The President reported that there have been demands from both the Church people and the government for us to give more direct service with regard to rural reconstruction work in this province. He also stated that F.C.U. has done a considerable amount of work along this line in sericulture, rice selection, frog research, water analysis, poultry growing, bee keeping, etc. The name of Professor Kellogg is widely known in connection with our rural extension work, and his work has been of great value, but on account of the delay of his return and our financial stringency, we have not been able to meet those urgent demands during the last few years. Recently Rev. B. H. Smith of the American Board Mission offered us a grant of \$5,000.00 gold out of a special fund which he raised sometime ago for rural work in Fukien, if we would enlarge out extension service.

M 717 VOTED that we accept Mr. Smith's offer of \$5,000.00 gold; and to express to him our appreciation of his cooperation with us in our rural service work, the President being asked to convey to Mr. Smith the acceptance and appreciation of the Managers.

M 718 VOTED that a committee of three, consisting of Dr. W. L. Beard, Mr. Lin Lei Chuan, and President Lin, be appointed, with power to coopt other members, to draw up a program for rural service for F.C.U., and to report same back to the Board.

#### Financial Policy

A general discussion of the financial conditions of the university was carried on. It was noted that we should have some means of carrying on promotional work abroad in connection with the newly organized Associated Boards in the interest of Fukien. The possibilities of doing some promotional work in China and in the South Sea Islands were also considered. The advisability of accepting specific grants from government and other public institutions was also discussed.

### Cooperation of the Boards of Managers of Other Christian Schools in Foschow

The Secretary read a latter addressed to this Board, signed by Dr. W. Y. Chen, temporary chairman, and Mr. Nga Geng Guong, temporary secretary of a meeting of the representatives of the Boards of Managers of Christian Schools in Foochow, to advise whether or not there should be organized an association consisting of two representatives elected from each of the Boards of Managers in Foochow for the purpose of the exchange of ideas with regard to educational policies and closer friendship and cooperation among the various boards.

The movement is to take in the rural life as a whole which embraces economics, health, education and the spiritual side of community life. present resources at the university and other movements in Fukien were also briefly stated. 2. Report by Mr. Howard Chang on the work at Foochow Union High School. He gave an account of the experimentation work on horticulture, pig raising and beekeeping. A certain amount of social education, health work and social service to the families were also reported. 3. Report by Mr. Lin Le Chuan as Principal of the Government School of Forestry and Agriculture. Rural service work has been conducted in a village about two miles from North Gate. Help of various kinds has been given to villagers. They secured the village gentry as directors of the work with school representatives on the local board. A graduate was employed at \$20.00 per month to conduct two night schools, one reading room and one tea garden, and to carry on a certain amount of investigation work. Mr. Guy Thelin of the Union High School reported on the Rural Service Union in North China, pointing out ten points of work which we might do in Fukien. A general discussion was carried on as to the kinds of service needed in Fukien and how the various agencies which are already in operation for such service could be coordinated. It was finally agreed to ask Mr. C. J. Lin to work out a program based on the discussion, same to be presented for further consideration on June 5. C. J. Lin Secretary

# Report of Gifts

Gift of the Chen Library. The President reported that the larger part of the Chen Library has been moved into a room in the Science Hall, as the University Library, in the Arts Hall, is over full. There are already 21,814 books, consisting of about 80,000 volumes, and divided into 2,813 sections. These are placed in twenty-seven Chinese book shelves. Some of the books are in special boxes, of which there are about 90. Agoording to the Librarian's rough estimate the books are worth at least M\$40,000. Among the collection there are some very valuable books and editions from the Tang, Sung and Ming Dynasties, and some of those from the early part of the Ching Dynasty could not be duplicated anywhere in China. There is still a portion of the library in Peiping and Tientsin which has not been moved to the university.

The President then recommended the two following amendments to the original terms of acceptance of the Chen Library (see Minutes of Meeting of Board of Managers held on June 10, 1932): Item 5: "Whenever the eldest son of our benefactor, through whom the President made all necessary arrangement regarding the presentation of the library to the university, and who resides in the ancestral home near Foochow, comes to read in the University Library, he is the official guest of the University.": which is to be amended to read as follows:

- (1) When our Donor, Dr. Chen, himself, comes to the University, he is to be the guest of honor of the University.
- (2) The University prepares five admission tickets with names and photographs attached, to be issued when required to the five sons of the Donor, which tickets shall admit bearers to the University Library subject to the rules of the library. If, and when, the University finds this privilege is abused, the University retains the right of cancelling the said tickets.
- (3) The University issues a special admission ticket to our Donor, Dr. Chen, which shall admit him to the library, and to all the rights enjoyed by regular memoers of the faculty in the use of same.

The President further reported that of the \$5,600. Mex. set apart for the mending of old manuscripts and books belonging to the Chen Library, \$3,000 has already been given to the Chen family for the delicate and costly task of making good lost pages, mending torn and worm-eaten volumes, and mending all the volumes, and seeing that all sets are complete. \$3,600 more will be sent to the Donor when the transaction is completed and the last word comes from cur Donor, whose final statement signed by himself once secured, will settle all questions to our rights to the Library which may be raised in the future by other members of the family or by descendants thereof. The President further proposed that out of \$10,000 set apart several years ago for this Library, \$7,000 being paid for the actual cost of restoring, rebinding, removing and shelving of the books, the remaining \$3,000 be used as the basis of the Chen Scholarship.

M 726 VOTED to accept the above amendments to the original terms of acceptance, and the apportionment of the sum of M\$10,000 set apart for this Library, with grateful thanks to the President for the trouble he has gone to, and the many difficult hours spent, in securing for the University one of the best Chinese libraries, which will be a tremendous asset to the university in years to come.

#### Problems Relating to Finances

Members whose names are starred above were present. There were present also Dr. W. C. Fairfield and Mr. F. T. Cartwright, Trustees of the University, and Mr. Theodore H. E. Chen, the Dean of the University. The Chairman, the Rev. Lin Yu Shu was in the chair. The meeting opened with prayer led by the Rev. E. M. Norton.

### Welcome to Dr. Fairfield and Mr. Cartwright

The Chairman on behalf of the Board of Managers extended a very warm welcome to Dr. Fairfield and Mr. Cartwright, Trustees of the University. The Managers rose to signify their appreciation of the presence of the two members from the Board of Trustees in their midst.

### Approval of Minutes of Last Meeting

 $\underline{\text{M 764 VOTED}}$  to approve the minutes of the last meeting of the Board held on September 29, 1934, as distributed to the members.

### Report of the Acting President

1. Scholastic: Though the number of students has slightly decreased since the last meeting of the Board, yet a splendid spirit has been manifested by the staff and the student body.

Two Inspectors were sent by the Nanking Government to inspect the University recently. One of the inspectors was

specially interested in the teaching of Science, the other was an authority on the teaching of Arts subjects. They were extemely pleased with the work done at the University. were particularly pleased with the Science work. They considered the equipment for scientific studies at F.C.U. far superior to that of many a college and university in China. They were greatly interested in the Workshop of the Physics Department, as most of the implements and appliances were manufactured They were impressed with the Research work carried on by the Professors of the various departments, on subjects connected with local conditions in Fukien, e.g., Professor Sutton's research work in Fukien Clays, Professor Wang's analysis of the water of the Min River, Professor Cheng's study of Fukien Birds, and the research work done by the department of Chinese in Fukien Folklore.

- 2. Religious: The students have been showing a deeper interest in things spiritual. Near the end of the fall term a special evangelistic campaign was held for three successive mornings during the chapel period. Practically the whole student body was present. This was followed by personal interviews and discussion groups, some of which are still meeting.
- 3. Visit to the Ministry of Education: The Acting President reported on his recent visit to Nanking and his interviews with the Minister of Education and other government officials. Most of them have heard something of the good work done at F.C.U. but they complained of the meagerness of literature on the subject!

#### The Dean's Report

The Problem of Small Number of Students Matriculating. The number of students has decreased, that is to say the men students have decreased but the number of women students has steadily increased. In the first year when women were admitted as students, we had seventeen women students; the second year we had 26; in this third year we have 35. We are thus faced with the problem of how to increase the number of students and how to induce students from places other than Foochow and its vicinity to come to F.C.U. The Dean reported that since Swatow Academy was placed on the list of recognized schools there has been a closer relationship between the two institutions, Swatow Academy sending one woman student and four men students to F.C.U. He also mentioned a school in Canton long petitioning to be "recognized" by the University, and the delay due to the difficulty of sending some one to inspect the school. Finally Mr. Munson was authorized to act as our representative to investigate the scholastic standard of the school. There is now every likelihood of the school being affiliated with F.C.U., and therefore some prospect of students from Canton for F.C.U.

- The Special Place of F.C.U. The Dean pointed out two obvious but fundamental principles in the development of F.C.U. First, the development of F.C.U. must be directed toward quality rather than quantity. We must be content to remain a small college - say with a roll of three hundred students. Second, we must remain more or less a provincial college serving provincial needs. We have therefore an important place in this vast province and a very special contribution to make - e.g. rural service, teacher-training, neither of which is undertaken by any institution in our province.
- The Problem of the Future Careers of Our Graduates. begged to have the advice and help of the gentlemen of the Board on this subject. Each year, he finds greater difficulty in finding employment for graduates. The question he pointed out will also affect the number of students matriculating.

#### Discussion Following the Reports

The Chairman expressed the Board's deep sense of thankfulness in hearing these reports and in hearing about the special contributions F.C.U. is making to the country in general and to Fukien in particular.

Some discussion then followed in the course of which the need of developing and strengthening particular departments in order to better equip the students to meet the demands of the times, was recommanded.

#### Budget for the Coming Year 1935 - 1936

The Treasurer, Mr. R. W. McClure, presented the Budget for the coming year and made the following statement about the financial difficulties with which the University is faced:

"The net decrease in our income through the Trustees for the year 1935-36 as compared with the year 1934-35 is \$8,717.79 Gold. This includes the \$5,000 which has been coming from the Rockefeller Foundation, but which will not be paid after this year.

"This decrease in income from America is further augmented by the sharp drop in exchange so that our predicted income for next year will be at least \$30,000 Mex under our income for the present year.

"There is some hope that President Lin, now in America, will be able to raise some special funds. Also that Mr. Stowe now on furlough, may be able to raise special funds. We cannot however rely on these sources of funds with confidence:

"Our furlough reserve fund holds about \$40,000.00 from which we are obligated to pay the expenses of President Lin in America, and also the travelling expenses and furlough allowance of Professor Martin, who goes home on furlough this summer. It does not seem the part of wisdom to underwrite next year's budget to the extent of \$30,000 Mex. from the furlough reserve fund. The treasurer would recommend that not more than \$10,000 be taken from the reserve fund for this purpose."

After some discussion it was

M 765 VOTED to refer the Budget back to the Treasurer, the Acting President and the Dean, with specific instructions to try to bring it within the income.

### Appointment of Dr. S. C. Chen and Reduction of Staff.

The Acting President informed the Board of the long and faithful service rendered by Professor Martin, and of his return to Australia this summer. He also informed the Board of Dean Marie Yu's leaving the University after three year's service as Dean of Women. The Acting President then asked the Board's approval to the appointment of Mr. S. C. Chen, M.S. (Pennsylvania) Ph.D. (Pennsylvania) as lecturer in Physics and Mathematics. Mr. Chen has had several years of teaching experience in Howard University, Washington, D.C. President Lin met him in America and invited him to come back to China to join the F.C.U. staff.

M 766 VOTED to approve of the appointment of Dr. S. C. Chen as lecturer in Physics and Mathematics, and to consent to Professor Martin and Dean Yu leaving the University at the end of the term.

M 767 VOTED that the Secretary be instructed to write to Professor Martin and Dean Yu to express the Board's deep appreciation of faithful service rendered to the University.

### Co-operation Between F.C.U. and Hwa Nan College

The Report and Recommandations of the Joint Committee representing the Boards of Hwa Nan College and Fukien Christian University were distributed to the Members and after the perusal thereof and some discussion it was

M 768 VOTED that on the return of President Lin and President Wang, the Executive Committee meet with the Executive Committee of Hwa Nan College and the two Presidents to discuss this matter more thoroughly.

#### Rural Service Programme

The Acting President reported the splendid results of the work of the Department of Rural Service at Nieu Tien and of the coming visit of Dr. Gunn of the Rockefellor Foundation, to see the work already accomplished at Nieu Tien. It was felt by the members of the Board that F.C.U. ought to try to meet in a more practical way the needs of the Province. It was suggested that a course in Agriculture be added to meet the need of North Fukien. Dr. James Ding reported that at the meeting of the Heads of the Christian Schools in Foochow an earnest request was made that F.C.U. open a summer school for teachers giving special attention to the Principles of Education and to Science and Mathematics.

#### Raise in Salary for Prof. T. L. Lin

M 769 VOTED that in view of the shortage of funds the question of raising Prof. T. L. Lin's salary be referred to the Committee on Budget.

#### Publicity Work

The Acting President reported that President C. J. Lin has been able to meet many old supporters of F.C.U. and to create interest in prospective supporters. Hence the importance of continuing this work.

The Chairman remarked on the "Cultivation Work" accomplished by the Acting President, Dr. W. Y. Chen, in his visit to Nanking and other parts of China.

It was pointed out that there is still much ignorance even within the country about F.C.U.; people often confusing F.C.U. with the Union Medical College in Peiping or the Union Theological College in Canton!

M 770 VOTED that the Acting President write on behalf of the Board of Managers to the Board of Trustees asking them to take measures to follow up the work that President C. J. Lin has started, suggesting the name of Mr. Stowe with a view to his being asked to give what assistance he can.

After sitting for three and a half hours the meeting adjourned.

Members whose names are starred above were present. It was an exceptionally well attended meeting. All members resident in Foochow and its neighborhood were present to welcome President Lin back. The Chairman, the Rev. Lin Yu Shu was in the chair. The meeting opened with prayer led by the Rev. Phillip S. S. Yu.

### Approval of Minutes of Last Meeting

M 771 VOTED to approve the minutes of the last meeting of the Board held on May 18, 1935, as distributed to the members.

### The President's Report

The President referred first to his printed Report sent out some time ago to Members of the Board. What he said this morning was mainly about the new term's work and a supplement to what he had already given in his printed report. He dwelt on the following points briefly:-

- 1. <u>Last term's graduates</u>. There were twenty-nine graduates at the last Commencement the largest class to graduate in the history of the University. Of the twenty-nine graduates practically every one is now engaged in some useful work. Some of them were invited to important posts three or four months before their graduation.
- 2. Closer relationship between the University and the Government.
  After conducting the Rural Reconstruction Experiment Station at Wu Li Ting (a group of twelve villages) for six years, the Government has handed over this work to the University, together with a grant of \$350 a month. To give an idea of the vastness of the task the President gave the following intersting statistics:

Wu Li Ting consists of 12 villages, 1050 families, a population of 7602, 1764 children of school age. The University has already undertaken work in rural production and social education among the twelve villages. The President also reported that the Ministry of Education has endowed a chair of Mathematics and Physics (\$4,000 Mex. year) in addition to the special grant of \$5,000 for the Science Department.

- 3. Students this term: At the Entrance Examinations we had the largest number of applicants some 120 students. Of this we received sixty about fifty percent of the applicants were admitted. The present number of students is 163 one fourth of this number are woman students. Over sixty percent of the students are Christians and about sixty one percent are majoring in science.
- 4. Teachers. The staff has been reduced by five. On account of the difficulty of balancing the budget a number of assistants had to be dropped. Mr. Stowe is on furlough. Dr. W. Y. Chen has been loaned to the Youth and Religion Movement and is doing splendid work throughout the country. Over eleven thousand students have been to hear him and his colleagues in Peiping and Tientsin. In Tientsin over two hundred students decided to become enquirers.

All the teachers on the staff of F.C.U. are Christians.

The general opinion is that we have never had a stronger faculty at any time in the past five or six years.

M 772 VOTED to acce t the President's Report.

### The Treasurer's Report

The Treasurer referred to the Annual Report for the Fiscal Year July 1, 1934 - June 30, 1935, which has been distributed to the members of the Board.

A word of explanation about the surplus - M\$2,734.14. On account of financial difficulties expenses were cut down. Hence the surplus.

Auditors. At the last meeting the Acting President forgot to bring the matter to the attention of the Board. So the Treasurer asked that auditors be now appointed.

m \underline{M}}$  773 VOTED to elect Messrs. Hu Sie Guong and Lau Kieng Guong to act as auditors.

#### Absolute Charter: Question of Granting Degrees

The President informed the Board of the Granting of the Absolute Charter to Fukien Christian University by the University of the State of New York. Heretofore every year the University has had to report the work of the graduates before the University of the State of New York could grant them their degrees. Therefore it usually took a year for a graduate to get his diploma from America. Now that the University has been granted the Absolute Charter it ought to simplify matters. But the University of the State of New York only recognizes the Trustees of Fukien Christian University. So the difficulty remains. The Administration still has to send an account of the graduates' work to the Board of Trustees, and it will therefore still take about a year's time for a graduate to get his diploma. The President pointed out that in the case of Yenching and Cheloo, the Boards of Managers act for the Board of Trustees. After some discussion it was

M 774 VOTED that we greatly appreciate the offer of the Board of Trustees to delegate their authority of granting degrees to the Board of Managers and accordingly request that we be so authorized hereafter to grant degrees, as is being done with Yenching and Cheloo Universities.

#### Government Recommendations

The President read part of the memorandum sent to the University by the Ministry of Education in which the Ministry shows their deep appreciation of the work being done at the University. In the memorandum the Ministry of Education goes on to make some recommendations. They are:

- 1. Re-adjustment of names of the various departments and faculty committees.
- 2. Financial Endowment. The Ministry noted that almost every year there is a deficit. They recommended to the Board of Managers that they secure definite endowment funds. They pointed out that the Administration and General Expenses were above the standard fixed by the Government. This last President Lin explained was due to the big nominal sum put down as Property Rent and Plant Depreciation.

After some discussion it was

M 775 VOTED to re-adjust the names of the various departments according to Government regulations.

M 776 VOTED that we should work for a substantial increase in our endowment fund, and we appeal to the Board of Trustees, urging them to lend their influence and effort toward this end in America.

 $\underline{\text{M 777 VOTED}}$  to approve of the idea of re-organizing the various Departments in the Arts College and to delegate to the President authority to do so.

#### Staff Appointments

The President stated that Miss Thomas has been taking special studies in English and method of teaching the same in Columbia University last summer and in the University of California this fall. #### Promotion of Rank

### M 781 VOTED to approve of the following promotion in rank:-

- 1. Associate Professor Malcolm F. Farley, M.A., advanced to the status of full Professorship in Western Literature and Arts, after fourteen years of service.
- 2. Dr. Francis Chen advanced to the status of Assistant Professor of Rural Economics, after two years of service in the University as a lecturer.
- 3. Mr. Y. C. Lin, B.S., C.E., to be advanced to the status of Assistant Professor of Physics and Mathematics after four years of service as lecturer and instructor.
- 4. Mr. Cheng Ching Tuan, B.A., M.S., to become Instructor in Biology after three years of service.
- 5. Mr. Lin I, B.A., M.S., to become Instructor in Chemistry after two years of service.

M 782 VOTED to appoint Mr. Kan Ching Hao, B.A. 1935, Graduate Assistant in Chemistry.

### Budget for 1935 - 36

The Treasurer pointed out that he has been able to balance the budget only by reducing the expenditure almost by half.

It was also pointed out that by taking out the nominal property rent and plant depreciation which amounted to some \$90,000 we would be able to reduce the Administration Expenses, the presence of this big sum having led to some misunderstanding on the part of the Government.

M 783 VOTED to request the Board of Trustees to reduce the nominal rent to a thousand dollars.

#### Honorary Teachers

M 784 VOTED that the names of Honorary teachers in the University be placed on the list of faculty members in the catalogue and that the Administration be authorized to give them appropriate faculty rank.

M 735 VOTED to put on record the Board's deep gratitude for the many years of devoted service rendered by Mrs. Roderick Scott as a teacher of music, and as an expression of our gratitude we vote to set apart a special sum of \$235 from the Contingent Fund, which sum, together with the \$155 put down in the Budget for the department of Music, making the total sum of \$400 - be allotted to her work.

M 786 VOTED that Bishop Gowdy as one of the oldest members of the Board, be asked to write to Mrs. Scott in the name of the Board to express our most heart-felt thanks.

#### The Budget Again

The Board then returned to the question of the Budget. It was explained how the adminstration did its best to reduce the deficit, but that after all their efforts there was still a deficit of about \$20,000, Chinese currency. At the meeting of the Board of Trustees in New York, the Trustees undertook to underwrite US\$8,000 which made it possible to balance the Budget.

M 787 VOTED to approve the revised budget for 1935-36.

The President then gave a short account of his visit to Salisbury Square and his appeal to C.M.S. Headquarters for help, and their promise to do what they could.

M 788 VOIED to write to the Chung Hua Sheng Kung Hui and to the C.M.S. asking them to continue their support of the University.

The Surplus. It was noted that there were old building debts amounting to over one thousand and seven hundred dollars.

 $\underline{\text{M 789 VOTED}}$  to dispose of the surplus in the following way (1) To clear off the old building indebtedness (2) To assign the rest to the building and land fund.

### Co-operation Between Hua Nan College and F.C.U.

After some discussion it was

M 790 VOTED to signify the Board's approval of what has already been accomplished in the Exchange of Professors (2) to indicate our desire for more exchange of professors (3) to request the two Presidents to discuss the question for a much closer co-operation between the two institutions and arrange for a joint meeting of the Executive Committees of the two Boards of Hanagers for a thorough discussion of the Trustees agreement.

The meeting then adjourned.
