Dear Sir:-

I would much appreciate it if you could send me a statement of the dates and amounts of remittances from the American Board for the running expenses of Fukien Christian University. I find that in our Prudential Committee votes of authorization there is a little confusion as to what periods the various votes cover, and if you could indicate also the fiscal period covered by the remittances which we have made, it would help me to clear this matter in my own mind. I believe that Dr. Strong has informed you that the Committee has voted that \$\frac{1}{12}\$,000. of our share of the amount necessary for land and buildings in order to secure the China Medical Board gift, has been voted, and I will plan to forward this to you at the end of this month.

After my six years at Foochow, I have become very keenly interested in the work of the University, especially through my personal friendship with Ir. Scott. The work of the arts course under his direction as Dean is certainly fine, and I feel that the School, even in its small beginning is measuring up finely to the hopes that we all have of the use that this University will be in the work of Christian education in our province. You may be interested to know that Ir. Lin, one of the first class of graduates who studied in Oberlin last year, receiving his Master's degree there, is now studying for his Ph.D. at Harvard, and I have occasional opportunity of seeing him. His record here certainly shows credit to the School.

Complying with your request of the 10th instant, desire to state that the following are the only remittances I have a record of, as coming from the American Board:

In regard to these two last items, there can be no doubt as to which year they applied on, as the first payment from the China Medical Board was received in May, 1919, - the second in April of this year.

As Treasurer, I deeply regret that it will be impossible for the American Board to pay more than one half of its share toward meeting the China Medical Board Grant for the Science Building. With the expected remittance of \$8.000. from the American Board this month, and \$5,000. from the Reformed Board, there will have been

provided in cash toward meeting the conditions, \$39,000.. or \$9,000. short of the required sum, and I am fearful that the China Medical Board will lose patience and refuse to grant a third extension.

Another matter which is worrying us is where we are to get the funds to meet the 1921 budget adopted by the Board of Managers in Foochow. As you know, the co-operating Boards are each furnishing missionaries for carrying on the work of the University, and in addition making a pro rata payment toward the expenses of the Science Department, but in addition to all this, it would appear from the budget sent us, that they will require between \$16,000. and \$20,000. additional for the coming year, and I do not know of any Board in a position to meet this situation. Perhaps from your intimate knowledge of the field, you can enlighten me if I am unduly worried.

Dear Mr. Carman: -

I thank you very much for your letter of December 13th on the matter of our American Board payments for the Fukien Christian I am now able to clear up the question of the years in which our various Committee votes are applicable. We have been getting a little ahead of ourselves and have already passed votes enough to pay the grants through 1922. According to the information which you send, our next payment should be for the calendar year 1921, and I will endeavor to send this amount to you sometime in the first part of the year.

I was somewhat surprised to hear that the Board of Managers' budget for 1921 would carry such a sum as you indicated. As I do not know what items of this cover work already under way, or absolutely necessary expenses, it is rather difficult to give you any enlightenment I do feel that there is a lack of understanding on the part of on it. those on the field as to the financial situation and resources of the Board It is possible that with Mr. Jones on the field now, that matter may have been considerably improved, but during the time when he was at home, the Board of Managers had to proceed very much in the dark as to what financial resources were available. It seems as though a better co-ordination between the Trustees and the Board of Managers, especially on matters of finance, would be very desirable. I am not saying this in any spirit of criticism, because very much the same applies to the case of the relations

between our Board here and the Mission organizations on the field. We need to know more and understand more about the situations at the other end.

I am afraid this comment has not contained anything of help or of information to you in your question concerning the 1921 budget, but I have just spoken of this to Dr. Strong and I want to get this word to as many of the Board of Trustees as I can.

Bear Mr. Belcher:

Thank you for your letter of the 14th. I think it will be necessary to advise even President Jones of the necessity for going very slowly on his budget. I do not believe anyone on the field realizes the serious financial situation on this side. When President Jones left, the Inter-Church World Movement had not been pronounced an impossibility, and I think that he with all others, believed the various Boards would have sufficient funds to make the necessary increased appropriations on the budget account, whereas quite the contrary is now the case.

He has also been counting upon the Boards making good their pledges to meet the China Medical Board grant on the Science Building, which seemed an assured fact when he left. Since that time, however, the American Board has felt the necessity for cutting its pledge in half, and I doubt very much if the Methodist Board can do more than pay its full prorata share, which has already been done. This of course means that we not only face a deficit on the subscriptions of at least \$9,000., but a like amount from the China Medical Board, - a total deficit on the Science Building of \$18,000. This he must be apprized of at once.

If you can make it possible to send me the \$5,000. voted by your Board in the very near future, I will be able to report to the China Medical Board in good season before the end of the month, so that they may meet the cash in hand by their pro rata share, and I may then have a good basis for asking an extension on the balance.

Dear Mr. Carman: -

Your letter of December 15th is received. and under the circumstances I think that it will be possible to forward to you immediately the \$8.000. voted by our Board for the Building account of Fukien I therefore enclose check to your order on the Christian University. Old Colony Trust Co., Boston for \$8,000. I hope that with this evidence of our acceptance of the obligation and with our tentative promise to provide the rest in 1921 you will be able to induce the China Medical Board to grant an extension on the balance of their appropriation. The Prudential Committee of the Board felt very keenly that it could not meet its obligation after two years' extension had been granted, and with the deficit of our last year to take into account and the uncertainty of our new financial year, they felt that this was the best that they could possibly do. I am glad that the check from the Reformed Board has already reached you.

I think you are wise in advising President Jones and the Board of Managers on the field of the necessity of planning conservatively. The Interchurch Movement so raised our hopes of a real adequate backing of the work on the field that it is extremely difficult to get the Missions to realize that all we can do is to keep the work going without making any definite advance.

I have just received a letter last night from Dean Scott in which he comments on the activities of the School. They have

My dear Mr. Carman:

Dr. Barton has brought to me your letter of May 13, inasmuch as he was not conversant with the matter of which you wrote and I am supposed to be so.

I am sorry indeed for the delay on the part of this Board regarding the meeting of its share of the obligation to provide \$48,000 to meet the China Medical Board's conditional grant of \$50,000. As I wrote you November 26, 1920, the Prudential Committee at its meeting on that week voted to appropriate the sum of \$8,000 in part fulfilment of its obligation of \$16,000 toward the sum of \$48,000. I expressed at that time the Committee's regret that it could not at present meet the full obligations, in view of the Board's financial difficulties.

I recognized that this might involve the necessity for the China Medical Board to prolong into another year its conditional offer. At a meeting of the Trustees of the University, commenting on this action of the American Board I indicated the Board's desire and purpose to provide the other \$8,000, completing its share of the obligation, during the year 1921.

On January 5, 1921 I wrote to Mr. Embree directly regarding the matter, expressing this Board's regret at its tardiness in meeting its full obligation, setting forth the the financial struggle that the Board was having and saying that it was earnestly hoped that during the year 1921 it would be possible to pay over the other \$8,000, thus completing this Board's obligation. A reply from Mr. Embree, written January 7th acknowledged this letter of mine, stating that in reply to your request the extension had been granted through the year 1921 and expressing the hope that all payments might be in hand during that year, so that the question of extending the offer for a further period might not come again before the Board. Inasmuch as this Board's fiscal year closes August 31st, and inasmuch as the financial distress is still heavy upon us, it has been our purpose to bring up the matter

between the 31st of August and the 31st of December, when a new fiscal year would be on, in confident expectation that the Board would provide then the other \$8,000, enabling the completion of the matter within the calendar year 1921.

I am sorry indeed over your embarrassment in the matter, and I assure you we are much embarrassed in this Board at the unintended and deeply regretted delay; but we are in such a plight that we have to do many things that are not agreeable or desirable, and this is one of them.

I trust that you will believe that we do not mean to repudiate our obligations or postpone them a day longer than seems to be necessary.

I note that you are sailing for Europe early in June. May you have a good voyage and a restful and rewarding visit across the water.

My dear Dr. Hodous:

I have received this morning cablegram from Foochow, sent in the Missions Code; the original and translation are as follows:

"SYNODICAL NY UKYEDJYXID YALE TAFEREXOVT STOKES SBALHOYXIX BLACK LYAFFCYAGM"

"WILL YOU KINDLY ACT AS MY (OUR) REPRESENTATIVE INSTALLATION YALE PRESIDENT JUNE 22, 1921 STOKES MUST BE NOTIFIED MR. E. C. JONES BLACK AWAIT, LETTERS BEFORE BUYING (MORE) UNIVERSITY SUPPLIES".

Will it be possible for you to attend President Angell's installation at Yals on June 22nd as the representative of Fukien Christian University? I hope you can, since you are near at hand and it would be difficult for me to arrange it. I presume President Jones addressed the request to me with a view to someone's being appointed from among our Trustees to represent the University at Yale at the forthcoming presidential installation. I am not quite certain of the meaning of the concluding sentence but I assume that Mr. Black, of the Construction Bureau, is awaiting letters from us relative to our action upon the budget before buying more material for the erection of the buildings for the University; or does it possibly refer to the purchase of more land? The word used for "supplies" does not seem to admit of the interpretation of "land", as other words are used for that meaning.

My dear Dr. Hodous:

Thank you for your note of September 5th with its acknowledgment of mine announcing a recent appropriation to the Fukien University, and with statement concerning the sending out of two new men for the University staff.

In announcing the appropriation toward the joint University office, I neglected to add another item - that the Prudential Committee also appropriated, upon recommendation of its Higher Educational Endowment Committee, the sum of \$833.33 as this Board's share for one-half the year of the \$5,000 to meet the China Medical Board's conditioned appropriation of \$10,000, the understanding being that this year's appropriations will complete the payments upon that conditioned gift, which was to run for five years; also an appropriation of \$500 was made for the University budget for the first six months of the current year, this also repeating the action of last year only for a shorter period of half the year; the grounds for this action being indicated in the following vote:

"In view of the limited income from the Higher Educational Endowment Fund and of the necessity of revising the list of institutions, and in accordance with the vote of the Prudential Committee taken January 10, 1911, that 'appropriations for individual institutions be made upon the basis of need, opportunity, available resources and efficiency of administration, 'it was voted that the appropriations for the institutions cover six months only of the ensuing school year, namely, from July to December, inclusive, 1922; that a report be requested to be in hand by January 1st, 1923, from each institution aided by the Fund, stating the uses to which the appropriation has been put, its available resources, curriculum and general educational standards, and efficiency of administration; that in the following years such reports be in hand from each institution no later than February; that this year, and also in subsequent years, the institution failing to report shall of necessity be dropped from the consideration of the Committee."

I need not say perhaps that this limited action was not due to any suspicion or hesitancy concerning Fukien University; it was action taken concerning all the grants made from the Higher Educational Endowment Fund this year, and for the reasons stated.

A further appropriation of \$270 was made for the first six months, in accordance with the action of preceding years, for the Union Theological College. My understanding is that this Theological College is now merged with the University, or at least conducted as a department of the University, so that this appropriation should be sent to the University as a part of the Board's contribution thereto. May I ask you to let me know at once if this is not right? We propose to remit all these appropriations through the Treasurer of the Board of Trustees in this country, and if this Theological appropriation does not go to the University our Treasurer ought to know it at once so that he may make proper remittance. I am sorry to bother you about the matter, but I do wish to have my understanding verified.

At the meeting of the Board of Trustees of Fukien University helf November 28, the following action was taken in regard to changing the charter to allow for additional members on the Board of Trustees:

T-539: VOTED to request and authorize the President and the two Secretaries to take the necessary steps to secure the following changes in the charter, namely:

- (a) enabling each co-operating mission board to appoint one additional member on the Board of Trustees;
- (b) that the board thus enlarged be empowered to elect additional members not to exceed one-half of its board-elected members in number.

In going over this matter with the legal adviser of the Methodist Board. Mr. W. O. Gantz, he says it will be necessary for us to secure the consent of all the cooperating boards before taking the steps necessary with the State Department of Education. May I request that you will take this matter up with the Congregational Board, and let us know as soon as possible whether they will approve of such a change in the charter for Fukien University.

My dear Dr. Strong: I write to convey to you the action of the Trustees of Fukien Christian University in their annual meeting October 10, with regard to the proposals for a joint financial campaign on the part of the various colleges and universities of China in this country. The action taken by the trustees is as follows: PROPOSALS FOR JOINT FINANCIAL CAMPAIGN "The Assistant Secretary presented the proposals looking toward a co-ordinated effort by the China Colleges and Universities for the raising of funds in this country. These call for the establishment of a committee composed of one representative from the governing board in America of each of the institutions participating and five additional members at large to be co-opted, which committee shall be charged with working out the plans for such an effort and also for setting up an advisory body of educational experts who can give advice on the problems involved in college and university management in China. It Was "T-569 VOTED that this board approves the above plan in general, with the understanding that this does not commit them to any specific program of procedure for campaign; YOTED to appoint the President of the Board. Wm. I. "T-570 Chamberlain, as our representative on the committee: VOTED to appropriate \$100.00 toward the initial ex-望-571 penses of setting up the plan, with the understand ing that further expense will be borne by the campaign." The committee which is responsible for preparing the general proposals for this campaign stipulated that the campaign should only be organized in case at least two-thirds of the universities and colleges agreed, and two-thirds of the misboards co-operating in these various institutions should agre

I am therefore writing to you to ask that the Congregational Board shall give its approval for the general proposals as outlined. I think that it would be perfectly in order for the Congregational Board, if they are so inclined, to approve the proposal for all of the institutions in which they are concerned in China at one time, although the other institutions have not yet been able to take the action required.

It may be of interest to you to know that the Presbyterian Board has already taken an action of this sort covering the institutions in which it has a share in China.

I telegraphed you yesterday morning as follows: "FUKIEN BUDGET NOT YET ADOPTED PROBBBLY AT LEAST FOUR THOUSAND OFFICE SIX EIGHTY FIVE" We had just received from China two days ago the budget for Fukien University for next year so that there has been no opportunity for the Trustees to act upon it. The badget calls for a larger expenditure than last year. de not know what action the Trustees will take, but am inclined to feel that they will quite possibly ask for a repetition of last year's appropriations and request the Managers on the field to reduce their budget to meet the amount provided. Your Board provided \$4,000. for this year on general appropriation. In the heat of the moment in getting off a telegram to you I overlooked the fact that each of the Boards also make a supplementary appropriation for the science budget under the terms of the C.M.B. grant to the University. For your Board this amounted to \$1,666.66 gold during this year. This amount would probably need to be added to the \$4,000. mentioned above in your figuring for the University. I am very serry for my shortcoming at this point and hope it has not caused too much inconvenience. With regard to the Central Office. On May 14th I wrote acknowledging the receipt of \$2,833.33 on this year's budget. Therefore the total received up to November 25th on this year's budget was \$3,341.77. Replying to your letter of January 14th. regarding the expiration of Professor Hodous's term on the Board of Trustees of Fukien University. I have to report that at the meeting of the Prudential Committee yesterday it was voted to appoint Professor Hodous to succeed himself as such representative.

Replying to your letter of March 11, received yesterday, inquiring as to the possibility of the American Board's securing a gift that will provide a residence for one of its representatives on the staff of the University at Foochow, I can only say that the possible source that we have had in mind for this gift is at Los Angeles. California. I wrote to the Minister of the Church there on January 28 of this year, and not having heard from him wrote again on March 3. I have not had an answer either to the second letter, but there is hardly time for that. since he would need to have written almost immediately on receipt of it if his letter should have reached here by this time. I fully expect to hear from him, and that before long, and will keep in mind the letting you know as to the nature of the reply when it is received. not give you any assurance until I do hear from him other than to say that the Church has sent one or two contributions, meeting at least part of the expense of such a residence. I shall hope to be able to give you fuller and more exact information before very long.

Dear Mr. Moss:

In connection with laying before the Trustees of the Hall Estate one of our institutions in India, concerning which they have been making inquiry, it is possible I may have chance to follow up with them a suggestion I made concerning a gift from that Estate to Fukien University. not sure just how things will turn, but have prospect of an interview within a week or so.

On looking over my files of documents I find I have not at hand all the data I would like to have, if I get the chance to set Fukien University's case before them. wonder if you have any maps, drawings or pictures that would visualize the location and plant; or any recent report of the University's working, numbers, growth, etc. I have a set of those little leaflets which Dean Scott got out, and I have some statements of President Jones made from time to time during his incumbency of office. But of more recent and up-to-date information I do not find that I have facts such as I would like to have to present. I suppose I ought to have some financial statement, at least the budget for the year, showing the total estimated expenditure for current purposes, the amount of value in buildings and land, and amount of present endowment which I understand to be nothing, and any other facts which would give them an idea of what the University now is and has.

I confess I am a little disturbed at the thought of laying before them just the financial situation with its obvious applying of funds given by the China Medical Board to other purposes which necessitate virtual repayment of that amount, but I think short of going into that matter in detail I may be able to put together figures which will show both the achievement and the need of the University and may incline them to feel that they are asked to help a going and a growing They will not want to send one good dollar after a bad one, or to turn their trust funds to the support of something which is in unstable or critical condition. I do not

regard the University as being in that condition since it has behind it these Mission Boards and since, I think, the Board of Trustees are determined to press for funds that may lift it out of its present distress. But I apprehend that the best argument to present to the Trustees of the Hall Estate would not be the present distress but the present achievement and the future prospect.

Can you help me by sending me some material as promptly as possible that I may have it for use if, as I say, the way opens?

Dear Mr. Moss:

I am returning to you under other cover the photographs of Fukien University which you kindly loaned me.

We had our meeting yesterday with the Trustees of the Hall Estate. It was an informal meeting, at which we talked over various matters that have been put up to them by this Board, in addition to some general discussion as to the needs of the different lands and the comparative responsibility of America therefor. They have not got around yet to the point where they are ready to make decisive appropriation of any considerable amounts to educational institutions, though they are forming their opinions on general lines and gradually picking out institutions that they may put into their tentative list.

I may say to you that they are very favorably disposed toward Peking University and the Canton Christian University. As I understand they have already done something for Canton, and I think they contemplate substantial aid to They did not commit themselves yesterday towards any Peking. of the matters that were put before them, but they gave close and interested attention and asked many questions. the help of Professor Hodous, the Secretary of our Board, and he was of great value in giving definite and accurate information both regarding the institution and its situation in the I am hopeful that some-Fukien Province educational work. thing may be forthcoming from this interview, but cannot speak with any assurance, much less with any definiteness, as to what or when. The Trustees have five years more in which to make up their minds before the time for disbursing the bequest is reached. I think, however, they hope to have their plans pretty well blocked out by that time and are beginning to think more seriously and particularly of the lands and the institutions they will consider.

The pictures and the statements you sent were of great value to us in laying the case before them, and I thank you for your effort in the matter.

Dear Mr. Moss:-

Dr. Strong has shared with me your letters of May 27th concerning the financial budget of Fukien. Previously we have been checking up and settling up on the basis of the calendar year, and I assume that the fact that the China Medical Board appropriation year ends June 30, 1924 has made necessary the arrangement of which you write, by which there should be paid over by this Board \$2,833.33.

As you know from past experience we have usually planned our finances so as to have a grand settling up at the end of the calendar year. It will, however, be possible to send at this time \$1,835.33, which I am enclosing in a check to the order of the Trustees of Fukien University. This will leave a balance due of \$1,000, which I hope it may be possible for us to settle up at the end of June.

The sheet which you appended showing annual financial needs of the Science Department July 1, 1924 to June 30, 1929 brought a considerable amount of consternation to us, as we saw the figures written down against the Congregational Board. I understand, however, that this is simply a preliminary statement showing the situation that the Trustees must meet and on the basis of which they must reach some decision concerning the Science Department, and the plans which they will make for the financing of it at the expiration of the C.M.B. appropriation. Is it definitely determined that the C.M.B. will not make a new appropriation toward the budget of the Science



My dear Mr. Belcher:

Supplementing my letter of December 16th, and answering your letter of December 13th, let me say that payments in full were made by the American Board upon the budget of Peking University for the year 1923-

February 7, 1924 - \$2,000.

March 1, 1924 1,500.

These completed the payments due up to June 30, 1924.

Your check for \$1.575. to the Trustees of Peking University has just been received. I have credited the account for the fiscal year ending June 30, 1925. The fiscal year of Peking University is from July 1st to June 30th. If it is the policy of the American Board to remit in quarterly installments, this will be entirely satisfactory to us, if the amounts can be made available to us within the first month of each quarter.

I have also to acknowledge your check for \$7,508.43. The \$1,039.99 included in this check completes payment on the American Board's share of the budget of Fukien Christian University to June 30, 1924. I note that the other items included are \$1,968.44 on the Current Budget and \$4,500. the recent appropriation for a residence for Reverend and Mrs. F. P. Beach.

The dates of the Fukien budget have been somewhat confusing, because the field has been accustomed to operating upon a calendar year basis, and then upon a year ending in the China New Year holidays. We shall endeavor to establish a basis on which I think the new field treasurer will agree with us, making the new fiscal year end with either June 30th or July 31st. Our own books here are at the present time being kept on the June 30th basis.

I thank you for your letters of December 16th and 17th in connection with the budgets of Peking and Fukien Universities.

I will plan to make remittance shortly after January 1st covering the third quarter of the current school year, and on April 1st the amount covering the fourth quarter.

I note that at the present time you are keeping the records in regard to Fukien on the school year basis and I have therefore adjusted my record to so correspond. According to this our account on July 1st would stand as follows -

> Balance due from June 30th Share in general budget Share in C.M.B. budget

\$ 1.039.99 1.666.66

On this account I made the remittance in my letter of cember 13th totalling \$3,008.43, leaving a balance still due on the Fukien budget of \$3.698.22. On this account I am making further remittance at this time of \$1.500., and therefore enclose check to the order of Trustees of Fukien Christian University for this amount.

The change on to the school year basis is making a rather difficult situation for us in regard to our appropriation provision, and I fear it will not be possible for us to clear up the full balance on the Fukien account at the end of this current school year. Our American Board fiscal year closes on August 31st, and our budget adopted for that is very rigid.
