My dear Mr. Hussey:

Thank you for your letters of December 14, 1918, and of May 19, 1919. The latter was forwarded to me from Foochow, and was consequently delayed in reaching me. My reply has been further delayed for several reasons.


I hoped to talk the matter over with you while in Peking but found that you were in America. When I arrived here, however, you had already started back to China before I could see you. Furthermore, I have not been in good health while here, and have been unable to attend to some things which should have claimed my attention. Moreover, I have had no opportunity to consult the building committee of the Board of Trustees as to what should be done with your bill. Recently however we had a meeting of that committee, and the question was discussed at some length. The committee feels that the work was done without their direction and consequently they are under no responsibility for the bill. They, therefore, repudiate the claim, and say it is my affair to settle it as best I can.

You know what a missionary's salary is, and the difficulty I would have in paying any such amount as you mentioned in your letter. Would you accept a couple of hundred dollars gold, and cancel the obligation.

In replying kindly address me at Foochow, for I hope to be on my way to China before your eply could reach me in the United States.

I have read through the correspondence you sent me relating to the claim of Shattuck & Hussey for services as architects, and this morning I talked over the telephone with the Rev. A.L. Waunshins. He told me that he thought Mr. Hussey was putting up something of a bluff and my first inclination was to recommend that we sit tight until Mr. Hussey's lawyer sends notice that he is taking further steps.

On second thought, however, it seemed to me that the best proceeding would be to follow Mr. Waunshins's advice, which was to refer the claim for settlement to the local Board of Managers of Fukien Christian University in China. I told Mr. Waunshins I would, with your approval, write a letter to Mr. Hussey to this effect. I am enclosing this letter herewith. If you approve it, will you kindly have it mailed as addressed; if not, please return it to me with any suggestions. If this letter goes I presume that Mr. Waunshins should send a copy of it to the local Board of Managers of the University in China for their information and action.

My dear Sir:

Letters relating to the claim of your firm Shattuck & Hussey, for services rendered in connection with preparing plans for Fukien Christian University were brought to my attention late yesterday afternoon and noticing that in your letter of October 13th, addressed to Mr. Waunshins, you stated you would be at the Waldorf Astoria for the next week. I telephoned that hotel this morning in the hope of reaching you but was informed that you had left. I am therefore writing this letter to you at that address in the hope that it may be forwarded.

In view of the fact that I am informed you are returning to China shortly and of the further fact that the Board of Managers of Fukien Christian University are conversant with all the details of your claim, it has seemed best to refer this matter to the local Board of Managers to take up with you in China and see if it cannot be amicably adjusted with due consideration of the rights and interests of all concerned. It is not the intention of the Board to repudiate any claim upon the technicality, but on the other hand in view of the difficulties which all the Boards are facing in raising money, will appreciate your generous cooperation in endeavoring to reach a just settlement.

Dear Sir: -

I have received your letter of Sept. 13th stating that the Building Committee in America has repudiated their debt to our firm.

As much as I dislike to put you to inconvenience I am very sorry that I cannot accept your offer for a settlement of our account against the Fukien Christian University. I feel that a settlement of the nature that you suggest would not only be most unjust to yourself and our firm but it would also do considerable harm to Mission work here in China. As one man stated after reading your letter and the correspondence from Foo Chow that if the Mission Boards in America continued to try to avoid paying their debts by taking advantage of a technicality of this nature it would entirely destroy their credit and standing in this country.

The Board of Trustees in America cannot claim that they knew nothing of the work we were doing for your University. This work was started over four years ago and during that time we have received several letters from you written from the office of the Board in America. In some of these letters you mention discussing our plans with members of the committee. I also received a letter from one of the members of the board in which he stated that he was glad that we were making your plans for you. I also discussed the University plans with you and Dr. Goucher in his residence in Baltimore. In the letters received from Foo Chow you frequently mention about sending our plans to the Board in America, and also mention the Boards comments on these plans. You and other members of your local committee have made frequent trips to America since we started your work and in almost every case you have asked us for plans to take back with you to discuss with the Board in America. Taking the above into consideration I think you can readily see that the Board in America cannot claim that they were without knowledge of the work we were doing for your University.

But even if they had no knowledge of this work the Fukien Christian University and not you personally is legally bound for this debt, as with the letters we have written by you we also have many letters asking for plans and signed "Clarance A Neff Sec'y of the Board of Managers representing the Fukein Christian University" also E.L.Ford Sec'y of the Board of Managers of Fukien Christian University". These letters so signed and written on the official letterhead of the University bind the University and if they are wrongly signed by an employee of the Board that is a question to be settled only among yourselves and does not affect this transaction.

As I did not want to take hasty action in this matter I have put off answering your letter until I could consult with several business men in Peking. After careful stucy of all the correspondence we believe that as the Board has so evidently tried to take advantage of what they thought was a technicality in their favor that I should take any action necessary to collect proper payment for our work.

I am enclosing a corrected statement of our account made out in accordance with existing contracts in this office with other Mission Boards. This is our usual fee under circumstances similar to yours. I am prepared to take such steps as is necessary to collect this debt.

I have the kindest regards towards you and the other men in Foo Chow and I only hope that any action that it is necessary for me to take in this matter will not put you to much inconvenience, but I feel strongly that I have been treated very unjustly in this matter by your committee in America. I will wait a reasonable time to hear from you before taking any action.

My dear Mr. Scott; -

I have your letter of December 11th. I certainly will give your Board every opportunity to pay our account in a way that will not harm your work as I feel very friendly towards all your men and especially towards the work you are doing in Foochow. But I also feel very strongly that your board has tried to do me a great injustic in this matter.

During the last four years I have prepared the plans for a large number of buildings for the Mission Fields. For the larger number of these plans I have not asked for dollar in payment for even my expenses. For most of the others I have only asked for my actual expenses not counting my own time.

If your Board had been unable to pay at this time I would gladly have waited for any reasonable length of time but when they try to take advantage of a technicality to keep from paying my account I feel I should take any course necessary to collect what is due me. I will wait until I hear from you before taking any further action, I am

Dear Mr. Carman:

The letter which I wrote Mr. Hussey and which you mailed brought a response sooner than I thought it would for Mr. Hussey called me up the next day, stated he was in town and came down to see me at the office.

We conferred, I should think, for about an hour, and according to his statement he has numberless grievances against the mission boards operating in China. I confess from some of the papers he had in his possession, it seemed as though the fault was not all together on his side. Mr. Hussey apparently is doing a prosperous business in Peking with the Chinese and it strikes me that it was most unfortunate for him to bear bitter feelings against the mission boards, when those bitter feelings have arisen not without some cause. He told me that he had visited the cite at Fukien Christian University twice by special request; that he had paid out \$1140 in salary to a Mr. Herman who is in his employ; that this did not cover the overhead or any other expense connected with the draftsmen of his force. He further said that the second item of \$1140, which on his bill appears to be charged for his profit and expenses, includes his traveling expenses to Fuchow and the remainder is divided between overhead expense and a slight profit to himself.

He said that at one time if the matter had been handled in the right way he would have been willing to accept \$1,000, and I told him that was the amount I had in mind for just settlement from the little I knew of the facts. I said, however, that I thought it hardly just that he should not be paid for the actual money he had paid out in connection with this affair. He finally said he would take whatever I, knowing these facts, would recommend. I told him that I would endeavor to communicate with the other members of the Committee and notify him of the result. Will you therefore let me know what you think is best to be done. I will gladly contribute \$140

to the Fukien Christian University so that the amount it will otherwise have to meet to settle with Mr. Hussey will not be over \$1,000. I told Mr. Hussey that I presumed the main thing in his mind was to have this question settled and that he would not require immediate payment. He told me what he wanted was to have the question settled and he would be willing to wait for the payment.
