JIP:VW Enclosures The Board of Trustees of Fukien Christian University respectfully petition the Board of Regents of the University of the State of New York to grant an amendment to the charter of Fukien Christian University, as set forth under the conditions herewith given.

Fukien Christian University was granted a Provisional Charter by the Board of Regents of the University of the State of New York on June 6, 1918. This charter was made absolute on October 18, 1934. The Provisional Charter set forth the names of twelve persons who made up the membership of the Board. These were incorporated as the Board of Trustees of the University. They were divided into three classes, so that the terms of four members expired in each of three successive years. Re-appointment, or appointment of their successors, was to be made by four Missionary Societies, namely, the American Board of Commissioners for Foreign Missions, the Church Missionary Society for Africa and the East, the Board of Foreign Missions of the Methodist Episcopal Church, and the Board of Foreign Missions of the Reformed Church in America. Each of these Societies was to elect one member each year for a term of three years.

An amendment to the charter was granted on October 18, 1934, which provided for each of the constituent Mission Societies electing an additional member every fourth year for a term of four years. The amendment also provided for the Trustees electing additional Trustees, the total board membership not to exceed twenty-four. These additional Trustees were to be elected for terms of four years, one-fourth of the number being elected each year.

The amendment now proposed is in reference to the manner of election of Trustees by the constituent Missionary Societies. Under the terms of the charter and its amendment, each of the four Societies elects four members, three for three-year terms and one for a four-year term. This difference in length of term causes difficulty in keeping the elections in order. The amendment is designed to correct



the length of term, so that each of the four members elected by a Missionary Society will serve for four years, one of such members being elected each year. The proposed amendment does not change the number of members of the Board of Trustees, nor the number or personnel of the representation of the constituent Missionary Societies, but adjusts the length of term of service.

The proposed amendment is as follows:-

*The Trustees elected to succeed the original Trustees, provided in the Provisional Charter granted by the Board of Regents of the University of the State of New York, on June 6, 1918, to Fukien Christian University in Foochow, China, shall hold office for terms of four years instead of three years. The Trustees elected upon nomination by the Mission Boards shall be divided into classes so that the term of office of one member of such nominees shall expire each year.

For some time I have felt that the holdings of the Fukien Christian University were not entirely suitable. After having made a study of this list, I consulted Mr. Ransom, and we both feel that consideration should be first devoted to the establishment of standards, which, while they may be deemed not immediately attainable, should be regarded as ultimate objectives. It would appear that safety of principal is the primary requirement of this fund, with the securing of a high rate of current income and of principal appreciation desirable, but of secondary importance. Therefore, we believe that a long-term aim should be to increase the percentage of high grade assets to something in the neighborhood of 50%. With this proportion in top grade securities, it would appear that the balance might be distributed between fixed income issues of lesser quality which would provide potentialities for principal enhancement. We suggest that the latter should be maintained at about 20 to 30% of the entire fund.

If it were considered undesirable to hold common stocks as permanent investments, the definite policy of switching from them into fixed income securities at a propitious time in the future might be established now. Under present conditions, however, it appears that not only do equities with a speculative appeal offer the only sound possibility for recouping the losses which have been experienced in the past, but their inclusion in an account of this type may be deemed advisable to provide a hedge against inflation.

We are basing our present recommendations on the realization that, while many of the securities held are unsuitable for permanent retention, wholesale liquidation would constitute too drastic a move in view of the fact that certain of these items appear reasonably safe for temporary retention, and are producing a rate of income that cannot be duplicated in the type of investments which we believe should be eventually substituted for those now held. American Power & Light 6s, Puget Sound Power & Light 5 1/2s and United Light & Railways 5 1/2s are issues which fall in this classification. On the other hand, we believe that better results might be obtained over a period of time by placing the proceeds of this type of issue into investment stocks such as American Chicle, Hazel Atlas Glass, United Shoe Machinery and G. W. Helme.

Second grade preferred stocks appear to be held in an inordinately large amount, and we believe a reduction in this classifications of assets should be made some time in the future. While such items as National Power & Light and Aluminum Company of America do not seem unduly risky for retention at the present time, we suggest that consideration be given to their eventual sale and especially to a reduction in the amount of the latter. Sale of the other preferred stocks would depend to a large extent on the proportion that the total of second grade preferreds and other fixed income assets bore to the entire portfolio at a particular time. It should be noted that Colgate preferred stock is selling five points above the call price.

There is risk entailed in the retention of an issue such as New South Wales under war conditions, but we believe that there will be an earnest effort to continue uninterrupted interest payment on the issues of this obligor. Moreover, it appears that the bonds at their present level constitute some hedge against the possibility of a quick peace. On the other hand, we believe that the opportunity is afforded for getting out of the Norway bonds at a small loss whereas the price of this issue might be seriously affected if the country was actively involved in the war or if its exports were shut off by a blockade. We feel that a stock such as Climax Molybdenum would prove a more satisfactory holding.

We suggest the sale of Hudson and Manhattan Income bonds, the Arkansas and Memphis issue as well as the Southern Pacific and the reinvestment of the proceeds in equities which offer possibilities of principal appreciation. Issues of this type might include Babcock & Wilcox and West Virginia Pulp & Paper.

We both feel that there is real justification for a small percentage of equities in this portfolio.

NEW HAVEN, Conn., Nov. 30—Peter Brinckerhoff Thorne, Yale, '40, of Rye, N. Y., a member of the varsity crew squad, died in the New Haven Hospital at 9 A. M. today, a

faven Hospital at 9 A. M. today, a few hours after a beach wagon he was driving crashed into a tree in Whitney Avenue.

With him at the time were two classmates, John D. Kausel of Beach Bluff, Mass. and Lewis C. Thomson of Cincinnati. Both escaped serious injury but are in the caped serious injury, but are in the hospital for observation suffering from lacerations.

The trio were returning from a dance in Hartford, when the accident occurred. The two injured men were asleep on a rear seat, and the police think that Thorne fell asleep at the wheel. Relatives suggested that a broken axle had caused the accident.

Funeral services for Thorne will be held in Dwight Memorial Chapel Saturday noon, with the Rev. Sid-ney Lovett, university chaplain, of-

Samuel was called by his mates "Brink," the other "Peter." They married sisters and traveled around the world together, being the closest of friends.

The son of "Peter" was named after the Yale nickname of his father, and the middle name of the cousin, who died in 1930. He prepared for Yale at Brooks School

pared for Yale at Brooks School and had been a member of the freshman crew and the varsity squad for two seasons. He was a member of Delta Kappa Epsilon, Skull and Bones, Davenport College and the Whiffenpoofs.

A brother, Samuel, Yale, '28, is curator of the map collection in the Yale library; Dr. Lewis, Yale, '31, is a psychiatrist in the Department of University Health, and James is a sophomore in the university. Two other brothers, Ward, Yale, '31, and Arthur, and a sister, Emeline, also survive. His mother, Mrs. Ethel Cheney Thorne, died two years ago.

Now that we have shaped our plan, there comes at once to the fore a group of points on which we need still more of your greatly appreciated help.

- 1. We need quite soon to secure some informal (not necessarily fully authoritative) indication as to the probable attitude of the Regents toward the points of our plan. It would be very unfortunate if we secured any considerable body of mission board or college board approval and then found that some principal element in the plan was unsatisfactory. Would it be possible for you to find a qualified member or representative of the Regents in whose hands you and I, with some verbal introduction, might place the document for a review and then get his impressions afterward? This probably should be done as soon as the mimeographed copies are available.
- 2. We need to know more precisely the legal steps involved in the case of colleges incorporated outside of New York State for these questions are sure to be asked and the lack of answer may block favorable attitudes toward the rest of the plan.
- 3. We need to have a specific schedule and text of the actions which should be taken by mission and college boards favoring the plan. Is the schedule under XI, "Measures of Future Procedure," in the document satisfactory, and what is needed to implement it?

Is there some way in which I can help to darify these items?

In connection with the possible merger of six Christian Colleges in China, a number of the members of the Board of Directors of the merged institution hould be elected by various constituent missionary bodies in this country, just as is now provided in the charter issued by the University of the State of New York to Fukien Christian University and other universities which might become parties to the merger.

The question was been raised by a representative of one of the Boards whether a provision should not be made in the constitution of the organization which would result from the merger for the election by a trustee electing body of alternates to sit with full power in case the principal elected by the same trustee elected body could not attend the meeting.

The legality of electing alternates, I am informed, a squestioned some years ago by Messes. White and Case of 14 Wall Street in this city, but upon studying into the question I am informed they reported that if the constitution of the proposed organization made provision for the election of alternate members having the right to attend a meeting if the principal

elected by the electing body could not attend, then such alternates may serve in a meeting in the absence of their principals.

Dear Mr. Garside:

Yesterday I had a letter from Dr. Milton E. Loomis, similar to what he wrote you, and I was about to write Dr. North and yourself.

If what Mr. Cressy says in his statement about the United Board in relation to the Boards of Directors in China, on page 13 of the memorandum whe handed Dr. Loomis, is so, namely, that "these regulations do not permit of outside control", it would seem to me that the regents would have a very valid objection to the incorporating of a merger of the Christian Colleges in China, under the Education Law.

On the other hand, if, as long as the local Christian Colleges or Universities in China are dependent for their support on funds sent from this part of the world, there would seem to be ground for maintaining at least a veto power over educational policies in case they did not agree with the standards required by the Board of Regents.

Cannot a plan to this end be worked out that would be satisfactory to all concerned?

Copy to Dr. North December 27, 1941 Mr. Samuel Thorne 20 Exchange Place New York City Dear Mr. Thornes I should long ago have acknowledged your letter of September 22 enclosing Mr. Brind's comment on the Agreement and Constitution. You will shortly receive a memorandum giving a summary of the present situation. I will try here to go over Mr. Brind's points. 1. "The Constitution should not be part of the agreement". I think this is sound. The resulting situation is helped by his Section 10. But this will not be quite enough for there will be many who will feel it insufficient for the new corporation along to form and adopt the Constitution (as it should the By-laws). Therefore could we not have the several Boards approve and authorize the Agreement (Regents) and then separately approve the Constitution as the basis on which they instruct their appointes to proceed? Some technique of united approval of the Constitution is desirable. Do you not think so? 2. "The Constitution Article III, 4, b, infringes on the powers of the Regents" - relating to power to establish new institutions, consolidate, etc. This needs some very careful thought, as does also Mr. Brind's paragraph 1 which limits activities to those "now being carried on". I am more and more clear that the new corporation requires - to fulfill its responsibility for North American and British aid to higher education under Christian auspices in China - more powers than now inhere in the separate corporations or their aggregate. In our draft of Agreement nothing is said about powers, but in the Constitution, Sections III, 2.b, 4.b, and VI 1. I think what we want is a corporation which can a. Receive and disburse funds for any purpose contributing to Christian higher education (e.g. middle schools, and educational association, fellowships, a new college, etc.) b. Receive and disburse funds for the specific institutions involved in the new united board.

c. Direct these institutions and enterprises so far as entitled to by New York State Law and Chinese Law and conditions.

- d. Award degrees under the Charters.
- e. Exercise such authority as the present trustees have and the new corporation can get in respect to re-location, consolidation, etc., of institutions.
 - 1. There are limits, by powers of field boards.
 - 2. There are limits, by powers of Chinese Ministry of Education.
 - 3. There are limits, by powers of Regents (see below)

Would the new corporation have all such powers (a) under its inheritance of existing charters, (b) under the Agreement as drawn by Mr. Brind and the Constitution as drawn by us? If not, what modifications are necessary to secure these powers?

- 3. Re the requirement in Mr. Brind's memorandum that founding of new institutions, consolidations, etc., would require approval by the Regents.
 - a. In respect to new institutions, I assume that Regents approval would not be required if the new United Board, with powers as above, became (under Chinese Law) a Board of Founders, for a new institution, unless the new Board desired power to award American degrees.
 - b. In respect to consolidations, re-location, dissolution, etc., there seems to me that some interpretation is needed as to powers of a board that is a consolidation of several boards. Where does "corporation" leave off and "institution" begin in such situation? Examples:
 - Case X. Corporation A holding an absolute educational charter from the Regents directs two colleges say one in New York and one in Ithaca. Under its approval each college awards degrees. The corporation decides that it will do a better educational job if it unites the colleges (facilities, students, plants) at Sparta and under a united or a new name issues diplomas. Does it have to secure authority from the Regents for this under an absolute charter? What is the institution the corporation, or the faculty-student-plant combination?
 - Case Y. If corporations B, C, and D, holding absolute charters and administering respectively colleges L, M, and N, decide to unite as corporations and securing the Regents approval do so unite as corporation E, must the new corporation E secure further approval if it wishes to consolidate into one educational enterprise colleges L and M? Does the charter inhere in the corporation or in the faculty-student-plant unit?

If the Regents hold, however, that the faculty-student-plant which they have charted cannot be consolidated, etc., without the agreement of the Regents, is this then the situation:

- a. We may secure the agreement of the Regents (which is probable);
- b. If they refuse, and we determine consolidation is right and consolidate, then we surrender the charter under which American degrees may be granted. Is there any other loss incurred the colleges being registered under Chinese Government Ministry of Education?
- 4. Under first "Whereas", the facts in the case of the last three lines should probably be checked for the various boards.
- 5. "Location of the institutions to be named in the agreement, the new corporation to have power to conduct institutions only at the exact locations named;" Mr. Brind's form, paragraph 4.

I am sure we need all the freedom we can get and the powers which I suggest above should be worded so as to allow change of location.

- 6. Date of Annual Meeting. If it is legally necessary to name a fixed date, we can do so, but I should like to avoid it as it will frequently be necessary to meet at some other date.
- 7. As to "time of taking effect", I agree that that should be struck out and left as of the Regents approval.
- 8. I see no difficulties in the rearrangement of the paragraphs he

Dear Mr. Dillistone:

It was a matter of sincere regret to the undersigned that after being advised of the honor of representing you and the Church Missionary ociety at a recent meeting of the Committee on Greater Unity for Christian Colleges in China, that I was unable to attend the meeting on January 16th.

Since that date, however, Dr. Eric M. North and I have had a conference and I note from copy of the letter of January 22th which Mr. Joseph I. Parker has written to you, that you presumably have received the papers entitled "Working Document" fully setting forth the draft of proposed agreement of merger, constitution and declaration of purpose, as well as provisions of New York State Law regarding consolidation of educational corporations. If, in reading over the Working Document any questions come into your mind, I should be happy to try to answer them.

There is one matter that Dr. North and I talked about particularly which relates to Article III, sub-paragraphs 4.(a) and 4.(b). From correspondence with the counsel of the Board of Regents, he has given us his opinion that before the Board of Trustees of the consolidated corporation could carry out the provisions as they stand in the sub-paragraphs referred to, they would have to secure the express approval of the Board of Regents of this State, and of course, for this reason, that provision will be included.

Dear Mr. Thorne:

Your letter of March 12, concerning the incorporation of Yenching University, has been received. The records indicate that the original incorporation was under the name of "Peking University" and was filed on June 25, 1890, with the authorities of New York State. This, apparently, preceded the time when incorporations were made through the Board of Regents, and, I presume, for that reason it was done differently than those which came later and were given provisional charters by the Regents. The amendments to the Yenching Charter, in 1915, 1928 and 1929, were made through the Regents. In securing certified copies of these documents, it was necessary for us to get the original Certificate of Incorporation from State Offices in Albany - other than the Regents - and there is no record of any document with them other than the Certificate of Incorporation, dated as above.

There seems to be one other college which has gotten an absolute charter directly, without previously having had a provisional charter. This is Ginling College which secured their charter from the Board of Regents under the date of January 25, 1935. This was remarked upon at the last meeting of the Committee as being unusual, but the Ginling representatives indicated that this had happened in their case.




