Dear Mrs. Wheeler: As you may guess from two long distance phone calls and a special letter of inquiry, the Washington Smith Club, or at least an influential miority in it, has strongly questioned the advisability of sending money to Ginling this spring because of Communist domination. Despite this opposition, the club as a whole (after considerable study) voted last week to send Ginling \$350.00 as represented by the enclosed check. Our club sends this contribution to you with the following defi definite requests! 1. That you deposite it immediately in the Hong Kong account for Ginling. 2. That if possible you procure for us an official statement and date of its receipt by Ginling. 3. That if our gift of \$350.00 cannot, for various reasons, reach Ginling within a month, you return this sum of money to the Smith College Club of Washington. You may yourself have confidence in a longer span of time, but the feeling of our particular club is that a month's leeway is the most they wish to risk. Please thank Dr. Fenn for his generous information and advice, and my thanks again to you personally for your helpful letters to Mrs. Colean and to myself. Dear Mrs. Wheeler: By now you have undoubtedly received my letter and check for \$350.00 from the Washington Smith Club. I am so pleased that Elizabeth Stenhouse was able to contact you at Northampton last Sunday because I was hoping that she would bring back to us some personal word from Dr. Fenn as further assurance that one gift will reach Ginling soon without Communist interference. Her report was valuable and I would like to share it with the executive committee which meets soon this month. Rather that pass on the information third hand, however, I would prefer presenting the facts as officially from you. So may I receive some of the items as they have come to me in order that you, in turn, may restate them in suitable form? The Seattle Smith 'lub also pressed you for reassurance. The Ginling N.Y. Office thereupon calbegrammed Ginling to dearn if rumors were true or not that the college was closing and Dr. Wu had left. A telegram from Miss Priest (treasurer of Ginling) came in answer to this cabelgram to the effect that "all was continuing as usual and that reports were untrue. Some students have left Ginling but some have also returned. Money is reaching Communist controlled China as evidenced by a receipted check form\$10,000 sent to a North China college recently - a college for several months under Communist control. In your restatement of the above items and any other facts you feel are pertinent, would you, incidently, mention whether the Seattle Glub did or did not preceed to make their gift to Ginling after hearing your reply? I hate to burden you with any further replies, knowing you have been plied with requests from all sides and special pressures due to the crisis. So just know that any answer a propos of the above will be sincerely appreciated. Gratefull yours, Betty Smith (Mrs. G.K.) 0830
