purpose and with instructions to make recommendations of some other procedure if the plan at present under consideration should finally prove to be impracticable.

I presume it would be well to give Mr. Feild and Mr. Gilchrist an opportunity to review the correspondence on the subject prior to their meeting to discuss it.

My dear Gilchrist:

Some time ago you were good enough to advise us regarding the organization of the Board of Trustees of the Central China College. Your advice was with particular reference to the status of proxies. In accordance with your advice we amended the by-laws of the Board and we authorized the necessary steps to incorporate the Board. At this point, however, our proposals were questioned by Mr. A. J. Feild, who is the counsel of the National Council of the Protestant Episcopal Church.

We are anxious to complete the incorporation of the Board as soon as possible and with that in view it is desirable that this point should be finally cleared up or that some legal way may be found to accomplish the purposes we have in view. Our suggestion is that you or your representative meet with Mr. Feild, Dr. Wood, and myself in order that we may discuss the problem and agree upon the necessary steps. We suggest that you meet us at luncheon on January 14, 15, or 16, as may be most convenient to you.

My dear Brown:

For some time we have been struggling with a problem that has arisen in connection with the proposed incorporation of the Board of Founders of Hua Chung College. I do not know whether this has been brought to your attention but in any case you will doubtless find the necessary papers in your files, as we have previously corresponded with Mr. Hawkins on this subject.

The difficulty arises in connection with the present plan by which the two British societies - your own and the Methodist - who cooperate in this institution appoint alternated resident in New York City who are empowered to act at all meetings in the absence of the principal representatives of these two societies on the Board of Founders. We have just had another conference with our legal advisers and it has been made clear to us that it is impossible to have alternated voting in an incorporated board. The Board of Founders is the same as any other board of trustees or the board of directors of a corporation. The responsibilities of the members of such a board are fiduciary in character and it is impossible for its members to transfer their responsibilities to alternates. The members of the board are the only ones qualified to act in all meetings of the corporation locate.

In our previous correspondence you will find reference to an idea that was suggested that alternates might be accepted on condition that they were elected by the same body that appointed the principal representatives. On further inquiry we find that this idea arose from a misunderstanding of a previous memorandum by our legal advisors. Such alternates can ext only in meetings of the members of the corporation in electing representatives on the board of directors or founders and in transacting such other business as the members of a corporation would choose to do. In this case the members of the corporation are the cooperating societies themselves and those persons who speak for them. I shall enclose a diagram which will make this distinction plain, I hope. In any case it is clear to us that on the Board of Founders no alternates can serve.


In order that we may speedily accomplish the incorporation of the Board of Founders of Mua Chung College, we suggest that the two British boards agree to one of two plans. (1) The simplest method would be for each of these boards to elect representatives who are resident in New York. We believe this would be the

simplest plan. Of course, if you or someone representing the Mothodist Society were in New York at the time of the meeting of the Board you would be recognized as the real spokesman for your Society and in voting in the meeting the official representative would simply express your decisions. In effect there would be no real difference between this plan and that which is now followed. For in practice the alternates are exercising all of the active responsibilities of representing the two British societies. The alternative plan would be to set up a new body which would have the character of a Foundation and which would exercise the functions under Article III of the Constitution, which deals with the holding of property. All other functions in the control of the University would be exercised by the Board of Founders. This plan is also illustrated in a diagram that I shall enclose.

In connection with Dr. Wei's campaign, we are expecting to receive funds and it is essectingly important that there should be an incorporated body to receive these funds. For this reason we hope that we can arrange for the incorporation of the board within the next few weeks. A regular meeting of the Board of Founders is to be held on February 14 and it would be exceedingly helpful if at that time we could have some reply from you and the Methodist Scoiety. At the last meeting of the Board this whole subject was again referred to Dr. Wood and myself, and I am writing on behalf of this special committee.

I shall send a copy of this letter to the Methodist Missionary Society and I hope that you will find it possible to confer on the subject soon so that we may be advised regarding the desires both of your societies with reference to this matter.

My dear Gilchrist:

We had a most useful conference a few days ago with reference to the incorporation of Hua Chung College at which you were represented by Mr. Bissell.

In the course of this conference it was suggested that a diagram would be useful in understanding the organization of the controlling bodies of this institution. I enclose such a diagram, which has been attached to a letter that I have sent to the cooperating bodies in London. I have suggested to them that they should accept our recommendation to appoint residents in New York as their representatives on the Board of Founders so that no alternates would be necessary. My dear Dr. Warnshuis:

I am glad that Mr. Bissell's presence at your recent conference proved helpful to you in planning your organization.

I have shown him your letter of January 22nd and he has gone over the chart with me and explained the situation so that I now have, I must confess, a much clearer picture of it than I did when I wrote you on March 16, 1934. It seems to me that you have arrived at a workable solution.

Mr. Bissell commented on the clarity of the chart—especially as to the annotations in the boxes at the right. He has made two minor comments, however, which may be of interest to you: In the first place he points out that in a membership corporation there is strictly no such thing as "shareholders". The exact term is "members". He says, however, that he used the word "shareholder" at the conference for the purpose of showing that members of a membership corporation occupy a position analogous to shareholders in a stock corporation. For this reason he thinks that the use of the word "shareholders" may well remain on the chart provided that you bear in mind that it actually means "members". In the second place, in connection with the use of the word "alternates" he says that as a matter of procedure you will probably have to work this out by means of proxies. This is, of course, a mere matter of detail.

Dear Dr. Warnshuis,

Mr. Noble handed me a copy of your letter to Mr. Brown, concerning the proposed incorporation of the Board of Founders of Huachang College.

Our Committee considered the matter very carefully, but cannot see their way to adopt either of the alternatives which you suggest, and prefer rather that the status quo should be continued. Even if the alternates Dr. Cartwright and Dr. Vaughan are not able to vote, they might be allowed to attend the Meetings of the Board of Founders and perhaps have the right to speak.

In reply to your letter of Jan.17th, we are delighted that Dr. Francis Wei is meeting with so much success during his visit to America, and that he has already secured the promise of 30,000 dollars (U.S.) and hopes to raise another 30,000. We hope that this also indicates a general economic recovery in your country. All the Missionary Societies will rejoice if this is so.

I am very sorry that we here are faced by a probable deficit in this year's accounts, and we have been obliged to give notice of a 10% reduction in our grants to all fields, so that on this ground we are bound to refrain from fresh commitments, and with great regret must decline to make the increased grant of 500 dollars for our contribution to the Huachung College.

Even had we been able, financially, to do this, we should have had to refer the matter to the Synod in Hupeh, as one of our rules is that all requests for grants in any Districts must first of all be voted on by the Synod.

Like you, we believe that the Huachung College is doing a great work and meeting an important need in Central China. We hope that it may soon be granted full University status. For these reasons our regret is all the deeper that we are unable to consent to anytincrease of our own grant.

CERTIFICATE OF INCORPORATION of CENTRAL CHINA COLLEGE FOUNDATION

Pursuant to the Membership Corporations Laws Of the State of New York

We, the undersigned, desiring to form a corporation pursuant to Article Two of the Membership Corporations Law of the State of New York, United States of America, do hereby certify as follows:

I.

The name of the proposed corporation is Central China College Foundation.

II.

The purpose for which the corporation is to be formed is.

To foster and promote the interests of HUA CHUNG (CENTRAL CHINA) COLLEGE, located at Wuchang, China, and to maintain the Christian character of said institution; and to that end,

maintenance and development of said institution.

aforesaid. No director, officer or member of the corporation shall receive or be entitled to receive any part of its income or assets, or any pecuniary profit from its operation, except reasonable compensation for services rendered in effectuating the aforesaid purpose; and upon a dissolution of the corporation no member thereof, as such, shall have any right, title or interest in or to its property or any part thereof.

III.

The territory in which the operations of the corporation are principally to be conducted is the United States of America and the Republic of China, but its activities and operation shall not be restricted to these countries.

IV.

The office of the corporation is to be located in the City, County and State of New York.

V.

The directors of the corporation shall not be less than nine (9) nor more than twenty-one (21) in number.

Dear Mr. Brown: I thank you for your letter of the 26th February referring to the question of the incorporation of Hua Chung College. At a meeting of the Executive Committee of the Board of Founders last Friday I presented your letter and also one from Mr. Grist. After further consideration of the whole question and further discussion of the problem with our legal counsel, the Executive Committee made a definite decision authorizing with its full approval the organization of a Central China College Foundation, the membership of which will be the same persons who are members of the Board of Founders but limited to those who are resident in the United States. The purposes and functions of the corporation will be limited to the holding of property and money in the interests of Hua Chung College. This holding corporation will not have any power in the direction or management of the College. It is organized in accordance with Article III of the Constitution of the Board of Founders, which provides that the Board would hold property either in its own name if incorporated or in the name of one or more of its members. In view of all of the facts, the simplest procedure seemed to be to incorporate such a Foundation to be the holding body for the College. Steps to complete this incorporation are being taken immediately in order that we may receive gifts that may soon be obtainable. With reference to our previous correspondence, you will see that this action means that nothing more needs to be done with reference to the representation of the L.M.S. in the Board of Bounders. We can go forward as we have been doing. However, if you desire that I should be a member also of this incorporated body, it will be necessary to make me a direct representative of the L.M.S. in the Board of Founders, only the full members of which who are resident in the United States can be members of the Foundation. As proxies under our existing by-laws, we can act for you in the Board of Founders but we could not act for you in the incorporated body. This is not of any real importance and if I am not a member of the Foundation it would give me a good reason to be relieved of the office of treasurer, which, however, does not carry any heavy responsibility. My dear Mr. Grist:

of the Board of Founders of Hua Chung College was duly received and I presented it at the recent meeting of the Board. At that time action was taken to confirm the authority already given to a committee to complete the incorporation of a body representing the College. Such incorporation is necessary in order that the College may be legally competent to receive funds and to hold property.

After further consideration of the whole question and after further discussion of the problem with our legal counsel, we reported to the Executive Committee of the Board last Friday and at that time definite decision was reached to approve the organization of a "Central China College Foundation." It seemed wise to set up this holding body in order to avoid the necessity of any changes in the existing organization of the Board and also to avoid complications in administration due to the laws of the State of New York with reference to educational institutions. The incorporation of the Board of Founders as now organized would have made it necessary to comply with the regulations of the Board of Regents of the University of the State of New York. We do not desire that status, for as an educational institution Hua Chung College is registered in China as a Chinese university. Here we desire only a corporation that will be a property holding body. This is the main reason for the incorporation of this foundation, the purposes and functions of which will be limited so that it will not have any share in the direction or management of the College. It is organized in accordance with Article III of the Constitution of the Board of Founders, which provides that that Board would: hold property either in its own name, if incorporated, or in the name of one or more of its members. The membership of the board of directors of the proposed foundation will consist of the same persons who are members of the Board of Founders but necessarily limited to those who are resident in the United States. In the board of direction of this incorporated body, no proxies can be legally accepted. Steps to complete this incorporation will be taken immediately in order that we may receive gifts that may soon be obtainable. As soon as possible I shall send you a copy of the certificate of incorporation.

With reference to our previous correspondence, you will see that this action means that nothing more needs to be done with reference to the representation of the Methodist Missionary Society in the Board of Founders. We can go forward on our present basis. However, the representatives of your Society would not be members of the board of direction of the foundation unless you should decide to appoint one or more residents in New York as your principal representatives. It does not seem to me that this is of any real importance, for the business of the caparation will probably be conducted at the time of the meeting of the Board of Founders and those who represent you as proxies will be present and participate in all the discussions even though they may not have a legal vote.
