with Mr. Cawthorne regarding the payment by the Baptist Board to cover the salary and expenses of the Dean of the Language School at the University of Nanking in the place of Mr. Keen, perhaps it would be well if I wrote to you stating the point of view of the University for your information:

Mr. Cawthorne informs me that the recommendation from the East China Mission was that this matter be covered by an appropriation of Mexican \$4,000. I pointed out to Mr. Cawthorne that while this would meet the actual salary of whoever is secured for the position, it would not provide for the increased expenses of furlough years and such other extra items as are included in considering the cost of a missionary on the field. The University finds that the average cost of the members on the staff is very close to Gold \$3,000 a year. This provides a prorata amount toward the increased expenses of furlough years. The hope of the university would be that if the Baptist Board agrees to the arrangement which the university has suggested in the matter of supplying the support of the Dean of the Language School, either that the Board should appropriate a fixed amount of at least gold \$2,500 per year; or that they would agree to pay the actual salary and expenses of whoever might be secured for this position. I think perhaps the former plan would be the more satisfactory from all points of view. I am writing this to you merely for your information, and not with any desire to complicate the situation at all; I am sure you will know what is the wisest plan to pursue.

The feeling of our Board was that we should not make the appropriation of \$2500 Gold outright, when we are supplying a house as well, unless it is definitely to be established as the standard of the Trustees of Nanking that the same scale of salary shall be applied when any of the other Boards supplies a worker under similar conditions. I shall be glad to hear from you if you can give us this assurance, and will then bring the matter to our Board for further action.

rangements as have been made in the past for paying the salary of a man instead of providing the individual, have been purely on a yearly basis, and have simply been for the purpose of oroviding the university with enough money to pick up someone in China to fill in the gap until the board should supply someone in the place. This is an arrangement of a rather different sort, wherein it would be expected that the board would meet all the expenses incurred in supporting a man in the position. It would be I think on a basis similar that under which the grants of the China Medical Board are usually made. This, in all the institutions with which I am acquainted, has been gold \$2,500 a year. In the institutions where the mission boards have made appropriations to meet those of the China Medical Board in personnel they have always been incurred on this basis.

It is further understood that in case the Mission lords are unable to make such advance payments, whon the fees re actually received in October, if the sum in hand is sufficient to complete the construction of the dormitory, erection of the building is authorized at that time.

I have inquiry from the officers of the University of Nanking in China as to the arrangements upon which the American Baptist Foreign Mission Society will supply the amount for the vacancy due to the regretted death of Mr. Keen.

They advise me that the China Treasurer of your Society has received no authority to make a payment, and so far as I can tell from the data I find here, the matter has not been carried in status beyond Mr. Cawthorne's letter of January 11, 1924 to Mr. Moss. It is understood from that letter that the Society was not prepared to furnish the salary at the rate of \$2,500 Gold a year.

y judgment would be that under these circumstances the thing to do would be for the University to accept the action taken by your East China Mission which I understand has the approval of the officers of the University on the field, and accept the settlement of the matter on that basis, of Mexican \$4,000 for the year.

In that case, will you be so kind as to authorize your China Treasurer, as soon as possible, of your approval of this plan, in order that he may make the payment in Mexican, to Mr. L. J. Owen, Treasurer of the University on the field? Will you not, at the same time, notify me when you take this action, in order that I may keep our records clear?

In this connection, may I call your attention to an action of the Board of Monagers of the University of Manking, March 16, 2925, as follows:

"M-221 VOTED that with the approval of the Baptist Board, the funds now provided by them for the support of the Dean of the Language School be utilized as soon as possible for another teacher in the College of agriculture & Forestry."







At the meeting on June 10, 1925 the Trustees of the University of Nanking upon the recommendation of President Bowen took the following action:

"T-239 VOTED that Article IV., Section 1, of the Constitution be smended by inserting after paragraph (1) the following paragraph - "

Alumni of the University, (the term of said members first elected to expire one, two, three and four years respectively after their election, thereafter) their terms shall be for four years."

and by striking out the former paragraph (2) and inserting the following -

"(3) The Board of Managers may elect five additional members each to serve a term of four years (and to be eligible for re-election)".

and that the form of the parenthetical matter in the final form of the amendment shall be at the discretion of President Bowen."

Amendment of this section of the Constitution requires the concurrence of the cooperating Mission Boards. We should, therefore, be glad to have as soon as practicable the concurrent action of your Board. The purpose of the amendment is to make room for the election of a larger proportion of Chinese upon the Board of Managers of the Institution.

The present form of Article IV., Section, I, you will find in the enclosed copy of the Charter Constitution and By-Laws. Additional copies of this are available at your request.





we are approaching the end of the fiscal year of the University of Nanking on June 30th, and I find we have not received from your Board any payments on account of its appropriations to the College of Agriculture and Forestry and to the hospital. The amount which we understand you will provide for the College of Agriculture and Forestry is Mex.\$3,000. and for the hospital, Mex.\$600. We also understand that the Woman's Foreign Mission Society is to provide Mex.\$400. for the hospital, making the total amount from your Board for the hospital, Mex.\$1000.

Inasmuch as the Nanking rate of exchange for June is not yet known to us, it would be appreciated if you would pay us U.S.\$1500. for the College of Agriculture and Forestry, and U.S.\$300. for the hospital for the general Board, and if the Women's Mission Society would furnish us with U.S.\$200. for the hospital. We are very anxious to get this into our accounts as soon as possible.

I also wish to inquire as to what to do concerning the appropriation by the Woman's Board about which I have been much perplexed. According to our files, Miss McVeigh wrote to Mr. Moss in September, 1924 that \$200. gold had been appropriated for the period ending June 30, 1924, but so far as I can find out, this payment has never been received. I wrote to the Board about it in December 1925, and to Miss McVeigh again in April, 1926. I am wondering if anything has slipped up in the understanding between the general Board and the Society that, of the Nanking hospital's Mex.\$1000. from Baptist sources, the Woman's Board was to furnish Mex.\$400. I shall be glad to have any word from you as to how to proceed in this matter. The Woman's Board paid us \$200.gold June 1,1925, which we have assumed was the appropriation for 1924-5, believing that this matter of support for the hospital was recognized both by the Board and by the Society as being a continuing agreement.

My dear Mr. Cawthorne:

I am trying to regularize the times of payments of the appropriations of the Boards to the Universities and find that there is no rule with reference to your Society's payments to the University of Nanking, except that they are paid when we ask for them at the end of the year.

I am wondering whether it might not be possible for you to regularize these payments and to let us have them quarterly, in the first or in the second month of each quarter. This would apply to the annual appropriation of \$1,500. to the College of Agriculture and Forestry and of \$300. to the Hospital. We would be satisfied with half-yearly payments, if these could be made in the third month of each half of our fiscal year which runs from July first to June thirtieth, that is, in September and in March. This might fit the appropriations more satisfactorily into your fiscal year.

I refer you to your letter of July 19th, 1926 in which you raise the question of regularizing the times of payment of the appropriation of our Board for the University of Nanking.

I have Been in correspondence with our East China Mission with regard to these appropriations and have been delayed in answering on that account. Our Mission has now recommended and our Board has voted to make its appropriations for the University of Nanking Hospital at the rate of \$75. gold per year beginning with the year which extends from July 1, 1926 through June 30, 1927. The Mission has also recommended to the Womans American Baptist Foreign Mission Society that they make an appropriation of second per year, but that is a matter that will need to be handled by the Board of the Womans Society. I understand that representatives of Nanking University on the field have in conference with representatives of our East China Mission accepted the reduced amount for the University Hospital.

Now as to the time of payments, it would be much more convenient for our Board to make its annual payments on Nov.

15th and on May 15th of each year, paying \$750. for the

University and \$37.50 for the Hospital at each of these times.


I, therefore, enclose our check for \$787.50. This covers our one-half of the year from July 1, 1926 through July 30, 1927.

Dear Mr. Cawthorne:

As you know, the University of Nanking has been hard hit by the events in China. We find that we are going to need nearly \$200,000. to be able to help the staff set up their homes and pay their salaries and the emergency travel expenses involved in the departure from Nanking and in the few months immediately following.

The University of Nanking happens never to have put on an intensive, broadcast campaign, with the result that there are only a few score names of contributors which are on the Nanking lists, and the raising of an amount like this in the short time that remains before the summer, we feel can only be done by a prompt approach to a considerable number of persons. As the American Baptist Society is one of the cooperating boards in the University we are venturing to ask whether it would be possible for you to make available to the University a list of names and addresses of those who would be looked upon as good prospects for gifts of \$50: to \$100. or more for an appeal of this kind. A draft of the text of the appeal is enclosed. We, of course, would like to have as many names as you would feel you could release to us. We would hope that it would be possible for you to release two or three hundred names or more. If there are any other ways in which you think it would be practicable to go about securing this fund we would be grateful to you for suggestion upon this matter. We must move promptly because the need for the actual cash is upon us and because there is so short a time before the summer.

Do you see any objection to our including Dr.Franklin's name as a member of the Campaign Committee to be listed on the letterhead on which this appeal is to be distributed?

Under the statement of losses and emergency needs on page 2, item 3, "Losses to Staff supported by the University, and other emergency expenses\*, the first group of losses listed is \*personal property and effects lost by hold-up of individuals and looting of houses, \$100,000". Below you state that the University itself must guard the interest of twelve foreign families and twelve single persons in addition to the Chinese staff, in other words, that the University will be asking for \$100,000 for the personal losses of twelve families and twelve single persons, which would mean something over \$4000 for each unit counting the single individuals as well as the families as units. I should be pleased if you could give us any more specific information as to how this figure of \$100,000 is fixed. Have you settled upon a definite amount that you will ask for each family and for each individual, and does it cover the entire losses of the individuals as estimated, or upon what basis is it fixed? Franklin reported concerning a meeting of the Board of Trustees of the University of Nanking on September 14, 1927 and it was VOTED: To approve the resolution of the Board of Trustees of the University of Nanking as follows: \*The Board of Trustees gave earnest consideration to the actions of the Board of Managers at their meetings on June 16, 2, and July 12, 13, 1927, and welcomed the proposals of the Board of Managers for its reorganization, the change of its name to Board of Directors and its assumption of full control of and responsibility for the financial support and administration of the University and it was voted 1. To approve and grant the requests of the Board of Managers '(1) That the name of the Board of Managers be changed to Board of Directors. '(2) That the Board of Directors have authority to elect a Chinese President. '(3) That the Board of Trustees lease the University property for a period of five years to the Board of Directors.

(4) That the Board of Trustees transfer all matters of internal control to the Board of Directors.' 2. In accordance with this action to leave the question of the election of a President to succeed Dr. Bowen whose resignation has been accepted to take effect on the election of his successor, to the Board of Directors and to leave to it also, under the full authority now given to it, the question of registration and all problems of internal administration and financial responsibility. 3. To make record that, in taking these two actions, the Trustees are acting on the basis of the provision in the proposed constitution of the Board of Managers declaring the purpose of the Board of Managers to maintain the Christian character of the institution with full religious liberty. 4. To approve in general, the relations between the Board of Managers and the Board of Trustees (or Founders) as proposed in the documents prepared by the Board of Managers. Recognizing, however, as stated by the Managers that these documents are not yet in final and matured form, the Trustees will be ready to consider any modifications which the more deliberate study contemplated by the Board of Managers may suggest.

5. To ask, meanwhile, all the Trustees not present at this meeting to approve the actions now taken and to submit these actions to the cooperating Boards for their approval, so that the Board of Managers may proceed at once as the recognized authoritative body for the administration of the Institution.

6. To waive and to hold in abeyance the present constitution and by-laws of the Board of Trustees in all particulars where they are inconsistent with the action now taken transferring the full financial responsibility

and administrative control to the Board of Managers in China.

7. To recommend to the Boards the continuance of their present cash grants to the University in accordance with the request that these

be continued if possible unreduced.

8. To recognize this arrangement as covering, as suggested by the Board of Managers, the period of five years, the question then to be considered of a renewal of the lease and in the light of the experience of the University and the Board of Managers to determine what further changes may be necessary or desirable in the interest of the largest fulfillment of the purpose for which the University was established, namely, the fullest possible measure of Christian service to China and to the Cause of Christ in China."

My dear Mr. Bolcher: Thank you for your letter of October 14th with its information as to the names of the three friends who have contributed \$250. each toward the support of Rev. Timothy T. Lew of Peking University. In this same letter you inquire as to the form of lease which it is proposed to use by the Board of Trustees of the University of Manking in leasing the University property to the Board of Managers as a part of the contemplated reorganization of the University. The exact details of this arrangement have not as yet been perfected. The general plan of the proposal is to lease the University property for five years at an annual rental of Mex. \$240,000. This includes all mission residences as well as the general University buildings. We attach a copy of the section of the proposed agreement referring to the property lease. Unfortunately our office does not have any further copies of this entire plan so it is not possible for us to send you a complete set of documents. Very cordially yours, A GARSIDE BAG-H Enc.

## Proposed Agreement with Board of Founders (Trustees)

#### Section 3

### Property Lease

That the grounds, buildings and equipment be leased to the Board of Directors by the Board of Founders for a period of five years beginning July 1, 1928, at an annual rental of one hundred and twenty thousand dellars Chinese currency. This lease may be renewed by mutual consent as from July 1, 1933, for a period and on terms which shall be determined on or before that date by mutual agreement between the Board of Directors and the Board of Founders, said lease to be subject always to the following conditions:

- 1. If for any reason the present Board of Directors should cease function as the responsible administrators of the University of Manking in accordance with the foregoing constitution of the Board of Directors which is made a part of this agreement, the Board of Founders shall have the right of immediate entry to repossess the property.
- 2. Should the property so leased or any substantial part of it cease to be used for the proper purpose of the University of Nanking to maintain in Manking a private institution of learning under Christian auspices, which shall conform to the highest standards of educational efficiency, promote social welfare and high ideals of citizenship, and, develop Christian character in accordance with the original purpose of the founders, the lease shall be subject to cancellation at the end of any scholastic year by either the Board of Directors or the Board of Founders but only on one year's notice.
- 3. The Board of Founders may increase its investment at the University of Nanking in land, buildings or equipment on the written request or with the written consent of the Board of Directors.
- 4. The Board of Directors shall maintain the property so leased in as good condition for operation and use as the seat of the University of Manking as at the date of the lease. For this purpose they shall set aside out of the general income of the institution each year not less than 2% of the cost of buildings and 5% of the cost of equipment, amounting to about \$12,000. Chinese currency, to be used for repairs, replacements and insurance. (Note: The exact percentages and amount of money will be worked out later on the basis of present conditions and included in the final lease.)
- 5. The Board of Directors may improve the property by the erection of additional buildings or other physical facilities or planting, with the written consent of the Board of Founders, subject to the conditions that the same shall be in conformity with general plan and type of architecture already adopted, and that the cost of such improvements shall be defrayed by the Board of Directors except as provided for in advance by special appropriations from the Board of Founders on the request of the Board of Directors. It is mutually agreed that the final judgment as to the location and external form and appearance of proposed additions to be physical plant of the University shall rest with the Board of Founders.
- 6. All residences shall be rented by the Board of Directors to the members of the staff according to the attached rent schedule and on the understanding that previous occupants shall have first claim and also that rank and length of service shall be the basis of determining priority of choice should a conflict of choices

arise between members of the staff.

In the event of a cancellation of the lease or of other disposition of the property, a settlement of conflicting interests shall be secured through conference between the Board of Directors and the Board of Founders, and if need be by arbitration.

In response to your letter of November 26th inquiring as to the objects for which the present disbursements of approximately \$22,000.00 on the University of Nanking Emergency account have been made, we append below the following summary:

Draft drawn by Field Treasurer for Emergency Travel, etc. G \$8000.00 Salaries and travel paid in New York \$14,996.08 Less salaries charged to the field budget at field rates 10,403,66 4.592.42 Special emergency re-outfit allowance 8,721.12 Emergency cables and telegrams 201.44 campaign office expenses - printing of appeals, subscription blanks, 680.99 stationery, postage, rent, etc. \$22,195.97

The \$12,000.00 estimated emergency expenses yet to be paid will include a relatively small number of salary items still to be paid in America and a reimbursement to our Field Treasurer for expenses there for travel, emergency re-outfit and other special expenses, over and above the \$8,000.00 already sent, amounting probably to something more than G \$10,000.

You are correct in your understanding that only those members of the University of Nanking staff directly supported by the University and not by the cooperating mission boards have received any assistance from our University emergency fund. I know that most of the ecoperating mission boards have given special assistance to all of their missionary appointees on the Nanking staff and I presume that all the cooperating boards have taken such steps.

We trust that this supplies all the information you need to effectively present this urgent request for assistance to your Board and your general constituency.

The number of missionaries and approximate amount allowed each. This information will be of use to us in dealing with our own missionaries. Second: The amount, if any, applied or to be applied to the restoration of losses by Chinese members of the faculty, losses in the equipment of the institution, etc. We have also received from you under date of Lovember 29 a mimeographed statement of "Some Factors in the Coordination of Christian Higher Education in China". My dear Mr. Howard:

In response to your letter of December 5th, I give below additional information regarding our University of Nanking emergency accounts.

First, the basis on which the emergency re-outfit allowance is granted is \$250.00 for single members of staff and from \$500.00 to \$750.00 for families, depending on the number and ages of the children. Twenty-four single members and married couples of the University supported staff have received this special emergency re-outfit allowance.

Second, nothing has yet been applied, as far as our New York office has any knowledge, to the restoration of the losses by Chinese members of the faculty, losses in the equipment of the institution, etc.

We now have on hand about four hundred copies of the folder "Our Only Plans are to Carry On" but will be glad to furnish your office with an additional supply if needed.

We are enclosing two copies of the mimeographed statement "Some Factors in the Coordination of Christian Higher Education in China"
