
Dear Dr. Anderson,

I have to-day received a letter from Dr. Sparling, from Chengtu, dated March 22nd. He writes about the Union Theological College, and encloses the minutes of the Board of Management of March 1st. These, and also his letter, speak of the "Board of Governors" of the College, but do not state whether that Board of Governors is a special Board for the Theological College, or is the W.C.U.U. Board of Governors. I am inclined to think it is the latter, but I cannot find that we have ever definitely heard that the Board of Governors of the W.C.U.U. have accepted responsibility for the government of the Theological College. If the Board of Governors of the W.C.U.U. have accepted responsibility, then, of course, C.M.S., as members of that Board, have a share in the responsibility; but if the Board of Governors of W.C.U.U. have not accepted such responsibility, then I cannot see how the C.M.S. in England has any responsibility for the government of the College. In that case it would seem to me that it is only the Church (Sheng Kung Hui) of which our Mission in Western China is a part, that has any responsibility for the College. I want to get this quite clear, because Dr. Sparling evidently thinks that C.M.S. at home should make contributions towards the upkeep of the College, and/or the new buildings which they are proposing to I do not myself feel that the C.M.S. in England have any such responsibility, though we have already written to say that the venture has our sympathy and moral support.


West China Union Theological College. - Your letter of May 28th arrived in time for our Committee to have it under discussion at their meeting on the 7th, and as our Committee will not be meeting again before the Board of Governors of the W.C.U.U. in July, it seems advisable for me to write to you and try and clear up the situation.

As far as I can understand, it is the Board of Governors of the W.C.U.U. that have been asked, and are likely to accept, the position of acting as the Board of Governors of the W.C. U.T.C. If it is so fixed, the Church Missionary Society will, of course, fall in with that arrangement; as members of the Board of Governors they will take their share in the work as they have done before.

There are, however, statements in Dr. Sparling's communications, especially the statement that the W.C.U.T.C. is "the College of five Churches on the field and eight Boards in the home land", which make us wonder whether we have made our relations to the W.C. U.T.C. clear.

First of all, the Church Missionary Society has not expressed its willingness to act as one of the eight Boards who are responsible for the management and upkeep of the Theological School. It is well to point out that, even where the West China Union University is concerned, the C.M.S. has always been considered as a third of one unit, the remaining two-thirds being taken by the Friends' Foreign Service Council. This fact is not mentioned in the correspondence, though the fact that the three Women's Boards are regarded as a single unit is so stated.

At present the Church Missionary Society has not done more than express its interest in the establishment of the Theological College, and its willingness that one of our missionaries on the field should assist in its work. But we have, so far, regarded the Church on the field with which we are in affiliation

(that is to say, the Western Szechwan Diocese of the Sheng Kung Hui) as the co-operating body. It is they who have, so far, made the grants for the upkeep of the Theological College, though we realise that they have only been able to do this out of the funds put at their disposal by our Society. As at present arranged, therefore, we cannot but regard the budget of the College as the responsibility of the Western Szechwan Diocese of the Sheng Kung Hui, and we are not prepared to be assessed by the Board of Governors sitting in New York to find any share of the I would not go \$6000 budget which is proposed from Chengtu. so far as to say that we have definitely decided to put no addition -al funds at the disposal of the Sheng Kung Hui, but certainly we shall make no allocation of funds until the Sheng Kung Hui has approached us in this matter, which they can only do through our local Western China Mission.


I have been asked to make this position clear in view of the fact that the Board of Governors are meeting in July, and, apparently, are likely to assume that the Church Missionary Society is only waiting to hear what amount of money they will be expected to give in order to pass a resolution agreeing to make the grant for this amount.

with regard to the cost of new buildings which it is suggested should be put up, the remarks that I have made above apply with increased force. I do not think it is at all likely, in view of our present financial position, that the Church Missionary Society will make any grants for new buildings for a Union Theological College. At any rate it must not be assumed that they have any responsibility for taking such action. It is just possible that if representations were made to us by the Sheng Kung Hui in Western Szechwan, through our local Mission, that some grant would be made; but I have no authority whatever at the present time for encouraging you to believe the Society would be able to find such a grant.

I hope you will not think this letter is unsympathetic, but I have no other course than to try and make clear to you what is the position of the Society.

Dear Dr. Anderson,

I received your letter of March 27. I am so glad that you are able to go on with your excellent work on behalf of the C.M.S. on the Board of the W.C.U.U.

You are good enough to ask me if there are any points that I want you to think especially about in view of the meeting of the Board on June 5. I cannot think of anything special except with reference to the U.T.C, about which I write in a letter enclosed with this. All that I have said there is perfectly honest and true to fact, and I feel sure that in any circumstances I should be writing in this same But I think I ought to let you know that it is a strain. fact that not all our missionaries in W. China are satisfied with the theological position of the U.T.C., and I therefore hardly think it likely that we shall get a request from them additional grants. I expect you realise that most of our workers there are decidedly conservative in their views, and they want to be well assured of what the U.T.C. is going to teach before they support it at all vigourously. You will not, of course, pass this information on to the Board of Governors. I only send it to you in order that you may understand what lies behind the situation.



Dear Dr. Anderson,

I have received your letter of April 3. calling the meeting of the W.C.U.U. Board of Governors for June 5. I am sorry that I shall be unable to attend, and would ask you to tender my apologies to the Chairman.

I have also received your letter of April 2. enclosing a copy of a letter from Dr. Sparling, with Minutes of the Board of Management of the W. China Union Theological College. Dr. Sparling has himself already written to us about this, and I have replied pointing out to him that the Home Board of our Society has not accepted the position of a participant in the U.T.C. Till now our Mission in Szechwan has taken an active part and paid their share of the budget, and we leave it entirely to their discretion as to what payments are made. Of course it is unlikely that they would be able to find money for capital expenditure from their own resources, but our Home Board will take no action in this matter without first receiving the advice of the local Mission. I am afraid, therefore, that you are unlikely to get any further advice from C.M.S. before your meeting on June 5.

Perhaps I ought to add that even if we should receive from our Western China Mission a request for a grant for capital expenditure for this College we should have the utmost difficulty in getting our Committee to approve. Our financial position at the present time is so precarious, and the state of affairs in China, and also in Europe, that I am afraid it is very unlikely that our Society will make grants towards buildings in Chengtu however well established the need for such a grant may be.

My dear Mr. Barclay,

Many thanks for your letters of April 14.

I am glad to know that you have written direct to the field regarding the U.T.C., and the exact position of the C.M.S. in relation thereto. I have always strongly urged on Dr. Sparling that the most hopeful method of securing support for the College is by representations made by the various missions on the field to the Home Boards, rather than by the rather roundabout method of working through the Board of Governors. Themlatter can, of course, add its weight to any appeals by forwarding them to the Home Boards; but it is the judgment of the representatives on the field that will carry most weight. Still I felt quite justified in sending all the information from the field to the various cooperating units, in advance of the meeting of the Board of Governors, so that when the Board meets, we may have just such reactions as you have furnished from the C.M.S.Point of view to guide us.

I am very grateful for the confidential letter. This ismjust the sort of information which I, as representing the C.M.S. on the Board of Governors need. I shall, of course, keep it to myself; but I am dispessed to think that any question could be raised as to the character of the teaching in the College. I can assure you that I have no sympathy with it.



Dear Dr. Anderson,

West China Union Theological College. - We have at last heard from our Western China Mission telling us that they are satisfied with the theological position adopted by the College, and recommending us to make the grant asked for for the new building. These letters arrived just in time for the last meeting of our Far East Committee before the summer recess, but you will be sorry to hear that they felt that they cannot make any recommendations for grants for buildings in China in the present circumstances. It is not merely the difficulty of our financial position that led to this conclusion, but much more the fact that, as we see things in England, it is unsound policy to be putting up new buildings in China to-day when there is such a likelihood of their being destroyed by Japanese bombers. No doubt the Theological College has got to find somewhere to house its students, but even so the decision of our Committee is final, and I am afraid the Board of Governors must conclude that the C.M.S. does not feel able to take its share in the cost of those new buildings.

I have written to the Secretary of our Western China Mission along these lines.





Dear Dr. Barelay:

I am glad to be able to report to you that a very fruitful A namual Meeting of the Board of Governors was held in New York on Wednesday, May 15th. We had the great advantage of having with us the Chancellor of the University, Dr. Joseph Beech, who had just returned from China and was in a position to give us the latest details concerning the progress of the University.

The minutes of the proceedings are enclosed herewith, and it is hoped that you may find time to give them a careful perusal, conveying to the members of your Board the main points in their contents. There are just two items referred to therein, Nos. G-1463 and G-1465, to which the Board asked me to direct the special attention of Board Secretaries and the Mission Boards which they represent. These deal with the Union Middle School and the Union Theological College. The Board of Governors received full reports of the work of both these institutions; that of the latter has already been circulated to all members of the Board of Governors and, no doubt, you have already studied it. I am asked to say that the Board is entirely satisfied that both these institutions are doing vitally important work, which has a direct bearing upon the University and the ideals for which it stands. I have talked this over with Secretaries here and we suggest asking that the Rev. F.W. Dillistone, who is now Vice Principal of Wycliffe College, Tor-He was a ClM.S missionary and was in close touch with us while in England, and we all feel that if he would accept the position he would admirably represent C.M.S. interests. I am, therefore, writing a letter to him and enclosing it in this to you, so that if you have no objections to this course you may post it on to him. If he agrees to accept the position it will not take so very long to put the necessary resolution through our Committees. My dear Mr. Barclay,

Twas at an informal conference in Toronto on Tuesday, at which br. Garsile and Dr. Eric North outlined a plan, which is the result of much careful thought, looking to a simplification of the present cumbrous machinery by which the 18 Union Christian Colleges in Thina are now governed.

The situation and proposals are outlined in an elaborate document prepared by Dr. Garsideand Dr. North in the New York Office, a copy of which I am sending you under separate cover.

It is, I feel, clear that something should, if possible be done in the matter. I followed the discussions carefully with a view to being able to report to you about it. And I may say quite frankly that I was much pleased with two points which seemed to come out quite clearly:--

- 1. That the shole trend of thought was to lay increasing emphasis on the Christian character of the Universities. I may say that the Sub*committee of the Associated Boards on Christian staff, character and curriculum is at the present time most energetically engaged in studying how this may be most completely effected.
- 2. That the individual cooperating units will be provided in some adequate manner with an opportunity of expressing their views on any major question of proposals affecting the general character end policy of the Universities.

The scheme, as you will see, attempts to safeguard in every way all existing endowments etc. so that the original intention under which they were set up shall not be violated in any manner.

It is the intention of the framers of the scheme to consult, before taking action, not only the Governing Board of each institution, but also the separate Mission Boards by which each Board of Governors is constituted. It might be well, therefore, if you would be so good as to let me know what the reaction of the C.M.S, to such a scheme would be. You will observe that, even if a particular institution decides against entering the scheme, it can still be put into operation by the remaining institutions.

Again Ite me assure you of our sympathy here in Canada with all of you in England in the terrible trial through which you are passing. We pray that the turn of the tide will soon come when will have respite from this awfuland senseless bombing.



Dear Mr. Barclay,

I returned a few days ago from New York, where I was able to attend all the meetings of the Associated Boards, and also the meeting of the Executive Committee of West China and that of the Board of Trustees of Fukien.

The meetings of the Associated Boards were very well planned and most inspiring; I was particularly struck with the material which had been prepared by Bishop Welsh of the M.E.Board for the devotional 15 minutes on the opening day. It was remarkable that this was in litrugical form, though I think that Dr. Wood and myself were the only ones present from the Anglican Communion. I think that I have a capy to send to you. Dr. Theodore Greene, of the Department of Philosophy of Princeton, also gave a most thought-provoking address on the essential relation between Democracy, Education and Christianity. This is to be reproduced in some form. I should add in this connection that the central point in discussion, for which the Special Committee on Christian Character, Staff and Curriculum had prepared the way, was how to make and keep the Colleges Chrstian. I am sure that all C.M.S. leaders will be thankful to know that there is not one on the Associated Boards who does not fully recognise the vital importance of this, and is determined that it shall be realised.

The C?M?S. was well represented at the meeting of the Fukien Board of Trustees by Mr. Thorne, Dr. Addison and myself. Unfortunately Dr. Addison came in late and left before the end of the meeting, so that I could not do more than get a hand-shake with him; but I think that he the right man for us. The elaborate scheme for greater Unity was before the meeting and approved in printiple, and Mr. Thorne was appointed to represent the Fukien Board on the Committee of representatives—one from each Board—to carry the schmem forward. This is an excellent choice, as he alreacy has acted and will act legal adviser in the matter. I seems uite clear that the rights of the individual Boards are fully protected in the plant I di not know that



there had been correspondence between the C.M.S, and New York about it; ti would seem that certain documents relating to it, which were sent to you, may have been lost in transit; but I felt justified, in view of your letter, in saying that the C.M.S. approved the plan in principle. I shall keep you informed of any further steps that are taken.

The Annual Meeting of the Board of Governors of West China is fixed for Nov 5 & 6 in Toronto

We continue to uphold you all in prayer in the terribly difficult days through which you are passing.

My dear Dr. Anderson:

I have just received a letter from Dr. Leslie G. Kilborn, Director of the College of Medicine and Dentistry of West China Union University. He tells me that he has recently written to you raising the possibility of your Society sending W. S. Thacker Neville to Chengtu to help in the emergency that has arisen there in connection with both the Medical College and the United Hospital.

I write to support Dr. Kilborn's presentation in every way that I can. The situation at Chengtu is extremely critical. I have no doubt that it has been described to you in detail and will not repeat what you already know. I would add, however, that only yesterday we received a cable from Dr. William Fenn, formerly a member of the University of Nanking faculty and currently our representative in China, stating that not only must reinforcement reach the United Hospital within the next few months but that sufficient relief funds from various agencies upon whom so much of our work in China has depended these last years are well-nigh unprocurable because of the situation having developed so far beyond the ability of the inadequate Western personnal to cope with it.

I know from Dr. Edward Hume of the Christian Medical Council for Overseas Work, onetime President of Yale-in-China and the organizer of the Hsiang-ya Medical College, something of Dr. Neville's high qualifications, his distinguished service in both Manchuria and China proper and his interest in the possibility of return for a few years of further, mature service. If your Society is able to meet the request of Dr. Kilborn it will be helping in an outstanding manner to meet a very critical situation on which a great deal, both now and in the future, depends.
