MINUTES OF THE GROUNDS AND BUILDINGS COMPLETEE
JUNE 30, 1927. Row As Enfilted by of see

June 30, 1927.

The meeting was held at the President's Office at 2 p. m.

Present: Dr. Learmonth, in the Chair, Miss Stahl, Mr. Chuan, Mr. Bevan, Mr. Barker, and Mr. W. W. Davis by invitation.

> The meeting was opened with prayer. Minutes of the last meeting were approved.

### MATTERS ARISING FROM THE MINUTES

G.B.1238 Voted- to ask Mr. Chuan to be responsible for seeing that no fishing was allowed on the campus anywhere and authorize the Construction Bureau to cut the reeds in all the ponds again within the next fortnight.

> Mr. Davis presented the report of the Sub-Committee on Finance.

1. Building Operations Undistributed. The Treasurer's Report makes this item over \$200,000 more than the Report of the Construction Bureau. A plan was worked out in cooperation with Mr. Beddow, by which these two items in the
reports are to be brought into closer agreement. This plan involves the arbitrary assignment of definite amounts to certain building projects, where the Construction Bureau shows a large excess of expenditure as against the Treaturer's report, e.g.

Refectory No.2 Treasurer's Report \$45,940
Construction Bureau 65,813
Additional amount charged to Refectory No.2 20,000 Total amount so distributed \$190,000

These charges affect the Treasurer's Report only and the details appear in his Revised May Balance Sheet.

- 2. Building Funds in the hands of the Treasurer and due to the Construction Bureau. We were unable to locate any such funds.
  - 3. Operation and Maintenance Ledger a/c. Owing to a misunderstanding the Committee failed to get any data.

The report was adopted. Mr. Davis and Mrs. Porter were thanked for their labors.

G.B.1239Voted- 1. That an itemized account of the sum owed by the Department of Athletics be sent to the Treasurer.

2. That the Secretary send a summary of the facts to New York and inquire about the balance owing to us, pointing out the difficulty of seeing what funds are appropriated for what buildings.

The following sub-committees were appointed (first named to be chairman in each case)

- G.B.1240 Roads Voted- to finish the road in front of Bashford and postpone any further work on roads till later on.
- Swimming Pool

  Voted- that the swimming pool be handed over when finished to the Department of Athletics. The medical officer requested to put up a notice that the work is not yet finished and that the water in the pool at present is infectious; and also to send a notice to the Students' Self-Government Association to this effect.
- G.B.1242 Doors in the Refectories
  Voted- that the request of the Men's College Faculty Executive
  Committee to have swinging doors between the Refectories and
  the kitchens in the Men's College be acceded to and to have
  automatic closers installed on the other doors when they arrive.
- Mr. Porter presented the report of the Color Committee. G.B.1243 Voted- to authorize Mr. Porter to go ahead with samples of the painting of Sage Memorial Hall and the Dean's Residence in the Women's College.
- G.B.1244 Voted- to authorize the Construction Bureau to prepare the Memorial Hall in Bashford for coloring under Mr. Porter's instructions.
- G.B.1245 Voted- to leave the painting of the Berry Library for the time being.
- G.B.1246 Voted- to go on with the color-washing of the Mem's Dormitories.

The other items on the agenda were postponed to the next meeting owing to the fact that so few members of the Committee were present.

### MINUTES OF THE GROUNDS & BUILDINGS

COMMITTUE, AUGUST 15th, 1927.

PEKING

The meeting was held at the Return Students Club, Peking.

Present: Dr. Stuart in the chair, Dr. Learmonth, Mrs. Frame, Mr. Chuan and Mr. Earker.

The meeting was opened with prayer led by Mrs. Frame.

The minutes of the last meeting were approved.

### MATTERS ARISING FROM THE MINUTES

GB 1247 - It was decided to consider the account standing in the name of the Athletic Department as an item of expenditure on "Grounds".

Mr. Barker read a letter from Mr. Gibb reporting the discussions of the Finance Committee in New York and giving much valuable information.

### TRACTOR

GB 1248 - It was decided to buy the Tractor from the Dept. of Agriculture at a nominal figure, taking into consideration the claims and mutual interest both of the Construction Bureau and of the Department.

### CONSTRUCTION RUREAU CARS

GB 1249 - It was decided to sell the truck and the two Construction Bureau cars, on condition that one car at least should be constantly available for the Yenching Community, this to be tarranged by Mr. Chuan and Mr. Barker.

made between the Treasurers of the Men's and Women's Colleges and the Construction Bureau that the University should pay Mex. \$70,000. - in monthly installments due on the first of each month for the current year, Residence charges for light and water to be collected in addition by the Construction Bureau and credited to the Power Plant Operation account.

#### CHARGES FOR LIGHT

GB 1250 - In view of this arrangement it was agreed to charge residence lighting at the rate of 20 cents.

### SCIENCE BUILDINGS

GB 1251- It was agreed to have the two Science Buildings white-washed before the beginning of the term, this to be charged to the Construction account.

### SHED FOR THE GAS PLANT

Mr.Barker reported that it was necessary to erect a shed over the entire Gas Plant. This matter was referred to the Construction Bureau to act in consultation with Mr.S.D.Wilson and Mr.P.A.Anderson.

GB -1252 -E.O.WILSON It was decided to go into the question of Mr.E.O.Wilson's salary and expenses being charged to the Construction Bureau account, with a view to preparing the University budget for next financial year.

### GB - 1253 - CAMPUS LIGHTING

It was agreed to install ag once thirty lamps on the Campus. The design for the standards was left to the Construction Bureau with the recommendation to see the standards used at the P.U.M.C.

### NEW ENGINE FOR POWER PLANT

Mr.Barker reported the opinion of the mechanical engineers that the additional light and heat needed for the coming session would make it necessary to run both the Steam Engine and the Diesel Engine at once. In addition to the expense, this left no possibility of running the Power Plant in case of accident, or temporary breakdown, and Mr.Barker was instructed to write to Mr.Gibb, including the engineers report, asking why the consulting engineer had allowed this to happen, asking for the Consulting Engineer's opinion on what should be done, and empowering Mr.Gibb to act for us immediately, pointing out to the Trustees the absolute necessity for such immediate action.

The Construction Bureau was also asked to go carefully into the question of what protective measures should be taken if the load at any time were too heavy.

### CONSTRUCTION BUREAU STAFF

- (1) The Secretary was instructed to notify Mr. Flood that his services would not be required after December 31st.
- (2) The Secretary was instructed to go into the matter of careful supervision of stores in consultation with Mr.Hildabrand.
- (3) The Committee ratified the increase of Mr.H.F.Woo's salary to \$120.00 per month, and asked the Secretary to find out if Mr.Woo would consider the possibility of a permanent position on the University Staff.
- (4) The Committee agreed that Mr.T.T.Liu's salary should conform to the salaries in the Administrative offices, the amount to be decided by Mr.Chuan and Mr.Barker.
- (5) The Secretary was instructed to inform Mr.Lund that during the remaining period of his services, i.e. to the end of 1927, he should be considered as consulting engineer, his duties to be advisory only, so that the engineers now in charge should continue to be responsible for the running of the Power Plant.

#### RESIDENCES

GB 1254 - Mr. Vincent's account: It was agreed to consider Mr. Vincent's outstanding account as settled.

GB 1255 - Heating in No.15: It was agreed to install a bath water heater in House No.15 in place of the present arrangement.

GB 1256 - House No.6: It was agreed to make House No.6 as nearly as damp-proof as possible, and to consider the same as permanent residence of the engineer in charge of the Power Plant.

House No.10A: A request was renewed to install central heating in house No.10A. In view of the fact that Mr.Flood would be leaving at the end of December and Mr.Bush could be accommodated in the Power Plant during the remainder of his contract this was considered unnecessary.

Roads: Mrs. Frame brought up the question of roads and paths, and asked if these could be marked out, smoothed and levelled so that they could be used by conveyances for transportation etc. Dr. Stuart reported that there was a gift of G\$7,000. - for roads.

GB 1269 - VOTED to ask Messrs. Porter, King and Hildabrand to make a further study of the general road system for the campus with special reference to east and west thoroughfares, and also to ask the Construction Bureau to find out how much of the G\$7,000. - has been spent for roads.

### SHED FOR THE GAS PLANT

GB 1270 - VOTED to approve of the above with the understanding that this comes within our appropriations.

### NEW YORK CORRESPONDENCE

Dr. Stuart reported the receipt of a cable from New York asking him to come to New York in view of the disorganization of the New York office, and stated that he would leave on the 24th of this month.

GB 1271 - Proposed by Mr. Bevan, seconded by Mr. Barker - that this committee sincerely regrets the necessity to call the President to America at this critical time in the life of the University, and deplores his enforced absence from the institution during the present term.

#### FINANCES

### a) APPROPRIATIONS

GB 1273 - VOTED to ask the Finance Committee (Messrs. Chuan, Davis and Mrs. Frame or a representative from the Wom. College), to find out from the Treasurer's office the amount received against each building from New York and how much is still in the hands of the Treasurer for these buildings.

b & c) POWER PLANT a/c: Mr. Barker reported that the Men's College still owes the Construction Bureau \$16,847.41., for the last year and the Women's College \$2,047.37., and that as far as the monthly payments for current year go the Men's College owes the Construction Bureau \$4,166.67.

GB 1274 - VOTED to refer these matters to the Finance Committee of the Grounds and Buildings Committee.

### d) MR. LUND'S salary

GB 1275 - VOTED to charge half of Mr. Lund's salary from 1st July 1927 to the Construction Bureau account and half to the Power Plant a/c.

### CONSTRUCTION BUREAU STAFF

This matter was discussed at length and the following actions were taken:

GB 1276 - VOTED: Mr. Hildabrand's appointment: VOTED that we appoint Mr. Hildabrand as the director of the Construction Bureau and the University engineer under the Administration of the University, to have the general charge of the Power Plant in the latter capacity.

Dr. Stuart read a letter from Mr: Hildabrand re his agreement with the University should Mr. Hildabrand be asked to stay on.

GB 1277 - VOTED that we approve Mr. Hildabrand's proposal as outlined in his letter to Dr. Stuart.

The question of Mr. Gibb's return to the Construction Bureau was also discussed and the following motion was proposed:

That this Committee recommends that Mr. Gibb be asked, in addition to teaching work, to represent the Administration in taking over general charge of the Power Plant operation at the expiration of Mr. Hildabrand's contract.

Messrs. Barker and Bevan voted for and Mrs. Frame, Messrs. Johnson and Chuan against.

GB 1278 - VOTED to ask the secretary to write to Mr. Gibb explaining why this action was not taken, and supplementing President Stuart's letter.

GB 1279 - VOTED to ask Mr. Holm to take charge of the Power Plant during his remaining stay with the University

PLANS FOR MR. WU'S FUTURE: It was reported that Mr. Wu is willing to make a ten year arrangement with the University; that Mr. Wu is planning to go to America next summer and will be away for four years, the University to pay Mr. Wu his salary during two years of his stay in America (at the rate paid at present by the Construction Bureau). At the expiration of which Mr. Wu is to come for six years to help with the University work.

GB 1280 - VOTED to ask Dr. Stuart to take this matter up with Mr. Wu.

### MOTOR CARS

GB 1281 - VOTED. It was decided to take this matter up at the next meeting.

DOMESTIC HOT WATER: It was reported that this would cost \$60. per day until the heating season.

GB 1282 - VOTED to refer this matter to the Staff Conference.

### CONTINUOUS ELECTRIC CURRENT IN DAY-TIME:

It was reported that there was no very satisfactory way of preventing electric current being used in other buildings apart from the Science Buildings during day-time.

GB 1283 - VOTED to ask Messrs. Holm and Chuan to take charge of this matter:

### ELECTRIC LIGHT SUPPLY

It was reported that the Faculty Executive Committee voted to have the electric current continued till midnight.

LIBRARY: The question of changing the present wiring for the lighting system in the Library was brought up and also the request for 22 more tables and 3 more shelves. It was reported that the changing of the present lighting system in the Library Building would cost about \$300.

GB 1284 - VOTED to ask the Construction Bureau together with Dean Hung and Mr. Tien to make a further study of this matter and to report back to this committée.

#### PARTITIONS IN MCBRIER SECOND FLOOR

GB 1285 - VOTED to ask Wessrs. Hildabrand and Chuan together with the committee on McBrier Building to act on the suggestions from New York about the lay-out of the second floor.

SIZE OF FUTURE DORMITORY ROOMS Dr. Stuart reported the receipt of a letter from New York re size of future dormitory rooms and it was

GB 1286 - VOTED to ask Mr. Chuan to take this matter up with the Commission of Students Welfare and to report back their recommendations to this committee.

WOMEN'S COLLEGE INFIRMARY; Mrs. Frame reported that the Wom. College proposes to use the Kindergarten house as their temporary infirmary as there is no room in the present infirmary for the Wom. College and asked the committee to ratify this action.

GB 1287 - VOTED that we approve of the Wom. College using the Kinder-gauten house as their temporary infirmary until additions can be made to the present infirmary; and agree to the Women's College having the use of that building for any other purpose they may need, until it has to be removed for further extension.

GB 1288 - VOTED to elect the following as members of the Grounds and Buildings Committee: - The acting Treasurer of the University, andMessrs. Holm and Bush.

GB 1289 - VOTED that Mr. Barker be re-appointed as secretary of the Grounds and Buildings Committee.

GB 1290 - VOTED to have the next meeting on Thursday afternoon at 2 p.m. Sept. 22nd, at the Construction Bureau office.

GB 1291 - VOTED to ask the Secretary to write to Mr. Bush expressing this committee's sympathy in his recent illness.

### MATTERS ARISING FROM MINUTES

### Report of Com. on size of future dormt. rooms:

MADRICAN

Mr. Chuan read a letter reporting action by the Commission on Men's Welfare re size of future dormitory rooms, suggesting that future dormitory rooms be made 1' wider and 1 'longer than the present rooms which are 9' x 13', that is that these rooms be made 10' x 14' the same as the Wom. College Dormt. rooms.

GB 1306 -

Voted to approve of the above recommendation.

### Sale of motor car

It was reported that the above matter was taken up at the General Executive Committee meeting. It was stated that the Committee is getting in touch with the New Republic Garage and is asking whether a better car service can be provided as the present one is very unsatisfactory, and suggests that the sale of the Construction Bureau car be held in abeyance pending consideration of the arrangements between the University and the New Republic Garage.

GB 1307 - Voted that the sale of the Construction Bureau motor car be held in abeyance pending further consideration of the arrangements between the University and the New Republic Garage.

It was also reported that the charge of \$5.00 for a trip to Peking hardly covers the cost of the same and it was

GB1308 - Voted to put a notice in the bulletin stating that Construction Bureau cars are available for service but subject to a slight raise in charge.

MOT WATER METERS: It was reported that four hot water meters arrived recently.

that this is in a very poor condition and that repairs are being done every fortnight and it was suggested that a new cable be put in, the cost of which will be approx. M#350. It was also reported that it is proposed to have eventually a Chinese bell and that in the meanwhile negotiations are being carried on.

GB1309 - Voted that the present bell system be repaired with overhead lines for temporary use during this academic year, and that we ask the chairman to communicate with Dr. Stuart re purchase of a foreign bell in America for temporary use. GB1310 - It was further voted that the cost of the above repairs will be charged to the operation and maintenance budget.

HOUSE FOR GAS- PLANT: Mr. Hildabrand reported that the amount allocated for the Gas-Plant is Mex.\$6.954.- and that \$7,000.- has already been spent for the Gas-Plant. He further reported that the cost of putting a shed for the Gas-Plant will be approx. M\$1500.-

GB1311 - Voted to authorize construction of a shed for the Gas-Plant and that funds for same be provided by the Science Departments, and that Mr. Chuan be asked to take this matter up with the Science Departments.

Cost of operating Gas-Plant: It was reported that the cost of operating the above will be somewhat in the neighbourhood of M\$1,000.- a year.

GB1312 - Voted to refer this matter to the General Executive Committee

### STORE HOUSE FACILITIES

It was reported that at present the Construction Bureau has \$70,000.- worth of goods, one third of which are lying outside and deteriorating from bad weather. It was suggested that an additional store house be built the cost of which will not exceed M\$600.-

GB1313 - Voted to authorize the Construction Bureau to put up an additional store house the cost of which not to exceed \$600.-

ADDITIONAL ARCOLA FOR HOUSE NO.11: Mr. Hildabrand reported that a request has been made by Miss Boring for an additional arcola for her house. Also that last summer part of the radiation from her house has been taken out, but now on account of her ill-health she requests for an additional arcola. It was reported that this will cost approx. GB1314 - Voted to ask Miss Boring to use ordinary stoves for the present

ELECTRIC CURRENT ON HOLIDAYS: Dr. Galt read a letter from the Science Departments and two points were brought up:

- 1. That day current is needed on all the week days including all holidays and vacations except the Christmas and New Year Days.
- GB1315 Voted to meet the request of the Science Departments for the day current during all holidays except Christmas and New Year Days.
- 2. That a continuous current from Wednesday 1:00 p.m. to Friday 12:00 p.m. be provided during the first and third weeks of each month.
- GB1316 Voted to approve of the above request.

It was suggested that a storage battery of Edison type might be purchased to meet the above demands, the cost of which will be in the neighbourhood of G\$950 .-

Voted to leave this matter for further study to a sub-committee composed of engineers and Science Departments representatives to consider technical and financial problems.

It was further voted that if the actions requiring day-time current should require additional staff that this committee will give consideration to the same.

E.O. WILSON'S SALARY: It was reported that Mr. E. O. Wilson's salary has been paid by the Construction Bureau ever since Mr. Gibb was connected with the Construction Bureau, Mr. Wilson being Mr. Gibb's substitute in the Chemistry Department, and now that the Construction Bureau is no longer using Mr. Gibb's services it was asked whether this can be transferred to the University's account. But as Mr. Gibb is entitled to a year's leave it was decided to

### MATTERS ARISING FROM THE MINUTES

a) Report of sub-committee on storage battery Mr. Hildabrand reported that a sub-committee consisting of Mr. Holm, Mr. Bush and himself and some Science Department representatives had a meeting at which the purchase of a storage battery was taken up. It was recommended that if the 24 hour current would not be required in the early future, a storage battery should be purchased for the Science Departments, the cost and installation of which is estimated at approx. 15,000 .- In case all night current be supplied it would add \$5.00 extra per day to the present expenses of running the lighting system.

Voted that we recommend to the General Faculty Executive GB1325 -Committee the installation of a storage battery, the cost of which and installation is estimated \$5,000 .- part of which to be charged to the Science Departments, unless it is the judgment of that committee that all night electric service be required at an early date.

b) Report of sub-committee on telephone: Mr. Chuan reported that to repair the whole telephone system so as to have permanent installation would cost approx. 15,000 .- and to repair it temporarily so as to keep it going would cost \$500 .- He also stressed the point that it is most necessary to repair the same on account of the congested state of some of the wires, and suggested that a sub-exchange be arranged at the Construction Bureau gate-house, which would relieve the Bast Compound. It was reported that the funds for telephone installation had already been overdrawn.

Telephone system: Voted that a sub-committee be appointed to ascertain whether means could be provided for permanent telephone improvements.

GB1327 - It was further voted that the chair appoint a sub-committee for the above.

It was stated that several laboratory sections had to be called off last year because it was extremely cold, which it was thought was caused not because the building was insufficiently heated, but because there are large cracks in the windows.

Mr. Hildabrand reported that this would call for 43 windows down-stairs and 53 windows up-stairs, the size of each would be 5'l" x 2'4", and the cost would be \$3.95 per window. The total cost would be somewhere in the neighbourhood of \$400.- He also suggested that since the Physics account is already overdrawn that the cracks be filled with cotton wool or paper temporarily.

GB1334 - Voted that we approve the request of the Biology Dept. for double windows in north rooms on the condition that the same is approved by the General Faculty Committee; otherwise we recommend that cracks be filled in temporarily for this winter with cotton wool.

request from the Department of Biology was that certain spots on the campus be set aside for wild plant reserves where no grass will be cut at any season of the year. The spots indicated where shown on an attached map.

GB1335 - Voted to approve of the above request with the understanding that the location of the spots chosen be approved by the Landscape Committee.

LAND IMPROVEMENT ACCOUNT: It was reported that a letter dated Oct. 17th was received from the Women's College asking explanation on several accounts among which was Land Improvement account. It was reported that Men's College pays 2/3 for land improvements while the Wom. College 1/3. The total expenditure for this up to the present is \$\frac{1}{71}.085.06.\$, of which the Wom. College has already paid 1/3 in addition to the Wom. College land improvements. Mr. Wiant stated that it would be difficult to give definite information re this account as the architect's fees are also involved in this, and that this is the one account on which the Treasurer's office and New York office have not agreed this year.

GB1336 - Voted that we refer this matter to the accountants concerned i.e. the Treasurer's office and the Construction Bureau accounting office and also to ask the Construction Bureau accounting office for analysis of the land improvement account.

### WATER BALING CONTINUOUSLY UNDER CERTAIN BUILDINGS:

NINDE, LIBRARY ETC. It was reported that this is due to leaky basements, not properly built. Mr. Wiant reported that there are funds for improvements for the Ninde Divinity Building.

GB1337 - Voted that we approve of filling in the basement of the Ninde Divinity Building, subject to the approval of the faculty of the School of Religion.

BICYCLES: Mr. Hildabrand reported that both he and Mr. Bush had their bicycles stolen, one on the main Campus, the other in Lang Jun Yuan. It was also suggested that the Construction Bureau should provide Construction Bureau members with bicycles for executing University business.

GB1338 - Voted to take this matter up at the next meeting of this Committee.

CANAL: Mrs. Frame reported that at the Grounds and Buildings Committee meeting on August 22nd it was agreed to make a canal, separating the Men's and Women's Colleges, as called for on Mr. Murphy's plan and in Mr. King's report. Mr. Stimpson's letter re his proposal for permanent telephone installation was read, and it was noted that his last estimate is \$3,000.- which is lower than his original estimate, which was \$4,000.-

GB1339 - Voted that we recommit Mr. Stimpson's proposal for permanent telephone installation to the sub-committee on telephone, and ask this sub-committee for a written summary of telephone finances and for definite recommendations.

PARTITIONS IN MEN'S ADMINISTRATION BLDG: Mr. Chuan reported that the sub-committee on Administration Building offices met and it was stated that the McBrier Building would be ready by the second semester so that departmental offices could be transferred to the first floor there while more permanent arrangements could be made for administrative offices in the Administration Bldg.

GB1340 - Voted to ask Mr. Hildabrand and Mr. Chuan to consider all these proposals and to report definite recommendations to this committee.

REQUEST FOR A NEW ENGINE FOR THE POWER PLANT: Mr. Hildabrand letter to Mr. Galt re purchase of a 25 HP engine was taken up. It was reported that the 15 K.W. Generator which was bought for generating current for the Science Departments and for other light work such as pumping water and running the sewage pumps during daylight hours is being run with an 11 HP engine, which is entirely inadequate, and that little saving is effected as when anything is wanted other than supplying the Science Departments one of the large generators has to be started.

Mr. Hildabrand reported that the Construction Bureau recently received quotations from several firms, Andersen, Meyer & Co's being the lowest todate, which is £327/-/- on a Fielding and Platt 24 HP Semi Diesel engine, ex Tientsin. This with some extras inland freight, installation costs etc., would amount, ready to run, to about M\$4,000.- and the cost of running this engine under full load, including fuel, oil, labour, interest on investment and depreciation would be between 50 and 60 cents per hour, which is less than one quarter of what it costs to run one of the large generators under a light load.

MM. Barker stated that New York had already been notified last summer of the necessity of purchasing an engine of this type, but that no authorization had been received.

GB1343 - Voted that this committee approve the purchase of an engine of this type, the same to be charged to the Current Power House Budget, and that a cable be sent to New York reporting that if the engine asked for in previous correspondence has not been purchased this committee proposes to purchase the same locally.

FURNITURE FOR THE MCBRIER HALL: Mr. Chuan stated that since the McBrier Hall would be ready by the beginning of the second semester it would be advisable to make preparation for the furniture for this building, and that the following are rough estimates of furniture needed for the above 200 sets of desks and chairs, 300 arm chairs, 4 seminar tables, 12 instructors tables also chairs. The cest of these will be somewhat approx. between \$2500 and \$3,000.-

GB1348 - Voted to appoint a sub-committee on furniture for the Mc-Brier Hall, authorized to expend for the same not to exceed \$2500.-without further reference to the Grounds and Buildings Committee.

Committee appointed: Mr. Chuan, Mr. Hildabrand, and the Registrar (Mr. Ch'en).

- 11. Raise ceiling in Ref. No.2. kitchen.

The above changes exclusive of sleeping quarters and cellar drainers will cost approx. \$600.-

In connection with the sleeping quarters for servants Mr. Bush suggested the use of House No. 10 in Tang Pu Hutung which he and Mr. Flood had just vacated.

GB1377 - It was voted to note the above suggestion and to refer the use of House No. 10 for sleeping quarters for servants connected with Men's Refectories to the sub.-com for further study and report.

COUNTER SIGNATURES OF CONSTRUCTION BUREAU AND POWER HOUSE CHEQUES: Mr. Hildabrand reported that Mr. Beddow requests that Construction Bureau and Power House cheques be countersigned at the Treasurer's office. ### MATTERS ARISING FROM MINUTES:

a)Attitude of students toward dormitory plans: Mr. Galt reported that the com. appointed at the last meeting to consult with the students re new dormitory plans had brought the matter before the students, who approved of the plans on the whole, the only question being asked was whether there is space for servants quarters. Mr. Galt further read a letter from The Student Self Govt. Association of the Men's College, in which they expressed their hearty thanks and appreciation to the Board of Trustees in New York for the new plans, and also their appreciation in having been consulted about these plans.

b) An additional partition in McBrier Hall: Mr. Galt stated that for information purposes he wishes to report to this combattat the President's office in dealing with the allocation of offices in McBrier Bldg., authorized to put an additional partition at the west end of the corridor on the second floor.

c)Repairs for Science Bldg Roofs: Mr. Hildabrand reported their last communication to Wm. Forbes & Co., in which they asked this firm to send their representative to make a more minute inspection of the roofs, and who would be given authority by Wm. Forbes & Co., to deal directly with the University. That in connection with this request Wm. Forbes & Co., sent their No.1. Roofing man who had inspected the roofs and returned to Tientsin to make a report to their Head office. Because it is important to have these roofs repaired before the rainy season starts it was

GB1462 - Voted to ask the sub-com. appointed re the above matter to try and speed up the process as quickly as possible.

MR. HILDABRAND'S RESIGNATION: Mr. Galt read a letter addressed to him by Mr. Hildabrand, in which it is stated that an offer has been made to him, which looks like a permanent position with an increase in salary to begin with over and above what he is getting now of about M\$200 .- He also mentions in his letter that according to his contract with with the University there is a clause which says, that he may discontinue his services with the University if and when a suitable substitute can be In view of this he has secured the promise of Mr. S. Dean, member of the Presbyterian Mission to take his place beginning from July 1st of this year and to continue until July 1st, 1929. He further stated that at first Mr. Dean advised that he would be able to spend only three days a week here at Yenching, to which Mr. Hildabrand replied that he did not think this would be satisfactory way of handling this job, which required the full time of one man. To this Mr. Dean replied that he would be able to spend five days a week until September 1st, 1928, for which he would require a salary of \$375.00 a month, and that he would also bring with him a Chinese assistant, who is a specialist in heating installation, at a salary of \$60.00 a month. Also that from September, 1928, until July 1929, Mr. Dean could spend three days a week here, at a salary of \$225.00 per month with two Chinese assistants at \$60.00 a month each; one to continue the supervision of heating and plumbing installations, and the second to look after the general building work.

Mr. Hildabrand further requested in his letter that if his resignation is accepted, the entire management and operation of the Power Plant be turned over to Mr. Holm, also that the Construction Bureau payments be made at the Treasurer's office, enabling Mr. Dean better to look after the construction and repair work.

Was also brought up before the Faculty Executive Com., and that in view of the fact that Mr. Dean can only spend part time on the job this proposal was found insatisfactory. After a lengthy discussion, on the suggestion of Mr. Hung the following voter was passed:

GB1463- That a small committee be appointed by the chair to consult with the University authorities, with Mr. Hildabrand and such other partie who are concerned in this matter, such as the Treasurer's office and the engineering office, and to report back to this committee for final decision.

The Com. appointed by the chair: Mrs. Frame, Messrs. Hung, Barker and Chuan, Mr. Hung chairman.

GB1464- Voted to meet not later than a week from today so as to make a final decision re Mr. Hildabrand's resignation.

WIANT'S RESIDENCE AND UNIT "A" DORMITORY CONTRACTS: Mr. Hildabrand reported that a contract has been let for Wiant's Residence for \$8,444 and that tenders ran from \$26,000.- to \$10,000.-

In regard to Unit "A" Dormitory, though the contract has not been signed, the bid is for \$7,991. and is undertaken by two men who had done building operations here before. In this case the Construction Bureau is to supply sand and gravel which will cost about \$400.-

In this connection Mr. Galt reported the receipt of a cable from New. York authorizing G\$7,000. - for this unit instead of G\$6,000. - as previously authorized.

ADDITIONAL EQUIPMENT FOR DEPT. OF PHYSICS: Mr. Galt read a letter from Mr. Anderson asking:

- 1. That the cost of the motor-generator for supplying alternating current to the physics laboratories be charged to the "permanent equipment budget". The cost being £129/6/- plus Tientsin Tls. 68.21.
- 2. That rooms 110, 113 and 115 of the physics dept.be supplied with work tables, electricity, gas, and water, and that the windows of rooms 110 and 115 be fitted with darkening shutters.

#157.- on the Physics Apparatus account and that apart from this there are no other funds available, the Physics Bldg. account being overdrawn to the extent of about \$9,000.-

GB1465- Voted that we reply to the Physics Dept. that there are no capital funds to draw, but that if gas and other equipment are required the same will have to be paid for out of the Current Budget.

Mr. Hildabrad reported that a contract had been let for liant's Residence for \$8,444 and that tenders ran from this amount to \$26,000. - the nearest one to it being \$10,000. -

Additional equipment for Dept. of Physics: The last paragraph should read:

Mr. Hildabrand reported that there is a credit balance of \$750 .- (not \$157 .- ) on the Physics Apparatus account and that apart from this there are no other funds available, the Physics Bldg. account being overdrawn to the extent of about \$9,000 .-

Repayment of loan to Mr. R.H.Ritter: Mr. Hildabrand reported that in their suspense account there appears a loan which had been made by Dr. Stuart, amounting to \$4,000 .- This money was borrowed to remodel and repair the Yen Compound, and we were asked to make a part payment of \$500 .- on this loan. Mr. Hildabrand further stated that he was informed that this loan was to be repaid out of the funds from the rent for the Yen Compound (Dormts).

The rest of the minutes as previously circulated were approved.

### MATTERS ARISING FROM MINUTES:

Mr. Hildabrand's resignation: It was reported that the sub-com. appointed at the last meeting to deal with this matter had met. The proposal that Mr. Dean should take over Mr. Hildabrand 's job was not found satisfactory, in view of the fact that Mr. Dean can only spend part time out here, and also that he will be going home on furlough after af year's time. Mr. Mildabrand agreed to suspend his resignation for the time being, and stated that he would take the matter up with Dr. Stuart on his arrival.

The Com. expressed its appreciation to Mr. Hildabrand's attitude in this matter.

PLAN FOR BUILDING NEW RESIDENCES: Mr. Chuan submitted a report, copy of which is herewith attached, which he had been asked to make for forwarding to the New York office, and which had been drawn up after making an inquiry to the various departments, asking how many additional residences would be required for their teachers.

In connection with the above Mr. Hildabrand pointed out that in some cases the figures given on the estimate for the new residences are too low and in view of this

GB1471 - Voted that the above report be revised as to the figures and submitted to New York for immediate action.

It was also reported that according to recent word from New York the Financial Campaign was planning on G\$40,000.- for residences.

RESIDENCE COMPOUNDS ROADS AND LIGHTS: Mr. Chuan stated that several inquiries have been made as to whether there was any provision made for public roads and lights in the Residence Compounds. It was mentioned that, when the residences were first authorized, if any funds should be left over from the total amount, these were to be allocated for the improvements of roads and installation of lights in the residence compounds, but as the cost of these residences exceeded the authorization it is feared that there are no funds left for residence compound roads or lights.

In connection with the above and in view that most of the matters dealt with by this com. are usually related to financial measures it was proposed to appoint a sub-com. which would handle these financial matters, and supply the information as to funds needed or available for various projects.

GB1472 - Voted to appoint a succom. consisting of the Treasurer and the University Engineer to deal with the financial end of matters brought up before this Com.

GB1473 - Voted that with reference to Residence Compound roads and lights to refer this matter to the new Finance Com., and to ask that a statement be prepared in regard to same, and that this matter be reported to this Com.

A LETTER REGARDING MR .H.F. WOO: Mr. Galt read a letter from Mr. A.V.Millar, Assistant Dean, College of Engineering in the University of Wisconsin, Madison, in which it is stated that Mr. Woo registered as a graduate student, and that at a recent faculty meeting it was voted that Mr. Woo be offered one of their graduate fellowships, Mr. Woo being the first Chinese student to receive one of these fellowships.

WATER SUPPLY FOR THE SWIMMING POOL: Mr. Galt reported that a representative from the Men's Student Self Association had called and asked whether it would be possible to supply water for the Swimming Pool from the Artesian Well instead of from the Lake as was done in the past. Mr. Hildabrand stated that the matter of supplying water for the Swimming Pool from the University Artesian Well was taken up at the time the Swimming Pool was in process of construction and that he had at that time and still does strongly advise against this arrangement, since the water required would undoubtedly be sufficient in volume to overtax the capacity of the well. Also that to drill a new well specially for the swimming pool would also be inadvisable, since it would have to be within 400' of the existing well, and would undoubtedly diminish the flow of the University Well. In connection with this water supply Mr. Hildabrand thought that the water might be clarified by first putting it thru a filter bed, and then it might be further purified by chlorinating.

GB1476 - Voted to reply to the Men's Student Self Association in the negative, i.e. that it would not be possible to supply the water from the Univer. Artesian Well.

reported that there was a bill for approx. \$89.00 for reconditioning the running track, about which there was some misunderstanding as to where it should be charged, but as he had had not time to go into this question, he suggested that it be postponed for further study.

GB1479 - Voted to postpone this matter for further study.

that, now since Mr. Bush has gone and Mr. Holm has the entire charge of the Power Plant, his entire salary should be charged to the Power Plant a/c. instead of half to the Con. Bureau and half to the Power Plant.

GB1480 - Voted that Mr. Holm's entire salary be charged to the Power Plant account.

reported that the present water supply in the Gardens is not satisfactory due to the insufficiency of the current for the hydraulic ram, and suggested that an electrically driven pump be installed, the cost of which will be about \$500.-

In connection with this it was reported that the Dept. of Chemistry is to analyze the water, and the present indications are that it might prove to be hard. An alternative plan of supplying the water from the main system was discussed.

OB1481 - Voted that we proceed with the purchase and installation of the proposed electric pump unless the analysis of water seems to suggest some other plan more advisable, the cost of the pump to be charged to Power House Current Account.

reported that at present the machine shop has three lathes and one shaping machine, but no drilling machine, and that all the materials which have to be drilled must be sent into town, involving additional expense and delay, and suggested that a drilling machine be purchased, the cost of which will not exceed \$550.-

### MATTERS ARISING FROM MINUTES

a) Addition to Residence No.20A: It was reported that the group which had met this morning discussed two questions concerning the above matter. First, the plans, and second, funds for carrying them out. It was reported that the plans as prepared called for two additional bedrooms, making it altogether four bedrooms with only one bathroom, which would not be convenient, and it was again pointed out that such an addition would impair the appearance of the house.

It was suggested that in view of the fact that small houses are being wanted more and more, and taking into consideration that the suggested addition to House No.20A would spoil the style of this house, whether it would not be possible to build a bigger house for Judge Kuo and leave his house for a small family, funds to be furnished from the recent authorization from New York for two additional residences. But it was stated that it was not certain whether funds would be sufficient to build one big house and one small house, and that Judge Kuo is reluctant to move from the Gardens.

Mr. Hildabrand suggested that in view of his family leaving soon he would be willing to move from his house and to let Judge Kuo occupy it. And that he would take one of the recently authorized houses when completed

GB1487 - Voted that we re-commit this matter.

b) Residence Compounds Roads and Lights: In discussing this matter two questions were faced: First roads and lights within the com-

pounds and roads and lights to the compounds.

would be needed for the two Residence Compounds, which would cost approx. \$600.-

GB1489 - Voted to proceed with the installation of lights within and to the Residence Compounds, funds to be furnished from the Campus Lighting authorization, the amount not to exceed the above estimate.

In connection with the above the matter of electric lights for Chengfu Street was also brought up. It was reported that some kind of a promise had been made by Mr. Gibb to the village elders that a few lights would be installed in Chengfu Street on the poles for the line connecting the East Compound with the main electric line, which arrangement was authorized by the Chengfu authorities. But as no lights as yet had been installed the village elders sunt in their communication recently reminding the Univer., of this promise.

GB1490. To install a few lights in the Chengfu Street, on the basis of a written statement specifying certain conditions, such as protection of electric fixtures, and re further extension of lights to other streets; funds for the above to be paid out from the General Campus Lighting authorization.

Plans for the two new residences: Plans for the two new residences were exhibited and after some discussion it was decided to refer these plans to Mrs. Porter, Mrs. Tsai and Mrs. J.C.Li, who are occupying Chinese residences for their criticisms and approval.

authorized for roads, this matter was again discussed. Actions of the meeting of April 26th were again reviewed, and the following motion was passed:-

Dr. Learmonth proposed: that the road from the Pres. House should follow eastward along the high ridge from Sage towards Mr. Gibb's house and then turn north and again east to the East Gate. After discussion it was

GB1492- Voted to approve of the periphery roads approximately as proposed by Mr. Hung at the meeting of Dec. 9th., but to leave the exact location to further consideration when a permanent road can be built.

With regard to a road to the President's House it was voted to

GB1493 - Rescind the former vote (1491) and to leave the question in abe-

In connection with this road it was also

GB1493a Voted that in putting the periphery roads in condition the East Gate of the Univer., Campus shall be built at a point south of the Power House service court; that the service court wall should also be built, and that the existing gate be used only for Con. Bureau and Power House business.

Building dyke south of Chengfu: It was reported that at one time there had been a dyke running eastward from about the middle of the East wall of the "Korean Garden". This dyke diverted the water to the eastward thru what is now an old dry river bed, emptying it into the stream near the Tsinghua College Gate. This dyke had been out of repair for a good many years with the result that all the water, which formally was carried thru the this old channel, now flows down the roads which runds runs along the east side of the Univer. Campus, with the result that during the flood stages a part of the Campus and part of the village of Chengfu are imundated. During the summer of 1927 there one time was a foot of water on the boiler room floor from this cause. A petition has been recently received from the village elders of Chengfu, asking that the Univer. participate in the re-building of this dyke, their estimate of the cost being \$800.— They had been reminded, however, that the first thing to be done is to acquire the right to turn the water thru the old river bed, and that this might require a considerable time, since it has been under cultivation for a good many years.

GB1494 - Voted to reply to the authorities that if they succeed in acquiring this river bed from the farmers the Univer. would be willing to discuss this dyke proposal, but that the Univer., might desire to consider the rebuilding of the dyke and the improvement of the road along the east side of the Campus as one proposition, since the latter would also be of benefit to the vila lage.

Roads to East Compound: Mr. Tayler, who now represents the East Compound Association, reported that, since it has not been possible to procure the Temple property, which would be the most desirable solution of the East Compound road problem, it is now requested that the piece of land on the opposite corner from the Temple be procured, which would permit removing one of the most undesirable curves. He also reported that the East Compound people were now willing to drop their first request and would be satisfied if the road could enter at the south-west corner of the Compound.

GB1495 - Voted to put this work in hand as soon as funds could be found



for purchasing the land in question, and constructing the road.

Mr. Tayler also submitted another request from the East Compound Association: to have a temporary entrance made to the main Univer. Campus opposite the Chiang Chia Hutung Bridge, in which case the road would pass thru the future Athletic Field, thence via the road in front of the Lakefront dormitories. After discussion, in view of the fact that the road along the lakefront dormitories would probably be considerably torn up and blocked for a period during construction it was

GB1496 - Voted to reject this request.

Road to Yen Compound: Mr. Chuan requested that some improvements be made to the road leading to the Yen Compound, since it is very muddy and impassable during the rainy season. Mr. Hildabrand reported that it would cost something like \$600. - to make the needed improvements.

GB1497 - Voted to approve of this request.

As the time was getting late and there were still a few more items on the agenda it was proposed

GB1498 - To continue until 6.30 p.m. and then to adjourn.

Sleeping quarters for Power House employees: Mr. Hildabrand raised the question of sleeping quarters for Power House employees, which he said was brought up at the meeting of Jan. 26th.

GB1499 - Voted that the com., on houses for kitchen employees be authorized to attend to the question of housing Power House employees who are single, and that the matter of providing quarters for married men to be referred to the above com., for further study and report.

Re-insulation of heating mains: Mr. Hildabrand reported that when they began the installation of the heating main for the Men's Gymnasium they found upon removing some of the insulation that the existing mains were corroding very badly. This is partly because the steel pipes were not properly painted. The insulation consists of a layer of braided rice straw to which was applied a coating of lime and clay and outside this was a lime and cement plaster reinforced with small mesh chicken wire. The trenches are not moisture proof, with the result that the straw wrapping absorbs moisturem and fermentation has set in . Upon consulting the Chee mistry Dept., it was found that an acid compound developed under these conditions, which accelerated corrosion. This means that the entire heating main would have to be opened up, painted and re-insulated. Mr. Hildabrand further stated that he is in touch with some Chinese asbestos mine owners and the Chemistry Dept., and may be able to develop an insulating material closely approaching the products manufactured abroad. He also suggested that this matter should be given a thorough study in consultation with experts in order to avoid mistakes being made a second time.

GB1507 - Voted that the sub-com. continue its studying and investigation as to the best type of chairs for the Auditorium, and that a sample of the Chen Kwang Theatre chairs be made for the inspection of this Committee.

Curtains for the Auditorium: Mr. Tsai brought up the question of curtains for the Auditorium.

Engineer he felt it incumbent upon himself to once more call the G.&.B. Com. attention to this hazard.



Minutes of meeting, August 7th.

Present: President Stuart, Mr. Hildabrand, Mr. Holm, Mr.S.J.Chuan, Mr. Galt.

1. The Committee took up the question of Mr. E.O. Wilson's salary, which in view of Mr. Gibb's salary as Director of the Construction Bureau having been charged to the Methodist Mission, has been charged to the University Construction Bureau.

Voted that after July 1st of this year, Mr. E.O. Wilson's salary be transferred to the regular University current budget.

2. Heating System at House No.11(Miss Boring and Miss Boynton)

The necessary alterations in this heating system having been authorized by earlier vote of the G.&.B. Committee, it was voted to charge the cost temporarily to account No.22 (University Residence Operation) and transfer the item later to capital residence funds, when such are available.

Reconstruction of Telephone: The question of the reconstruction of the telephone system as set forth in a letter of August 4th signed by Mr. Hildabrand and Mr. Holm was considered. It was agreed to increase the amount of money to be used for the reconstruction from \$7,000 Mex., to \$10,000, and to spend these funds for permanent improvements in such a way that the improvements would all be in the direction of the more thorough reconstruction advocated in the letter from Mr. Hildabrand and Mr. Holm referred to above. It was voted to secure the \$10,000.— needed from the following sources:

- 4. Decoration for Bashford Hall: After informal discussion of the proposals for the design, for the decoration of the corridor in Bashford Hall, it was agreed that Mr. Hildabrand should have certain sections painted as samples for inspection and criticism preliminary to final decision regarding the design.
- that a sum of Gold\$5,000.- toward the proposed "Scranton Luce Memorial" or similar structure had been secured, and that according to the terms of the donation, the work should be undertaken at an early date. Mr. Chuan was asked to correspond with a Chinese architect in Tientsin regarding a design for the proposed building and President Stuart was asked to correspond with the New York Office in order to secure authorization for the use of these funds.
- Lakeside dormitories: Regarding the plans for the Lakeside dormitories, it was reported that possibly the two refectories involved in the plans as drawn up by Mr. Mupphy might not be needed. It was agreed that in further construction of this dormitory unit, the dormitory rooms should be built first, and that the refectory units be either delayed in construction or modified to serve as student's dormitories, as might be decided later.
- 7. Funds for the Remodelling of Professor T.H.Chen's Residence:
  A statement regarding plans for the remodelling of this residence in
  Haitien was made by President Stuart and Mr. Hildabrand. It was estimated that approximately Mex.\$2,000.— would be required to finish the work. It was voted to charge this item to the current budget for the time being, attempting to secure capital funds for the same later, if possible.

## Special Executive Committee in charge of G.& B. affairs for the summer.

Sept. 12th, 1928.

Present: Mr. Galt, chairman and secretary, Miss Stahl, Dr. Stuart, and Messrs. Chuan and Hildabrand.

that pursuant to an unrecorded request made by the Grounds and Buildings Committee earlier in the year, investigation had been made as to whether it would be more economical to install additional radiation, or provide double windows on the north and west rooms of some of the University buildings, which at present have inadequate heating facilities for the coldest weather. This investigation indicated that the cost of additional radiation would exceed the cost of installing double windows, which due to the fact that there would be the operating costs on additional radiation, would make it more economical to provide windows.

Due to the fact that the most serious complaints received last year were from the occupants of the west and north rooms of Bashford Building, a special study had been made of this particular structure, and it was found that the cost of installing double windows would approximate \$600.-

8 - Voted to authorize storm windows for the west and north sides of Bashford Building.

NINDE DIVINITY HALL ATTIC: It was reported that Mr. Barker suggests that this attic be fixed up to accommodate Theological students as a dormitory. Mr. Hildabrand stated that the cost of this would approximate \$400. - including a new bath-tub. The question of heating was also discussed. It was pointed out that there are pipes in that part of the building, and that by taking the insulation off, the place could be kept fairly warm. And as Ninde Hall provides a reading room where the students can study and spend their leisure hours, and use the attic only for sleeping, there should be no need of installing either stoves or radiation.

Since accommodating this number of students in the Ninde attic, would make that much more space available in the dormitories it was

9 - Voted to proceed with the alterations of this attic, the expense to be charged to the Contingent Fund. Further that this action be referred to the General Faculty Executive Committee, which is in control of the Contingent Fund.

INFIRMARY: Dr. Stuart stated that the Trustees during the last few months have been remitting to the field the remainder of the McKelvy funds for the Infirmary, and that they are anxious that the construction on the uncompleted portions of this building should proceed. He further stated that the New York Office would be pleased to have a set of the plans for the section already erected, and also for the uncompleted portions of this building.

In discussing this question it was suggested that the wings of this building should be widened for sleeping porches, the roof on the south side being extended accordingly. Further it was proposed to proceed with the foundations of these wings this Fall.

Voted to proceed with the work of putting in the foundations this Fall, and to ask Mr. Hildabrand to study the question of widening the wings for sleeping porches, and the extension of the roof on the south side.

President's House: This will be finished next month.

Water-Tower: will also be finished this year.

(b) Communications from New York: Mr. Galt reported that authorized payments for buildings have been coming out regularly. The following method being adopted: a schedule of authorization is sent to the Field by the Trustees and all money drawn by drafts, nothing being drawn unless authorized by the New York Office.

He further stated that a cable received a few days ago authorized G\$5,000.— to complete the purchase of the northeast property for the Athletic Field, also \$10,000 (silver)) for a building on the island. In connection with this it was reported that the Construction Bureau have gotten in touch with a Chinese architect in Tientsin and asked him to submit a design for the proposed building.

These first plans were found too elaborate and the architect was asked to re-draw and simplify them. It is proposed to start this work next Spring. It was stated that it is proposed to have a simple tea-house and a pavilion, which would accommodate a company of not more than one hundred.

Mr. Galt also reported that in one of their recent letters the New York Office suggested that accounts of completed buildings be closed, and on the basis of this the following action has been taken by the Executive Committee:-

"Voted that no further charges should be made on the Capital account for the following buildings: 4 Men's Dormitories, 2 Science Buildings, Ninde Divinity Hall, 2 Refectories and the Wom. College Buildings, and that further expenses should be charged to Maintenance Account rather than Construction Account. The same applies to residences, except those under construction, due consideration being given to unsettled accounts of occupants for painting, gardening etc. Further that this is subject to Mr. Hildabrand's and the Treasurer's approval."

(c) Actions by the Executive Committee during the Summer:
Mr. Galt reported that two meetings were held during the summer by
the Executive Committee. First one was held on Aug.7th, the minutes
of which Mr. Galt read to the Committee. A copy of the same is attached to these minutes.

Another meeting was held on Sept.12th copies of the minutes of which had already been distributed.

Agriculture: Mr. Galt stated that the Dept. of Agriculture in their letter of Aug. 27th offered for sale stones, tablets, and other materials from their new site, Yen Nun Yuan.

GB1526 - Voted to defer this matter until the question of the legal status of movable properties is settled.

(e) <u>Coal Supply</u>: Mr. Hildabrand reported that arrangements have been made with the Kailan Mining Administration whereby we can purchase as much coal as is required from Sept 27th to Dec. 31st,1928, at \$10.00 a ton for No.1. Slack and \$9.35., for No.2 Slack.

In connection with the above it was

GB1527 - Voted to ask Mr. Hildabrand to prepare a memorandum for householders as to what kind of coal is best for use in arcolas, and boilers.

GB1528 - Voted to ask the chairman together with Mr. Hildabrand to report to President Stuart the various proposals made re roads last Spring by this Com., and to leave this matter to the three with power.

INSURANCE ON ACADEMIC BUILDINGS: A letter from Mr. Edwards, chairman of the Insurance Committee was read and the following was noted:-

The possible losses to be covered on certain buildings as follows:-

Men's Dormitories(4)	M\$9,000 each
Refectories (2)	9,500 each
Ninde Building	6,500
Science Building	12,000
McBrier Building	12,000
Sage Building	8,800

making a total of M\$94,300. This covers the entire probable loss for each building in case of fire in the roof. In case of the refectories the amount was increased as the upper floor ceilings and the upper floor windows would be damaged in case of a roof fire.

The Insurance Com, , further recommends that the University create its own reserve fund to cover loss on these and other buildings, and second that until this fund is created insurance be carried by regular insurance companies to cover the risk during the period while the fund is accumulating.

It is also recommended that the reserve fund be fixed at M\$15,000.—so as to cover easily the loss on any one building, and that this fund be secured by setting aside \$1,000.— per year for eleven years at 6% compound interest, which would approximate this sum at the end of the period. Further that while the fund is being accumulated it would be advisable to insure the buildings. The Insurance Committee recommends Mr. Paulden, a well known insurance man in Peking, and with whom they have been in touch in working out the above suggestions.

Dr. Stuart was of the opinion that precautions and measures should be taken on the Field for protecting the buildings against fire rather than insuring the buildings with an outside company. In connection with this it was reported that no provision as yet had been made for fire-hydrants.

It was also emphasized that it is most essential to insure the Power Plant.

Mr. Hildabrand suggested deferring the recommendations of the Insurance Committee and getting in touch with another company which he has in view.

GB1529 Voted to approve of the general policy in regard to self insurance, and that temporary arrangements as recommended by the Insurance Committee be deferred until Mr. Hildabrand consults with another company.

### MINUTES OF THE EXECUTIVE COMMITTEE OF

The meeting was held at the President's Office at 2p.m.

Present: - Mr. Galt, chairman and secretary, Miss Ruth Stahl, Dr. Stuart, and Messrs. Chuan and Hildabrand, and Dr. Y.M. Hsieh by invitation.

RADIO FOR THE PHYSICS DEPT: Dr. Hsieh stated that it is desirable to have this erected between the two Science Buildings and not near the Power House as was proposed at the last meeting of the Grounds and Buildings Committee. His objection being that having this structure that far from the Science Buildings it would be difficult to receive clear messages should there be any disturbances in the atmosphere He proposed to have three poles erected, one on the Physics Bldg., one on the Chemistry and one on the Library, thus forming a triangle, and to have nine wires altogether.

This matter was again considered from the architectural point of view, and it was pointed out that this structure would not be so much exposed to view from outside, and would only be seen in this particular quadrangle. After some discussion it was

15 - Veted to leave this matter for further consideration between Dr. Hsieh and Mr. Hildabrand.

MOTOR GENERATOR: Dr. Hsieh raised the question whether the motor generator which was purchased for supplying alternating current to the Physics Dept., could not be considered as permanent equipment. It was reported that the University has no funds for permanent equipment. Mr. Hildabrand stated that he had that morning written to Dr. Hsieh on this subject.

16 - Voted that on receipt of this letter Dr. Hsieh consult with Mr. Galt on this subject.

18 - Voted to ask Mr. Hildabrand to write to the Trustees explaining the reasons why the Gymnasium has been located as it is.

FINANCIAL MATTERS: Mr. Hildabrand reported that the Construction Bureau will need \$33,000.—1.c. between now and the 1st of the year. \$8,850.—1.c. of the above sum is needed to cover balances due or to become due on the following:—Water-Tower, Men's Gymnasium, two Chinese residences, President's House and McBrier Building. \$8,800.—of this sum is required for paying outstanding bills such as the stene—cutter, plumber, electrician, Andersen, Meyer & Co., J.E. Hayes and the American Express Co., tegether with salaries for the last three months of this year. The balance of the \$33,000.— is needed for painting and decorating the interior and exterior of Bashford, exterior of the Library and McBrier, furnishings for the President's Office suite (Bashford) and furnishings for the President's House. \$8,000.— of this is needed to pay the money borrowed from the Power House.

He further stated that we have still coming to us from New York G\$8,000.— which at exchange \$2.15 equals \$17,200.— about \$6,000.—1.c receverable from various departments of the University, and that New York had been advised in a letter dated Sept.5th that additional \$10,000.—1.c. would be needed to carry thru to the 1st of the year.

With reference to the above matters President Stuart asked Mr. Hildabrand to write to him regarding the financial needs and that he will take this matter up with New York.
