Mrs. Williamson, I think, would be ready to cooperate in any way possible, at the time you mention, namely about January 20th and two weeks following that time. I will be in the city at that time, but will be away during the preceding week and would be unable therefore, to give any time to make arrangements, etc. Perhaps you are not counting on us for much in the way of preparing for the luncheon or dinner meetings of the various groups mentioned. I was very sorry indeed to miss seeing you when you were in Chicago some time ago. I made an effort to get in touch with you and Mrs. Williamson at the time appointed for our meeting to say that I was ill and could not come. I understood from Mrs. Williamson when I talked with her afterward, that you had gotten in touch with Mrs. Bush by phone and had made an appointment to meet her. I was hoping that you had realized something from your interview with her. I have not had any reply to the letter I wrote her some time before that. Mrs. Williamson doubtless told you of our effort to get a contribution from her. I am certainly happy over the result of the campaign and think that your plan to follow up with the sort of program that you have outlined will be a very fine thing. My dear Mrs. Avann:

I have been to New York twime within ten days which is the main reason why your letter of January 21st has lain unanswered until now.

The first trip to New York was, as you doubtless know through letters from Mr. Garside, for the purpose of meeting with the special committee appointed to study plans for the new gymnasium. Mrs. Frame was also present as was Mr. Higgins, a member of Mr. Marphy's firm of architects. After we had all spent a good deal of time over the plans and reached certain decisions as to many points, Mr. Higgins took the blueprints home with him and the committee came together again the next morning to go over the plans as he had redrawn them.

I think this work of planning the gymnasium is coming forward very satisfactorily, thanks chiefly to Mrs. Frame's intimate knowledge of the location and the needs of the students. We are proceeding on the understanding that the building can be completed with the movable equipment for \$80,000. Mr. Garside says that McBrier Hall was actually erected within the amount specified for that building, and he hopes that we can have the same experience in connection with the gymnasium. We are naming \$80,000 with the thought that we should reserve about \$5,000 for unforeseen expenses and the other \$5,000 for equipment. A cablegram was sent to the field authorizing the purchase of certain materials before the China New Year, though the plans were not at that time complete.

Now as to the questions you raise about the membership of our Committee. I have been going over the list and feel that we as a Committee have been careless in regard to the time when the term of individual members should expire. As I understand it, the American Board is entitled to three responentatives, the W.F.M.S. to two, the Presbyterian Board to two, and Wellesley College to one. All women Trustees are ex-officio members of the Woman's College Committee. You report that Mrs. Boyd has been made a Trustee so that at present the members of the Yenching College Committee made such through their Trusteeship are yourself, Mrs. Williamson, Mrs.

Boyd, Mrs. Henkins, and I, together with Mr. Warner, Chairman of the Trustees, Mr. Garside, Secretary and Dr. Schell, the third Trustees appointed by that body.

The American Board representatives are Miss Kendall, Mrs. Baldwin and Miss Kendrick when we so elect her. Miss Gouldy is the single W.F.M.S. representative, Mrs Finkey and Mrs. Roys the representatives of the Presbyterian Board, President Pendleton the representative of Wellesley College, and Miss Alice Clark is the only coopted member. In addition to these Mrs. Parlin was in the meeting of November 1926 elected as the special representative of the Transfersy Alumnae.

Williamson in the class of 1931, Mrs. Boyd I judge in the class of 1932 as she has just been elected (please let me know is this is correct), and I in the class of 1930 as my present election is to fill out Mrs. Clark's term. Mrs. Jenkins belongs to the class of 1929 of the Trustees, so she will, I suppose, have to be reelected at the coming Annual Meeting if she continues as a Trustee.

Mr. Warner has just been reappointed by the American Board as one of its Trustees so belongs to the class of 1932. Dr. Schell writes that he must resign, but the appointment of someone in his place pertains to the Trustees and not to our Committee. Mr. Garside continues as long as he is Secretary of the Trustees, I suppose.

Our Woman's College Committee By-laws, Article II, Section 2, provide that members representing mission boards should be chosen for a term of three years. Can you tell me the date of Miss Gouldy's election as one of the W.B.M.S. representatives? Apparently she first sat with the Committee in the November meeting 1926. If it is necessary for her to be reappointed by the W.F.M.S., will you attend to that before the date of the April meeting or at such time as seems to you best? I am writing Mrs. Roys to ask when she and Mrs. Finley were elected as representatives of the Presbyterian Board.

Is it your understanding that President Pendleton continues as the representative of Wellesley College as long as she is President of the College, or should some action be taken in regard to her? If so, by whom? Mrs. Parlin was, as I remember, elected by the Yenching Committee itself to work with the Committee as special representative of Wellesley Alumnae. She also first sat with the Committee at the November 1926 meeting, so I think that our Committee should reappoint her at the April meeting.

At present our only coopted member is Miss Alice Clark who was elected in November 1927 for a term of three years. The Yenching Committee should, as I understand it, coopt one more member at the coming meeting, and I hope that the W.F.M.S. can also before our April meeting have appointed its additional representative. If these two things are done, our membership will be complete, will it not?

Dear Mrs. Lee:

I thank you for the copy of Miss Stahl's letter and also for your own letter. Miss Stahl's letter is full of interest about many things, and of course as you say that part of it which deals with the question of Mrs. Frame's return as Dean of the school is of very special interest to us. I have recently had personal letters from staff members telling me that they were taking this action and hoping very much that Mrs. Finley would be willing to come. I saw Mrs. Frame in Detroit who intimated that Mrs. Frame would probably receive an invitation to continue in her present position permanently. I can see some reasons why Mrs.

Frame might wish to stay here, at least for a while, but I hope the great need of the college for her help for a few years will make its appeal to her and overbalance any other considerations. I think we will certainly want to take action at our April meeting in regard to it.

I am glad that plans for the gymnasium are going forward. I note that you quote \$80,000 as the figure decided upon as the maximum cost of building minus the equipment. I note that the minutes of the Finance and Property Committee quoted the figure a little lower and I think it is well to hold it to \$77,500. They are so likely to run over. It is encouraging to hear that one building was actually erected at a cost not to exceed the amount specified for it.

Just a word in reply to all that you have said concerning the membership of our committee. Yes the numbers you quote as representing boards are correct, and these are appointed for a term of three years. I suppose we as a committee have nothing to do with their reappointment beyond possibly reminding boards that their terms are expiring. So far as our own board is concerned, we review annually our appointments on these college and university committees and in fact we name them annually. Miss Gouldy was elected by our Society in the fall of 1925 and reelected last fall, so her term will hold until 1931 unless we should have some occasion for making a change. I am sorry that we will probably be unable to name our second member of the committee before our meeting in April. Our Mid-year meeting is not held until May and I would rather have the appointment made at a meeting than by a correspondence vote. Mrs. Boyd was made a Trustee last fall so she would be in the 1931 class. In speaking of your own

Aperican Board representatives, you say nothing about Mrs. Lyman. Has her resignation been acted upon? I presume she has or you would have mentioned her. Miss Kendrick is to be put in her place, I judge.

Concerning the co-opted members, we have in addition to Miss Clark, Mr. Bowman. I do not remember just which year it was that Mr. Bowman was elected, but you have the records and can tell. Unless he resigns I would suppose that he would consintue at least until the expiration of his term of three years. We have been remiss, I think, in the matter of re-electing our co-opted members, which means that we have omitted this formality in the case of Mr. Bowman only.

My judgment would be that we have nothing to do with the appointment or election of the representative from Wellesley, and that so long as they name Miss Pendleton, we would simply accept her as a member of the committee.

Miriam Parlin is a member of the committee, but was asked to be the Wellesley Alumnae representative. It was understood that she would sit with us and we have always had her name as you recall, on our stationery. You remember the discussion, I am sure, that we had about that. Mrs. Boyd, I think it was, rather than Miriam, saying that it would be difficult for her to do anything if she did not have this recognition of her standing with the committee.

I am very sorry, indeed, to hear that Dr. Schell is having to resign as a trustee and as a member of our committee. I have always felt that he was a valuable member and the sort that we were glad to have.

Summarizing all of this you see, we have little to do really with the membership of our committee, our only elections being those of the co-opted members. We accept members of our committee from the boards and the ex-officio members from the Board of Trustees. It seems to me it would be well if we could find someone for co-opted membership at this time. Because of our experience of last year, in making a suggestion to the Nominating Committee, that it give consideration to the matter of a co-opted member, I am a bit leary about asking a committee to do that, and perhaps it isn't a legitimate part of a Nominating Committee's business. At least it would be only at the committee's request that a Nominating Committee would bring forward a nomination for a co-opted member. What is your thought about asking a Nominating Committee to do this, or shall the officers of the committee give the matter some serious thought and make some suggestion. Perhaps you have in mind someone that you think would be desirable and valuable on the committee. While my attention is called to the fact that we have co-opted member from each of the Presbyterian and Congregational Boards, I do not think it follows that this nomination should be from the Methodist board unless we should happen to find just the person that we want among our Methodist men or women. I think we want the person who is best qualified for membership on the committee irrespective of denominational affiliation.

Mrs. Williamson and I are going to meet Mr. Bowman next Wednesday and have a talk with him. It seems to be Mr. Bowman's idea that our contingent fund should be kept here. It has set me to thinking and while I am not making it as a suggestion at all, I am not sure that it might not be a feasible thing to have a treasurer of our committee for the purpose of handling just our contingent fund. Anyway I think we might give the matter some thought. If you have any opinion about it, I would be glad to have you express it before we see Mr. Bowman next Wednesday, if that is possible. Our appointment is in the afternoon. Possibly I could get a letter from you if written immediately on receipt of this by Wednesday noon.

Mrs. Williamson and I had a conference with Mr. Bowman yesterday. I think that he will now turn over to the New York office all of the accounts with the exception of the Contingent Fund and \$3000 which the College asked him to invest over here. I suggested to him that he write to Miss Boynton and find out what is their wish with regard to this \$3000 which is invested. I have also suggested to Mrs. Williamson that when she is writing to Miss Boynton that she mention it too, so that we shall surely have a reply when we meet in our annual meeting in case Mr. Bowman should not be able to get his letter off promptly.

We three are quite favorable to the idea of having a committee treasurer for the purpose of handling our contingent fund. That will not be turned over now and we will bring the matter up for consideration and for action one way or the other.

Mr. Bowman did not seem to have any notification of the meeting in April and therefore I surmise that you are not considering him as a member of the committee. However, I think we must consider that he still is a member of the committee. He was co-opted and has not resigned. I do not know when his term expires, but I think we should assume that he is still a member and that he should be notified of the meeting. It is perfectly evident that he still considers himself a member of the committee and I think when you send the notice to him it would be well not to intimate that you had any other idea.

I will be in New York next week and will talk with Mr. Garside about this matter of holding the contingent fund in the committee.

Dear Mrs. Avann:

You or Mrs. Williamson may have received You or Mrs. Williamson may have rece a copy of the enclosed documents in regard to the unmet obligations of Yenching Women's College in the construction work. I found this letter here when I returned from New York. I

wrote Mr. Garside a few days ago asking him what steps he thought should be taken in regard to the settlement of our obligations. I this morning have a letter from him which says in part:

"We have received Dr. Galt's letter of March 7 giving in detail the state of the Construction Bureau accounts with the Women's College. In addition to the deficit in Women's College funds on the field as revealed by Dr. Galt's statement, you will remember that there is also a deficit on our New York records amounting to approximately Gold \$18,000. which has been standing for something more than a year. It seems to me that the only thing we can do is to await the arrival of the Women's College accounts, and to make a careful and detailed study of your funds for report to the Finance Committee, and possibly also to either the full Committee of the Yenching College for Women or at least to the officers of your Committee. The Women's Committee plant deficit on the field and here in New York is a serious handicap to the building operations of the University because there is in all a shortage of about Gold \$35,000.00, so we should take action as soon as a careful analysis of the situation is made and everyone is agreed upon the policy we should pursue. I know, however, that the Finance Committee and the Board of Trustees in general will all be very anxious not to take any actions affecting the Women's college funds until all the ladies are assured that the action taken is in order and is acceptable to the Women's College."

Do you see any reason why the Women's College Committee should not meet these obligations? As far as I can discover, they are just charges and we have understood for some time that there

would be obligations which we must meet from our balance of Building Fund money.

Will you and Mrs. Williamson as you have opportunity go over these lests and let me know your thought in regard to bisiprocedure? Please teturn Miss Stahl's letter and the enclosures to me that we may surely have them for file.

Another letter this morning from Mr. Garside says he has not yet received the books from Mr. Bowman and that he has had no direct word from him as to the date at which he may expect to receive them. Would it be in place for you to telephone Mr. Bowman asking whether he has sent on the books and the money?

Please also let me know whether you agree with me in thinking that the costs of the recent meeting of our Committee should be paid before the permanent fund is set up. Mr. Garside writes that he is holding in suspense the various expense accounts and other items that must eventually be a charge against the women's College Committee.

You will be glad to know, however, that we had a fine meeting with a big rally of young people on Friday night and that I stayed over with my husband's daughter, who lives in Detroit, until Saturday night and had a perfectly lovely, restful day with her and her husband.

You will remember that the Yenching Committee at its recent meeting authorized the Candidate Committee to seek and, on condition that her papers were approved, engage a secre-Miss Kendrick is in touch with a young woman who tary to the Dean. seems to her and to me to be just the right one for this position. Her name is Doris Cummings and she has had considerable experience as a teacher and as a secretary. She is also quite musical. Mrs. Her testimonials are also exceed-Frame has met her and likes her. The papers have now gone on to Mrs. Finley for her apingly good. proval as she is the third member of the Candidate Committee. Miss Kendrick may by this time have them back and in any case, she will have them soon. I feel quite hopeful that she will approve of Miss Cummings as do the rest of us who have met her.

Miss Kendrick has raised with the question of the contract she should sign in case her papers are approved. The necessity of speedy action on Miss Commings' case has impressed upon me the desirability of our getting the revision of the contract made at as early a date as possible.

There are only two major points that should be considered as I see it. First is the question of salary. I understand that your Board has increased its North China salary for single women to \$900 Gold. Our Board has done the same, and I think there is reason in the feeling of the Yenching faculty in general that short-term teachers should not have less. I believe the University has already approved of such an increase and has indicated its judgment that the change should apply to women teachers as well as to men. The figures provided for in the Budget authorized on April 10th are still, however, the old ones, which means a salary of \$840 Gold for the Women going under the Yenching College Committee.

Do you think the Committee can and should increase the salary to \$900 and accept responsibility for finding the difference of \$60. Gold per teacher for the coming school year? I very much wish we might do so. Miss Cummings is declining a very attractive position here in America that she may go to China. She is, I believe,

actuated by a true missionary motive and it seems as though we should be able to offer a woman who is willing to make such a sacrifice a salary that will be somewhat adequate in this day of increased costs.

The other question raised by Miss Kendrick in the contract as it now stands is the provision for travel. She feels, and I agree with her, that we can hardly ask a teacher who has contracted for three years of work and fulfills her contract to pay a part of her own return travel when the Mission Boards pay round trip travel in full for three years of service.

As I have gone over the contract as it now stands, it seems to me that it would be much wiser for us as a Committee to have one form of contract for teachers who go for a termor three years or less and another for those who go for a longer term. In the second type of contract we could then deal with the furlough question.

I am enclosing a copy of the contract as it now stands and a copy of the contract embodying the changes I would suggest. Will you kindly study this matter as soon as you conveniently can and let me know what changes you think should be made? I have told Miss Cummings that a Committee was appointed to revise the contract and that we would have it ready for her as soon as possible.

Miss Veghte signed the contract as it now stands, though she too questioned the fairness of the provision in regard to travel and seemed somewhat dubious about the salary. Am I right in thinking that if the \$900 Gold salary is agreed upon, it should beginning with the new school year be given to all the teachers directly under the Yenching College Committee? In other words, the increase in salary should not be confined to those who sign a contract later than our April meeting.

You will remember that the action taken by the Finance Committee on February 1st, 1929 and reported to us by Mr. Garside was as follows:-"F-2459 VOTED that the Finance Committee give general approval to the proposal of the Committee of Yenching College for Women in regard to the purchase of Residence No.30 by the Men's College at the cost price of Mex. \$17,394.62, and refers with power to a sub-committee consisting of the Chairman of the Finance Committee, the Treasurer, and the Secretary, the matter of financing this exchange, with the understanding that at present any payments made will not exceed Gold \$6,000.00." His comment is as follows:-"It is clear from this action that the Committee intends ultimately to pay over to the Women's College the full amount of Mex. \$17,394.62. At the present time our plant funds are about all expended so I am not sure whether the Committee will find it possible to at once pay over the balance required to complete this transaction which would amount to something over Gold \$2,000. Of course, if it is possible for us to receive from the Women's College in the near future the deficit of Gold \$18,000.00, which we are now carrying on our books, it would greatly simplify our plant funds situation and make it possible to complete this payment, and also to care for a number of other urgent needs. Dear Mrs. Avann:

I am glad to have your telegram saying that you approve of the proposed changes in the form of contract with teachers or other members of the Yenching staff who go under the Committee rather than under thatsion board.

Since I wrote you I have had another talk with Miss Cummings and one with Miss Kendrick. Miss Cummings very much wishes that the Committee would agree to pay travel one way and expect only that the appointee would pay her own return travel in case she wished to withdraw at the end of one or two years. In other words, she objects to my suggestion that if she stays only one year, the Committee should pay one-third of the round trip travel and she herself the other two-thirds. This seems to her rather unjust and even Miss Kendrick seems to feel that it would be better psychology for us to pay the outbound travel for anyone who seems to us a sufficiently good candidate to send. I think, however, that Miss Cummings will agree to the terms suggested if we think this is the right form. Please let me know definitely whether you think the basis suggested is the right basis or whether we should make some change. I will wait a few days longer before asking Miss Cummings to sign the contract. It will be better all around, however, for us to get the matter settled as soon as we rightly can.

She seems to be well qualified for the work and to be very much interested in Yenching. I think too she has the spirit of service and to a degree at least the real missionary spirit. At the same time she hesitates to give up an opportunity in this country which would bring her a much better salary, as she is entirely dependent upon herself. These financial questions have caused her to hesitate and to vacillate between going and not going until both Miss Kendrick and I have wondered a little whether she might be vacillating in her work on the field. I put that question quite frankly to her and she said that she thought that she would not be, that she has through hard experience learned the necessity of thinking things through carefully before she reaches a decision, but that the decision once made, she drops the questions from her mind and gives herself whole-heartedly to her work.

Barbour Blair of Chicago? She is interested in Yenching and has given toward the new plant, though I do not know just what part of it. It seems that she is a friend of Miss Cummings, and when she learned that Miss Cummings was considering work in Yenching, she herself immediately revived a thought she had entertained but had abandoned, that she might go out to the dedication. I today had them both to luncheon with me and I think Mrs. Blair will almost certainly go, probably making the outward journey with Miss Cummings but joining the party of visitors for the return trip. I do not know Mrs. Blair's church connection. From something she said, I judge she lives on the south side.

I hope you are not too tired out with all your meetings.

Because it relates to a number of questions to which we need to find an answer as soon as we can, I am enclosing for you a copy of a recent letter from Mr. Garside. A later letter expresses the hope that I can certainly come to New York for the next Finance Committee meeting, and I have suggested if possible it be held either on May 27th or June 4th or 5th, as I could then go to or return from our National Council meetings in Detroit by way of New York, and thus be present at the Finance Committee meeting at a much reduced expense. If you have wisdom on any of the points raised, please let me have it. Do you see any reason why the Women's College Committee should not pay its obligations on construction account without further delay? These obligations will apparently take a large slice out of the small amount we still have in our Building Fund, but we must pay the debt sometime, must we not? Is there any advantage in further delay?

Dear Mrs. Avann:

On getting back to my desk this morning after my trip to Detroit I found two letters from you both bearing date of May 51st. One relates to the Yenching Women's College building account and tells of the study you and Mrs. Williamson made of the accounts as submitted from Peking and New York.

You say that you and Mrs. Williamson are both convinced that the total amount of the indebtedness of the Women's College to the Trustees is approximately \$18,000 Gold. Since writing that letter you have doubtless had Mr. Garside's letter of May 29th addressed to you, Mrs. Williamson and me in which he encloses a summary of the standing of the Women's College building account and gives our total indebtedness as \$19,007.28 Gold. If you have not already written Mr. Garside as to whether or not you are willing to accept that figure, will you please telegraph him so that he may receive the word sometime Friday, June 7th. As you know, a meeting of the Finance Committee of the Trustees is called for Friday afternoon and I am planning to go to New York for that meeting. I would be very glad if we could at that time report that the Women's College had settled its outstanding debt on approximation account. The summary Mr. Garside gives seems to me to be accurate so far as I can tell.

Your other letter of May 31st was in response to mine about the further needs of the Union Women's Industrial Institute in Foochow. My thought in writing you was not that your Board could probably make an additional appropriation of \$750, but that you might know of some individual or individuals who would be willing to make a special gift of that amount for the sake of getting the work started. Your own suggestion that something might be done as a memorial to Miss Mean Adams seems to me particularly good. You will know better than I whether this idea can be pushed. I surely hope it might.

As to Mr. and Mrs. Williamson's going to Yenching, I am wondering if there is a development that I do not know about. Mrs. Williamson wrote me that although he had hoped that she might go, they Mrs. J. M. A. -- 2

found that it was too expensive and that they had given up the thought entirely. They were hoping that Mrs. Williamson and Ruth might go to Europe next year. It certainly is extremely fine if Mr. and Mrs. Williamson have discovered that they can after all make the trip to Peking.

By the way, you have not, I think, told me who the two women who are to serve on the committee preparing for the dedication are. I would be very glad to know.

Dear Mrs. Avann:

I am this morning in receipt of a letter from Miss Gouldy saying that she is planning to go to Peiping for the Formal Opening in the fall, and that in view of the cost of her own trip and of her many other outstanding obligations, It will not be possible for her to meet any part of the traveling expenses of the new Physical Education Director. This is a disappointment. However, I have just been looking over the budget and find that an item of \$19,028 Mex. has been included in the budget expenditures under the heading of "Contingent Fund." As our Woman's Coblege guarantees its appropriations at the rate of two to one and as exchange in China is at present favorable. there will probably be a considerable credit to the account of the College for year from gain in exchange. Do you not think that we are justified in expecting the budget to meet the travel of a new Physical Director from the Contingent Fund, together with the gain on exchange?

As the salary appropriation for Miss Ch'en, was was at the time of our meeting in April expected to continue, was only \$1440 Mex. and as Miss McGowen's salary will naturally be at the American salary rate, the Committee will have to provide also for a balance on account of salary.

One other question that comes to me in connection with Miss Gouldy's statement that she has decided to go to Peiping is the question whether the Yenching College Committee should make her a formal representative of that body. her a formal representative of that body. In response to a request from Mr. McBrier, the American Board is giving an official statement bearing the seal of the Board to those who are to be its representatives at the Opening. I understand that other Mission Boards are doing the same thing. I wrote President Pendleton a few days ago, asking whether Wellesley College had appointed anyone as its representative, and she replies that the College will be glad to ask Mrs. D. Y. Lin of the class of 1913 to act in that capacity. I have just written her requesting her to send Mrs. Lin an official letter, and I am reporting her as Wellesley's representative to Mr. McBrier. Please let me know whether you think our Committee should to something of the kind in the case of Miss Gouldy.

Dear Mrs. Lee:

I have been at Winona Lake this week in a conference with our Branch officers. I find your several letters here on my return. They present problems that are rather difficult to decide in this way, I mean by correspondence. However, we cannot always anticipate problems and provide beforehand for a way of solution.

I do think, however, that we should have a contract for appointees under the Yenching College Committee who are to be permanent members of the staff and not contract workers. I remember having when we were working on the contract for short term

that thought when we were working on the contract for short term workers but let it pass thinking that when we had a case in point it would be time enough to take care of it. As a matter of fact Miss Wagner's case is only different from the contract workers in that she has agreed to stay a year beyond her three year contract. If the time were not so short and but for the reason that Miss Stahl speaks of, viz., that the number on furlough in 1930-31 would be increased and evidently is already large, I should quite favor her staying another year and then coming on regular furlough. The case then would be analagous to those who have gone out under boards on a regular missionary basis. Have you consulted Mrs. Frame about this? If Mrs. Frame thinks she should come now and have her year of furlough for study, and then return, I am willing to make some arrangement on that basis. I do think as you suggest that she should sign a contract for a term of service after her year of study. As to the amount of furlough allowance I hardly know that to say. You say the American Board furlough salary is \$1000. Our Methodist home salary is \$850. I do not know what the Presbyterian Board pays. Perhaps you might find out and agree to pay something between \$850 and \$1000 which probably are the extremes of that paid by the three. I am quite sure that ours is not adequate and we do allow \$200 in addition to this in the form of an educational grant to those who are studying. Rather it is \$100 a semester. They get \$200 if they study two semesters. In view of what I have just stated, I would be quite willing to make the grant \$1000.

Concerning the swimming pool and the matter of reducing the cost of the symnasium so as to conserve part of the money for maintenance, I really do think that that is a part of our business rhathers than a faculty matter. I think that we do need Mrs. Frame's counsel and advice, and also that of the faculty, but

responsibility of the the decision and what is involved in it does rest with us. I feel that Mrs. Frame's advice was adequate for us and that the decision we have reached should be final. The comments I have had from the field are with regard to the difficulty of keeping the men out of our women's gymnasium pool. It seems to me that that matter could certainly be taken care of. I do not think that Miss Stahl's analogy of a family bath tub is a true one, and in any case I think that the matter of the swimming pool in the gymnasium is certainly a closed one. This answers your question as to whether the extract from Miss Stahl's letter should have further publicity. I certainly think not.

It is rather surprising to learn that Miss Boynton is to stay on the field for service in the Language School. If Miss Cookingham is going, and I too understand that she is, Miss Boynton's going will not seriously affect the work at the College.

I hope that sufficient funds for the building of the Practice House for the Kindergarten-Primary School may be available from some source.

There is one other matter that I should speak of in this letter though I am probably too late to help you any. It is the question of the amount of salary to be written into the contract for Miss Cummongs, and also for Miss McGowen. I trust that this letter reached Mrs. Williamson in time to allow her to get some word back to you before you needed to close the contract. Whatever you have done I will accept. A \$900 salary would be about what our women supported by boards are getting, but I realize that they have some benefits because they are out under boards. They have a constituency that is remembering them in various ways often. I will be interested to know what you did about the salary.

I am glad they have secured a Chinese doctor. . It will be interesting to find how she gets along. I hope it will prove a successful experiment.

For some weeks I have been on the point of writing you concerning the subject on which you wrote under date of January 21st. I had copies made of Miss Lambert's letter which came to me about the middle of this month to share with you and a few others, but the break in the routine of office work caused by the Foreign Missions Conference and other meetings has delayed my getting this off. Since Miss Lambert has sent a copy of the letter to you that need not be included. You have also had a copy of the minutes of the meeting of the Board of Managers so I need not send that.

It is very gatifying to know that the departments of the school are getting organized and the work going forward. It is encouraging too that the C.M.S. have made this loan of buildings to the school and that there is some hope that eventually they may become the property of the school.

The plan that seems to be evolving, intentionally or otherwise, I think is not a bad one, i.e. that each of the boards assume responsibility and support for certain departments of the school. I am thinking that this department of Domestic Science and Child Welfare which they hope our Society will get under, is one in which our women would be much interested. There are certain things that make me rather hopeful that we can and will do this. I am not sure what the attitude of our women will be toward the definite proposition that is made concerning the memorial to Miss Adams. There seems to be something rather fitting in designating the income from the property given to us by Miss Adams to the support of the school as a memorial to her. Whether that is done or not, I am still hoping that we can find some person for the department suggested and assume the support of such a worker.

I think it is quite impractical to try to call a meeting of the Board of Trustees at this time and in fact I doubt very much that the proposition they want our Society to consider would be especially strengthened by having the action on it by the Board of Trustees. I have written to Miss Lambert and also to Dr. Lewis that the matter will be presented to our board when we meet in May, but that I think we will not try to call a meeting of the trustees. I do think when Miss Hurlbut gets back it would be helpful if we could have a meeting when she could bring to us first hand information about the work of the school and some inspiration for meeting its needs. I would think she would be a very valuable member on the board, but that is a matter for your board to consider, is it not?

We shall need to be planning before very long for our meeting in April. The dropping out of the meeting of the China

Medical Board is going to make some difference I suppose, in the plans for these annual meetings. I am wondering whether our British representatives will be over for the Yenching board meeting. You may know that the meeting of the Board of Governors of Shantung University is to be held in London this year. At least an attempt is being made to have the meeting there. In that case I doubt very much that these men will be over for the Yenching meetings, but I presume the annual meetings of Yenching University and College Committee and probably a meeting of the American Section of Shantung will be meeting the same week. I have asked for more adequate time than we usually have had for the meeting of the Woman's Medical Committee in connection with the Shantung Governors meeting and preceding it. We will want to ask that our Yenching College Committee has its meeting prior to the Board of Trustees meeting.

I have not heard just when the Boyds are expecting to be at home but doubt that it will be in time for these meetings. I wish they might be with us. I have not heard from Mrs. Boyd since Christmas time.

There are other matters concerning the college which I might write, but nothing that must have attention at this time.

I have a very small amount to contribute toward the campaign fund and Mrs. Williamson writes me that she has a little, but only a little. I am anxious to hear from other members of the Promotion Committee.

Dear mrs. Avann:

A letter from Mrs. Williamson a few days ago tells me that you are about to start on another trip to the far mast. As I understand \*\*\*E foreign mission to the Board has appointed a commission to the Korean work in particular, but I think that without doubt you will go on from morea to china and perhaps to other fields before you return to America.

I am glad for you to have the great privilege of renewing your first hand acquaintance with the work on the field, and I hope that the work of your commission will not be so difficult and so strenuous as to preclude any rest and refreshment. We shall be sorry enough not to have you with us at the november meeting of our yenching college committee. Some tile please let me know the approximate date of your return and something of the plans for your months abroad. I will not ask you to send me even a brief line during the busy days before you start, but possibly you can get in a little note while on the steamer.

I hope you can visit xenching while in china. I fear Mrs. Frame has not been very happy over the way a good many things are going, and I hope you may be able to have a heart to heart talk with her. If you do, I hope you will also write me confidentially if you wish, as to your impressions. You doubtless do know that the woman's college faculty was greatly surprised, almost dismayed, at the action of our committee and the trustees making the woman's college mxecutive Staff responsible for the housing of all women members of the faculty. Apparently they thought the action taken placed additional financial responsibility upon the woman's college. I have explained to mrs. Frame and to pr. Galt that we took it for granted that the department having the use of a secretary, clerk or helper of any kind would meet the cost involved in housing her. I also explained that feeling was that if the woman's college committee

Mrs. J.M.A. -- 2 were obilged to approve every candidate sent for any position, secretarial and clerical as well as teaching, we hoped to be able to lessen, even eliminate the misfits. one of the difficulties as I understand, has been that young women going for clerical or secretarial positions have felt no responsibility for the social and religious life of the students. They work from Bisell. to 5 P.M. and then feel that they are entirely free to do as they please. The result is that they lead rather a gay life and their influence over the students is often not what is desirable. Miss Kendrick and I feel that we can do a great deal to prevent this state of affairs by explaining to every possible candidate the missionary character of the institution and our feeling that every staff member maratter what her type of work, should carry her share of responsibility for the moral and social wellbeing of the student body. I have not yet heard from Peiping in reply to these letters. I told Mrs. Frame that if, after they had betteru understood our thought and had again talked conditions over, the Woman's College faculty still felt that our action placed on them an almost impossible burden, she should say so frankly and request reconsideration of our action at the November meeting of the committee. Possibly we will all have reached a satisfactory understanding on thas matter before you get to reiping, but I felt that you should know of the correspondence that has passed. You will doubtless also visit Foothow will you not? Dr. Lena G. Pyer, our American physician in our women's hospital in Foothow, has just reached America for a furlough year. She was in Boston with us yesterday, and we had some talk on problems connected with the development of the proposed Union Hospital. So far as I can tell some of the lions in the way of that development are disappearing. If, as you study the situation, you have suggestions of any kind, I would greatly value having them. I know how very busy any Board Secretary is as she visits Mission stations, so do not expect you to write long letters. Dear Mrs. Avann:

I am in correspondence with Mr. Garside as to a date for the November meeting of our Yenching College Committee. I understand that a meeting of the Trustees is to be called and the natural plan will be for our Committee to meet one day and the Trustees the next. November 3 and 4 are suggested dates, but the final word has not come from Mr. Garside. As soon as it does I will write the members of our Committee.

The purpose of this letter is to ask what progress if any has been made by the W.F.M.S. in securing a teacher of household economics for Yenching. I have had a letter from a Miss Miriam F. Clarke, 49

Daniel Avenue, Rutherford, New Jersey. She is a Methodist, a graduate of Mount Holyoke College and has had some graduate study in Yale. She was an assistant in Physiology in Mount Holyoke, 1924-26, and instructor in Physiology at Western Reserve University, 1926-29, and a student at Yale in Physical Chemistry, 1923-24 and 1929-32. She will be ready to go to the field in the summer of 1932. She is prepared to teach Home Economics, especially nutrition, etc., physiological chemistry, and thinks she is prepared to be the head of a department. She gives her purpose in wanting foreign service as her "desire for a unique opportunity to teach in an institution of high purpose and standing."

I remember that you or one of the W.F.M.S. secretaries was in correspondence with a Miss Eckert. If that appointment is going through you will probably not be interested in Miss Clarke, but I felt that you should at least know of this possibility. We should of course, need to learn more about Miss Clarke, especially perhaps her Christian experience and purpose, but she seems to have had very good training and also to be deeply interested. I am right, am I not, in my understanding that the W.F.M.S. has assigned Miss Mary Katherine Russell to at least part time work in Yenching this year? That is fine, but I do hope we can get a permanent person for the Household Economics work not later than next summer.

Dear Mrs. Avann:

Thank you for your letter of October 3rd in response to mine about a Home Economics teacher for Yenching. Very likely the young woman I named Eckert is the Miss Eikworth of whom you write. About the time I wrote you I wrote also to Camilla Mills Biggerstaff who is now in Cambridge, telling her what I knew of Miss Miriam F. Clarke. In reply she writes as follows:

"She has had very excellent scientific preparation apparently but as I see it we need someone there who is prepared to teach the more general phases of Home Economics - Child Care and Development, Household Management, applied art work, etc. This is particularly true if Ch'en I does not remain longer than this year - and if Lan-chen Kung. who is working for her Ph. D. in Nutrition at Columbia, goes back this next summer as the plan has been to have her. Lan-chen is primarily interested in Nutrition and the allied subject matter so that she and Miss Clarke would be interested in precisely the same thing."

This may help you or any of your W.F.M.S. secretaries who are trying to fill the position. I do not know Lan-chen Kung, but if as I understand the facts she is a student in Columbia, we can perhaps get in touch with her when we are in New York.

Yes, I discovered when I got back to the hotel from my dinner engagement that you had gone. I was later getting back than I expected to be and though I was sorry not to see you again, I was really glad that you had not waited up for me.

If she still thinks that it is better for her to wait until May to return we shall, of course, use her, but would not think of detaining her if the way were clear for her to go.

I trust Cincinnati Branch will not detain Ruth Stahl on account of the lack of funds to send her back. If she is physically fit to return I sincerely trust that Cincinnati Branch will be able to meet the expense of her return. I shall write to her secretary this morning urging it.

I have felt that our meeting in New York in the interests of the colleges in China was really very worth while. I suppose I shall be going to Atlantic City for the Foreign Missions Conference. I am planning that way though I am sorry to make another trip and to be away from home and my office for another period. I shall look forward to seeing you there.
