My dear Mr. Hawkins:

We have just received a letter from Dr. G. A. Johnston Ross,
dated September 15th in which Dr. Ross writes as follows:-

"My wife and I have recently made a decision which will involve my absence from New York for practically three quarters of the year. We propose to make our home on Oaten, Hawaii.
"This means that my resignation from the Board of Trustees becomes urgently necessary, that some one may be appointed who can discharge the duties efficiently. I do not know even the duration of my appointment, nor the steps which I should take to lay down my office in proper form.
"I shall be greatly obliged if you would set me right on these matters; and, if it be open for you to do so, if you will present my resignation to the Trustees, with an expression of my regret that I have been unable to render effective service.

According to our records, Dr. Ross is a representative of the London Missionary Society in the class of 1928. I believe that if his resignation is accepted his successor should be elected for the class of 1932. We are hoping to have a meeting of the Peking Trustees this fall, probably the latter part of November. I am not sure whether arrangements for choosing a successor to Dr. Ross could be completed in time for that meeting. If so, we would invite his successor to be present at that time; otherwise, we might ask Dr. Ross to continue in office until that meeting. We should at least have his successor appointed well in advance of the annual meeting of the Trustees which will probably be held sometime in April 1929.

Dear Mr. Garside,

I write to thank you for your two letters of the 19th instant and for the accompanying draft for £125, which we have put to the credit of the Yenching University, and out of which we are defraying the expenses in connection with Miss Dora Bent. I enclose our receipt for the draft. With regard to any balance there may be, would you like us to return the amount, or would you wish it to be placed to your credit to be available for any similar kind of expenses in the future? We will do whatever you desire in the matter.

Miss Bent is starting for China to-morrow morning. I was present at a large gathering in Erdington, Birmingham, last week to take farewell of her, and it was very satisfactory to hear the ^{up} high testimony to her, and I am very hopeful that she will be able to render exactly the kind of help at Yenching which is most needed.

Referring to what you say with regard to Dr. Johnston Ross, I saw an intimation in the newspapers this morning that he was about to take up his residence in Hawaii, and realised that this would involve his resignation as a Trustee of Yenching. Unfortunately your

letter arrived just two days after the meeting of our China Committee, held on Tuesday, when we should have accepted his resignation and nominated a successor. Nothing can now be done until the next meeting of our China Committee on the 23rd proxime, and meanwhile I am anxious to find some suitable person for nomination for this position. We would much prefer to appoint somebody in New York who could attend the meetings. I should be very much obliged if you could write to me in time for the letter to arrive before the 23rd proxime, with any suggestions you may be able to make in this connection, after consultation with anyone who may be available. Unless we can find some suitable person in, or near New York, I am afraid there will be no alternative but to appoint someone in this country, with the probability that he would seldom be able to attend the meetings. Naturally we want to make our representation on the Board of Trustees as effective as possible. The only suggestion that occurs to me at the moment is that we might ask Mr. Jefferson, of the Broadway Congregational Church, to accept the position, and unless I am able to think of any more suitable person I propose to nominate him, but I shall be very grateful if you can make any suggestions which I might bring before our China Committee. Kindly make an effort to write to me as soon as possible. If an appointment is made on the 23rd proxime, notification of it could get out to New York in time for whoever is appointed to attend the meeting in the latter part of November.

Dear Mr. Garside,

I have to thank you for your letters of the 12th and 18th ultime, which arrived on the 19th ultime and the 1st instant. I have read the Minutes of the Committee of Yenching College for Women, and the accompanying papers, with deep interest and am much obliged to you for passing them on to me. I presume they will come up for consideration by the Yenching University Trustees at an early date. I will only express the hope that nothing should be done in a hurry. It is no doubt well to coordinate the administrative work of the two Colleges, as far as possible, but I trust that no proposal for complete merger will be carried out without the fullest consideration. Apart from the arguments used by the Women's Committee, in many of which there is considerable weight, I cannot help feeling that if that Committee ceased to exist the work at Yenching as a whole would lose a good deal of financial support which otherwise might be available for it. We owe much to the work and interest of that Committee, and I should be sorry to see it merged in the Board of Trustees without their very careful

My dear Mr. Hawkins:

We acknowledge receipt of your two letters of September 27th.

We are glad to have the amended form of resolution consenting to the suggested changes in the Constitution, Charter and By-laws of Yenching University. You will be interested to know that the New York educational authorities have now formally approved the amendments in the University's Charter.

We are happy to know that Miss Bent has now begun her journey to Peking and that all of you are pleased with the reports of her you have been receiving. With regard to any balance you may have in hand from our remittance of \$125. after you have defrayed all expenses in connection with Miss Bent's outgoing, I would suggest that the simplest procedure would be for you to return such a balance to us. It is quite likely that such a balance will be very small and I believe it will be a simpler to close the matter by returning it to our office rather than for both you and us to keep the account open on our books for use at some indefinite date in the future.

As regards the appointment of a successor for Dr. Johnston Ross, I am quite certain that everyone would heartily welcome the addition of Dr. Charles E. Jefferson to the Yenching Board of Trustees. I cannot at this time make any suggestions of other possible appointees but will take up the question informally with Yenching Trustees as I have an opportunity to meet with them. If action is taken at the meeting of your China Committee on the 23rd of this month, as I hope may be the case, we shall probably not have time to get any further suggestions to you.

No date has yet been set for a fall meeting of the Yenching Trustees although we are still considering that such a meeting should be held the latter part of November. Within the next week we will be undertaking definite plans for such a meeting.

I am much obliged to you for your kind letter of the 3rd instant with regard to the formal dedication of Yenching University in the first week of October next year. I feel sure the London Missionary Society will wish to send a delegation to the opening ceremonies, but I am afraid it will have to be one from China itself. I have no doubt our Directors will appoint the Rev. C. G. Sparham of Shanghai, the Secretary of our China Council, as a member of the delegation. As far as I can see it will be impossible for us to send anyone from this country. I should naturally be selected, but I am only recently back from a visit to China and it would be out of the question for me to consider the question of going there again next year. I am afraid the only large donor in this country is the L.M.S. who as you know have made a large capital contribution towards the buildings. I sincerely hope you will be able to get a large delegation. I do not know how many L.M.S. people from China you would like to form this delegation apart from Mr. Sparham, but I expect we shall have no difficulty in arranging for the Rev. T. Cocker Brown who at the end of next year succeeds Mr. Sparham as Secretary of our China





I write to thank you for your letter of the 27th ultimo with regard to the formal dedication of the Yenching University in the first week of October next year. I have already written to Mr. McBrier on the subject, but since I did so it has been found necessary for the Secretary of our China Council to return to this country in April. I have no doubt our Directors will appoint as their representative his successor, the Rev. T. Cocker Brown, at present in Amoy. In February he will be removing to Shanghai, where his address will be, London Mission, 23, Yuen Ming Yuen Road, Shanghai. We have asked our China Council to suggest other L.M.S. persons who might be invited, and I will let you have their names when I receive them. In any event I should like invitations sent to our missionaries in Peking. Of course such of them as are on the staff at Yenching will be invited in that capacity, but apart from them there is Mr. E. Shilston Box, Rev. W. F. Dawson, Miss Gladys Meech, Miss Carol Leinwood, all of London Mission, West City, Peking, and Dr. Bernard Read and Mr. G. G. Wilson, both of the Union Medical College.

I am very sorry that it will be quite impossible for me to be present; as you know I was in China this year, and cannot possi-

contemplate another visit next year. I am not aware that any L.M.S. people from this country are likely to be in China in the fall of next year, but if I do hear of anyone I will let you know.

Many thanks for the Minutes of the Yenching Trustees Meeting of the 16th ultmo, which arrived with your letter.

Dr. Wallace arrived last week, and we have provided a full programme for him. I have already been at five of his meetings, (and presided over three of them). He is making an excellent impression, and I am quite sure his visit will be most useful. He is leaving by the LEVIATHAN a week today and you will no doubt be seeing him as he passes through New York. He will be telling you of our discussions here as to the most practical means of co-ordinating action at the home base of the Union Universities, as between New York and London. We propose that our "China Group," which consists of the Secretaries of British Boards having work in China, should be re-constituted so as to form a Group on this side similar to your Committee on China Union Universities in New York. Owing to the existence of the Atlantic it is not easy to secure effective cooperation between these two Groups. It is suggested, however, that there should always be an interchange of Minutes, and that a certain amount of personal contact may be secured, if Dr. Blair and I, who between us are interested in five of the Union Universities, should take advantage of our annual visit to New York in the second week of April, to meet

with the New York Committee, and that when larger Groups of the representatives of British Societies have occasion to go to America (and ~~the various~~) other joint meetings might be arranged. I shall be in New York for the second week of April next year, probably from the 6th to the 13th. Six representatives of British Societies may be passing through New York early in July next year on their way to the International Missionary Council Meetings at Williamstown, to be held from the 11th to the 21st of that month. These consist of the Bishop of Salisbury (Missionary ^{of the Church of England} Council), Rev. Wilson Cash (General Secretary of the C.M.S.,) Mr. Macleman and myself (British Conference of Missionary Societies and L.M.S.) Mrs. Fergan (United Free Church of Scotland) and probably Mr. G. E. Wilson of the B.M.S. It may be thought desirable to arrange for these six to meet the New York Committee, but this is a matter we can discuss when I see you in New York in April.

I was intending to write to you early in the New Year with regard to the University meetings in New York in the second week of April. My fixed Meeting is the P.U.M.C. one on Wednesday, the 10th April. I should be very grateful if you could, in consultation with the other Secretaries, get the dates of the Meetings of the Yenching, Shantung and Lingnan Groups fixed for the other days of that week, and, if the suggestion commands itself to you, a meeting of the New York China Union Universities Committee. I shall make no engagements for that week in New York until I have

You are already quite familiar with the actions taken by Yenching University and Shantung Christian University in regard to the proposals for the coordination of Christian higher education in China. In order, however, to bring this matter formally before the London Missionary Society we quote below the actions of the Boards of these two Universities. We request that you take whatever steps you feel will bring this program before the London Missionary Society in the way that will cause it to receive the most thoughtful and sympathetic attention.

Action of Shantung Governors on Nov. 21st

"NAS-109 VOTED that the North American Section expresses its hearty approval of the general principles underlying the program for the correlation of Christian higher education in China, and records also its warm approval of the general proposal that within this program Shantung Christian University shall continue and develop still further its purpose of emphasizing the training of leaders in the fields of teaching, evangelism, medicine, nursing, and other social and religious service in the towns and smaller cities and the rural districts of China;
that the Section requests the Field Board of Managers to make recommendations as to the place of the University in the Correlated Program and the details of its participation therein; and
that the Section refers the Correlated Program to the various mission boards cooperating in the University for their information and for their recommendations"

Action of Yenching Trustees on Nov. 16th.

"T-2382 VOTED that the Board of Trustees of Yenching University record their approval in principle of the general

plan for the correlation of Christian higher education in China and that the Secretary ascertain from the Board of Managers their reactions to the plan and to the details as they affect Yenching University."

Some days ago we sent you a copy of the Minutes of the Yanching Executive Committee Meeting on December 3rd. We would particularly call your attention to Action F-2401 as follows:-

"VOTED that, although pending further action by the Board of Trustees, Article IV, Section 1, of the Constitution as adopted April 10, 1924, defining the composition of the Board of Managers is being retained as Article VII, Section 1, of the Constitution, the Board of Managers be authorized to continue for the time being under the organization set forth in the By-Laws of the Board of Managers as approved by that Board at its meeting on September 22nd, 1928; and that the Secretary be instructed to transmit to the Mission Boards cooperating in the University, with a request for their approval, a statement of the revised composition of the Board of Managers as set forth in their By-Laws referred to above; with the understanding that the Board of Trustees will be asked to take final action on this revision of the composition of the Board of Managers at the annual meeting in April, 1929."

The new composition of the Board of Managers referred to in this action is as follows:-

"Section 1. There shall be a Board of Managers in North China, to be composed of not to exceed twenty-one members.

Section 2. The Board of Managers shall be constituted in accordance with the following provisions:-

a) The bodies which founded the University shall

appoint, according to a process mutually agreed upon, eight members.

- b) The University faculty shall appoint five members as stipulated in its own by-laws.
- c) The above constituted members shall elect additional members to the Board from the country at large provided that the membership of the Board shall not exceed a total of 21.
- d) At least one-fifth of the Board of Managers shall be women and a majority of the Board shall be Chinese, preferably those living in and near Peking.
- e) In filling vacancies consideration shall be given to graduates of the University.
- f) An essential and the sole religious qualification for membership shall be profession of evangelical faith in and loyalty to Jesus Christ.
- g) The term of office of the members of the Board of Managers shall be for such periods as shall be provided in the By-Laws of the said Board and approved by the Board of Trustees.

Section 3. The Chancellor of the University shall have the privilege of attending meetings of the Board and of taking part in all discussions, but without the right of voting."

By comparing this proposed composition of the Board of Managers with Article VII of the Constitution of Yenching University, a copy of which was attached to the Executive Committee Minutes of December 3rd, you will notice the changed proposed. In general it may be said that the total membership of the Board is reduced from approximately 30 to approximately 21. The representatives from the cooperating Mission Boards is reduced to 8 members. Representation from the faculty is increased from 3 to 5, and number of coopted members is increased to 8.

We would appreciate very much your kindness in seeing that this proposed change in the composition of the Board of Managers is brought to the attention of the proper body in your Board. We sincerely hope that all the cooperative Mission Boards will find

I now write to let you know that at a meeting of our China Committee held last week, Dr. A. L. Warnshuis, of the International Missionary Council, 419, Fourth Avenue, New York, was unanimously appointed a representative of the L.M.S. on the Board of Trustees of Yenching. I think this appointment will be quite satisfactory to you, as it will bring on to the Board someone living in New York, who will be able to attend the Meetings, and I feel sure will give valuable help. I shall be very grateful for any suggestions.

Dear Mr. Garside,

I have read through the Minutes of the Committee of Finance Property and Investment of Yenching of the 4th December, and I was specially interested in the Minute with regard to the insurance of the University buildings and library. I believe I can arrange for you to affect a fire insurance on all the buildings, library, furniture and equipment on much more favourable terms than those indicated in the Minutes.

For many years past all the foreign property of the L.M.S. has been insured against fire with the Alliance Assurance Company, one of the oldest and wealthiest of the English insurance companies, at a flat rate which works out at about 1/9 per £100 sterling. This policy, which is for about three-quarters of a million sterling covers all foreign properties from thatched houses in Central Africa to steel and concrete buildings in other parts of the World and includes an insurance of the missionaries' furniture in all our buildings. When I was in China in 1921 I discovered that the Shantung University were paying a high insurance premium on their buildings. I cabled to the Alliance asking if they would accept the risk at L.M.S. rates for an insurance of £150,000. Within forty-eight hours I had

a cable from them that the property was covered for this amount. The British & Foreign Bible Society and the Wesleyan Missionary Society insured all their foreign property at the same rate. It might be worth your while to consider such an insurance for Yenching, and if so I shall be glad to send you further particulars, or to arrange for the Alliance to do so. What we do is to insure all our missionaries' furniture for the first £100, and if they want to increase the amount of the insurance they are at liberty to do so at the same rate of 1/9 per £100. I, of course, have no pecuniary interest in making this suggestion, but I should be glad to act as an intermediary if you think it worth while to consider the matter further. The condition the Alliance would make would be that all the property at Yenching should be included, and not selected items only. I may add that we have had a good many claims under our policy, and in every case the Company has taken our word for the loss without making any independant enquiries. Only a few days ago I sent to Tsinan £900 for the loss by fire of one of the houses there. When I gave them particulars of the loss they remitted the amount within two, or three days.

Dear Mr. Garside,

I have to thank you for your letter of the 17th instant, which reached me on the 22nd instant, with regard to the action of the Shantung Governors and the Yenching Trustees as to the proposals of the Correlated Program for Higher Christian Education in China. We had the pleasure of a visit from Dr. Wallace to our China Committee the week before last and the Committee expressed itself as heartily in favour of the plans of co-ordination proposed, and generally approved of the policy outlined in the program, and referred it to our China Council in Shanghai for consideration and report. Dr. Wallace did not ask us to do more than that as the program was to be further considered by the Council of Higher Christian Education in China next July. We shall have the views of our China Council on what is proposed long before that meeting. I have no doubt that as far as the institutions in which the L.M.S. is interested the program will be accepted. //

I also have to thank you for your letters of the 14th and 15th instant, which arrived on the 24th instant. It is immaterial to me whether the meeting of the Trustees in April is held on Tuesday, the 9th, or Thursday the 11th, so long as it does not clash with the

I find that I have not formally acknowledged your letter of December 7. Most of the items you discuss in this letter I have already covered in other correspondence, but there are one or two matters on which I should write further.

I have quoted to Mr. McBrier what you say in regard to plans for having some representatives of the L.M.S. at the formal dedication of Yenching University next year. We are all very sorry indeed that it will not be possible for you to attend the dedication yourself.

We are glad to have your comments on the steps being taken in England for helping along the program for the co-ordination of our Christian higher education in China. I certainly hope that it will be possible for you to organize in England a group somewhat similar to our Committee for Christian Colleges in China here in New York. Our American group will always be anxious to cooperate with you in every way, particularly through the interchange of minutes and informational material of various kinds. It should certainly be possible to arrange some meeting of this committee next July when the six representatives of the British Societies are here in New York. We will not attempt to make any final plans however until I have a chance to discuss the matter with you in April.

I have already written to report on the various Board meetings we are arranging for the second week in April.
