Many thanks for your cable of the 2nd instant received here  
on the same day. It reads as follows:-

SUGGEST MEETING CHINA COLLEGES CORRELATION

JULY EIGHTH NINTH TENTH.

We will arrange for such of the British representatives on the International Missionary Council Committee, who are likely to be interested in the Meeting of the China Colleges Committee to be held on the 8th, 9th or 10th July, to be informed at once. In addition to this Meeting there are two other Meetings which it may be convenient to hold in New York on one of those days. The first is a Meeting of the African Literature Committee, as to which Mr. Kenneth MacLennan will be corresponding with Dr. Donohugh, the Chairman of the American Committee, and I have suggested to Mr. MacLennan that he should ask Dr. Donohugh to communicate with you before fixing the date of that Committee. The second one is a possible Meeting of the Provisional Board of Founders of the Central China University, as to which I heard from Dr. Wallace this morning. You would, of course, arrange for these three Meetings, if they are held, not to clash. I propose to leave for New York on the 29th June, which will give me three or four days there before going on to Williamstown.

I thank you for your letter of the 19th February with regard to Yenching, and for the copy of the Minutes of the Board of Managers accompanying it. I am glad to hear that Dr. Wu has accepted the position as Chancellor of Yenching.

Referring to Miss Linehan's letter of the 19th February, I will get the formal approval of our Board to the proposed changes in the Yenching By-laws, at the next meeting of our China Committee on the 26th instant, and will then write further.

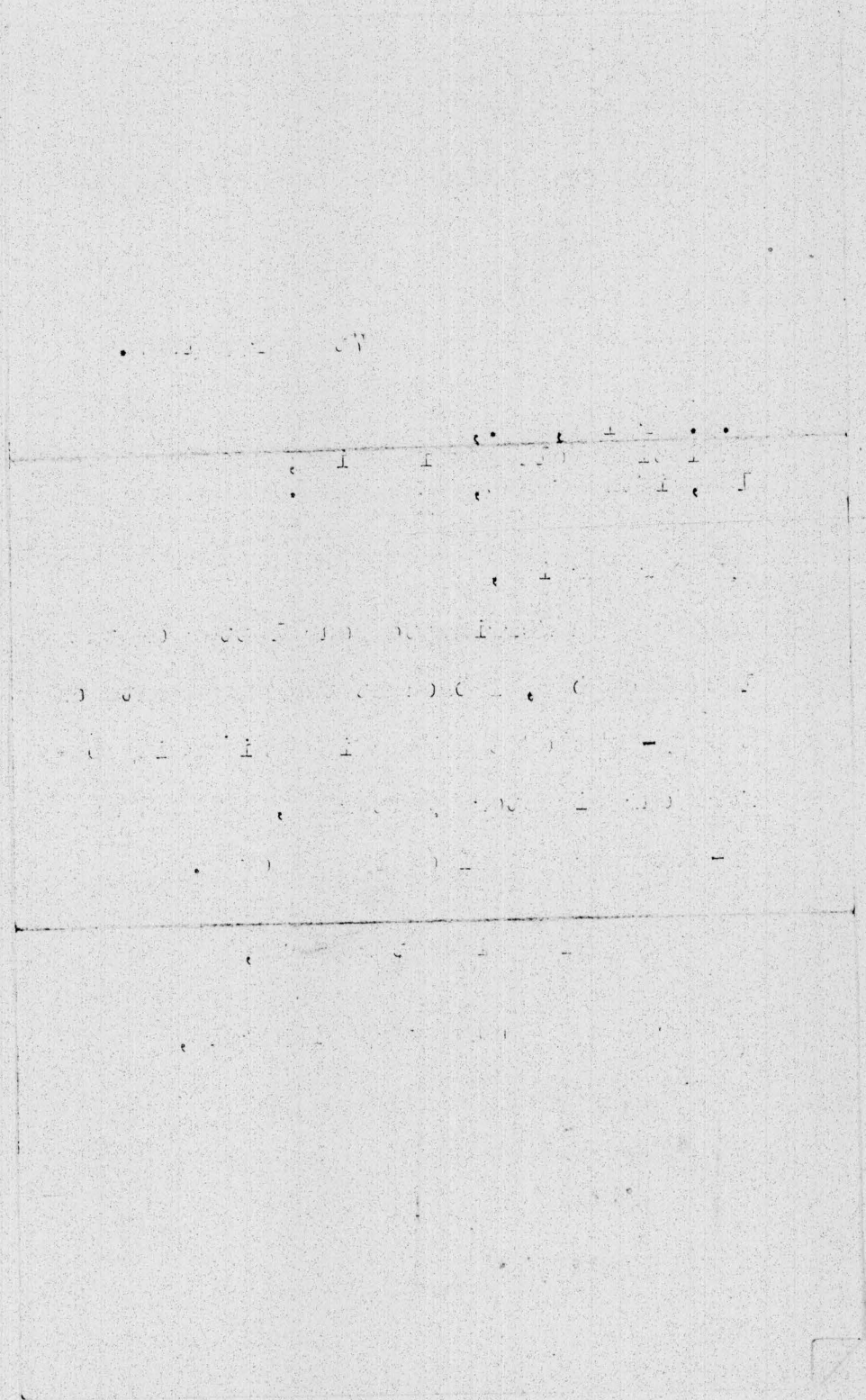

Herewith we are sending you a copy of the docket for the meeting of the Board of Governors of Shantung Christian University.

You will note on this docket that under the item of changes in the roster of the Board we have queried the term of Dr. Wigfield. According to our records Dr. Wigfield was formerly a representative of a cooperating Society in the class of 1929, but in 1927 we understood that the British Section coopted him. The roster of membership for the Annual Meetings of the 1927 and 1928 meetings of the Board of Governors listed him in the class of 1931. The minutes of the meeting of the British Section held on March 22nd make no reference to Dr. Wigfield. Do we understand that Dr. Sparham has succeeded Dr. Wigfield? We also noted that Miss M. B. Referring to my letter of 30th April with regard to Mr. W. Band, I have now heard from him and find that during my absence in America he cabled to Mr. Tayler accepting the position at Yenching. His testimonials seem to be very satisfactory and I have heard from two or three quarters to-day with regard to him and he seems to be an excellent man for the position, and I am therefore proceeding with the arrangements for his going out. My dear Mr. Hawkins:

This will acknowledge receipt of your letters of April 30,  
May 2 and May 7.

We very much appreciate your services to the University in  
arranging for the outgoing of Mr. W. Band. I will send you a check for  
£100. within the next fortnight. We are arranging for a meeting of the  
Committee on Instruction of the Board of Trustees to give formal approval  
to Mr. Band's appointment, although I am not sure that, under the circum-  
stances, any action by this Committee is necessary. I know they will  
heartily endorse the invitation sent Mr. Band by Dr. Stuart, particularly  
in the light of your favorable report concerning him.

We are enclosing herewith three copies of candidate applica-  
tion blanks we use in securing information regarding applicants for posi-  
tions at our various China colleges. Mr. Band has already sent us such an  
application form giving full information regarding himself so nothing fur-  
ther will be necessary in his case. I am sure, however, that you will be  
glad to have these forms available in your office for use in future.

We are grateful for your remittance of \$58.63 (£12.1.6), the  
balance due the University on account of Mr. Mervyn Armstrong and Miss Bent.  
If any other disbursements on either of these accounts are brought to your  
notice please let us know and we will reimburse you at once. Your letter  
of May 7 states that you will be paying Mr. Band from the remittance we shall  
send you the \$250.00 allowance for his first outfit. You do not make any  
mention of our sending you anything more than the hundred pounds asked for  
in your letter of May 2. I am wondering, however, whether you will not  
need more than one hundred pounds to cover Mr. Band's outgoing expenses and  
pay his first outfit allowance. If so, please let me know how much more  
will be needed and we will remit promptly. Since the \$250.00 outfit allow-  
ance is being given Mr. Band I presume he is going out to the University on  
a five year contract rather than the three year short term appointment, as  
short term appointees are given no outfit allowance except furniture provided  
in Peking or, in lieu thereof, a furniture allowance of Max. \$200.00 for pur-

I am enclosing herewith a draft for £100. to cover Mr. Band's outgoing expenses. I am sorry that we have been delayed in sending this remittance to you. I had hoped to have formal action from the Board of Trustees some time ago appointing Mr. Band as a member of the Yenching staff and authorizing us to advance his travel expenses, but this action has been delayed and was formally completed only yesterday.

The Committee on Instruction and the Executive Committee of the Board have been quite satisfied with Mr. Band's papers and the evidences of his training, professional qualifications, and Christian character. Dr. Scott was somewhat critical of the statement of Christian experience appended by Mr. Band to his application and voted in favor of his appointment "subject to Mr. Hawkins's satisfaction as to Mr. Band's evangelical faith." I attach hereto a copy of Mr. Band's statement of Christian experience in case you may not have seen it before. Both the Committee on Instruction and the Executive Committee have such entire confidence in your judgment that they know Mr. Band is the man we want for Yenching if you are willing to recommend him as I understand you are. It will not be necessary for you to delay in any way the plans for Mr. Band's journey to Peking for the formal action of the Trustees was simply one of approval of his appointment. The question raised by Dr. Scott is brought up quite informally.

I find I have not acknowledged your letter of May 22 in which you request that we ask Dr. Warnshuis to attend, on your behalf, any future meetings of the Committee of Central China University. We will be happy to have Dr. Warnshuis's presence at such meetings and will see that he is always invited to attend.

I have this morning received Mr. Evans letter of the 20th instant with regard to Mr. Band. I should in any event have been writing to you today about his journey to Peking. Immediately after my return from America I received on the 31st ultimo a cable from President Stuart as follows :-

"Band avoid delay as much as possible Siberia if possible  
we would suggest the advisability of provisional reservation  
via Canada"

When I reached Plymouth I had the news that the Siberian route to China via Harbin was suspended. I thereupon arranged for Mr. Band to travel via Siberia to Vladivostock which avoids Manchuria, and I found that it had been arranged that Miss Cochran was to travel with him by this route. First of all I booked him to leave on the 3rd September, but this was afterwards altered to the 10th to fit in with Miss Cochran's arrangements. We heard this week that Miss Cochran would not be travelling via Siberia. Mr. Band's parents thereupon raised strong objections to his travelling alone by this route and I think they were justified. With considerable difficulty I have secured a passage for him via Vancouver leaving tomorrow.

He is due in Yokohama on the 23rd proximo, so that he will actually get there some days earlier than if he travelled via Siberia.

He has been very good in making all his arrangements to leave at forty-eight hours notice. Travel by this route will, of course, be rather more expensive, but in view of President Stuart's cable in which he suggests the Canadian route I had no hesitation in booking him that way. When we know what the total cost amounts to I will send you an account of the payments on his behalf.
