



My dear Mr.Diamond:

In accordance with the request in your letter of February 26 I am sending you herewith a schedule of salaries and allowances of University supported Western staff at Yenching University.

At the present time the whole question of salaries and allowances at Yenching is being restudied both on the field and here at the home base. Not only is the amount of salaries and allowances being considered, but study is also being given to the question of whether salaries should be paid in gold amounts or in local currency amounts.

In addition to the regular salaries as shown on the attached schedule, the Board of Trustees of the University has granted a special supplementary allowance of 12-1/2% of the basic salaries during the fiscal year 1929-30 to compensate for the unusually low value of Chinese silver currency.

For several weeks I have been intending to write you for information as to salaries and allowances of missionaries of the London Missionary Society serving on the staff of Yenching University and those living in the North China area. The Yenching Board of Trustees will wish to have full information as to the salary and allowances schedules of all the cooperating Mission Boards as a basis for any changes they may make in the University schedule. I would appreciate it if you would send me full information as to your salaries, allowances and method of meeting problems arising from fluctuations in exchange. I hope that a special committee appointed to go into these questions of salaries and allowances will have a report ready for the annual meeting of the Yenching Trustees on April 22. We do not have a great deal of time to complete our work on these problems so I hope you may find it possible to send this information without delay.

My dear Mr. Hawkins:

Let me acknowledge receipt of your letter of March 21. I have also received Dr. Weir's letter of March 22 with which he enclosed a mimeographed copy of Miss Miner's letter to Mrs. Carr.

I feel that the British Section has done the wise thing in waiting until your meeting on April 24 before taking any further action in regard to the various problems at the University, particularly the question of reorganization and registration of the Arts College. In reporting by cable to the British Board the actions taken by the Executive Committee of our North American Section, we had no thought whatever of urging the British Section to take similar action or, for that matter, to take any action whatever. The report was made simply because we considered it both courteous and desirable to keep the British Section fully informed of what the North American Section was doing.

I have been interested to note in later correspondence from the field that while our Cheeloo delegates were in Shanghai at the Council of Higher Education meeting they consulted with the Ministry of Education concerning registration at Cheeloo. Evidently the Minister of Education encouraged the University to go ahead with registration of the Medical School separately, leaving the registration of the Colleges of Arts and Science to some undetermined date in the future. It is difficult to estimate from the brief mention made of this discussion just how fully the Minister of Education was informed of the actual situation at the University and the quality of work being done by the Colleges of Arts and Science, and how far he was influenced by the hostile and unfair reports made by the Shantung Commissioner of Education. I am sure everyone will agree that our home boards here in the west can only fall in with the procedure recommended by the field board in matters of this kind. About the only thing we in the West can do is to take such steps as are necessary to convince ourselves that the actions proposed represent the mature judgment of the field authorities, reached after all the factors in the situation have been given careful and dispassionate consideration.

I have before me a memorandum to the effect that we have not as

yet received from your office the final accounting which we understood you were going to send us in connection with Mr. Band's outgoing expenses to Yenching. You will remember that on November 4 you stated that "As soon as we hear what expenses in connection with his travel have been paid in China, I will send you an account". I have no doubt that this accounting has been held up by a delay in obtaining information from China and am simply mentioning the matter so that it will not be overlooked.

Dear Mr. Garside,

I am sorry that owing to pressure of work at the turn of the financial year I have not replied fully to your letter of March 1st in time for the Annual Meeting of the Yenching Trustees on the 22nd inst. I hope, however, that the following information will still be of interest to you.

The standard rate of personal allowance in China for L.M.S. Missionaries is as follows :-

Married persons	... £364
Unmarried persons	
living alone	... £165
Unmarried persons	
living together	... £135.

These rates are increased by £5 to £12 in the case of residents in Shanghai.

In addition to this there is an allowance for children varying from £18 to £48 according to age and a further £12 a year is paid where children are at Boarding School.

Of the salary £60 in the case of a married Missionary and one-fifth of the salary in other cases is payable in sterling or if drawn in China, at the current rate of the day, the balance is drawn at the rate of 1/9 $\frac{1}{4}$ to the dollar.

In addition to this allowance £15 is allowed

for each Missionary and Missionary's wife as a travelling outfit allowance to be drawn not more often than once in five years. The allowance is \$25 each on first appointment.

Half medical and dental expenses are paid when approved by the Society's Medical Council.

A language allowance is given in China for five years.


Please let me know if any further information would be of use to you. The information given is of course confidential for the use of yourself and the Trustees of Yenching.




Dear Mr. Wannamaker,

My dear Mr. Hawkins:

Dr. Warnshuis turned over to me copies of correspondence he had with you concerning the appointment of a new L.M.S. representative on the Yenching Board of Trustees as soon as a vacancy occurs. He asked me to give you certain additional points of information.

You will have noted that the minutes of the annual Yenching meeting held on April 23 listed the L.M.S. representatives and the dates when their terms of office expire as follows:

<u>Representative</u>	<u>Date term expires</u>
Miss Margaret E. Burton	1929
F.H. Hawkins	1930
S.P. Cadman	1931
A.L. Warnshuis	1932

Miss Burton's term of office nominally expired at the close of 1929, but the regulations of the University provide that a representative shall continue to hold office until a successor has been appointed. So far as I know, the London Missionary Society has not as yet taken action re-appointing Miss Burton or electing someone to succeed her. You will remember that Miss Burton was appointed a short time ago to fill the vacancy created by the resignation of one of the L.M.S. representatives so as yet she has not served more than a small fraction of the normal term of four years. Possibly it was the understanding of the L.M.S. at the time she was elected that she had held office not only for the small fraction of the unexpired term, but also for the new term of four years expiring in 1933. While Miss Burton has been very busy with her work in connection with the Y.W.C.A., she has been genuinely interested in Yenching and has taken as active a share in the work of the Trustees as her other duties permit. I believe that the considerations which led to the proposal of her name a year ago are still valid and that everyone on the Board of Trustees would welcome her continuation as a L.M.S. representative if this course is satisfactory to you, and if you have no one else whom you would prefer to serve as your representative.

Your own term of office expires at the end of 1930 but, of course, we are all hearty in desiring your re-election so there can be no thought of a vacancy there.

Dr. Cadman's term of office expires in 1931. As you know, Dr. Cadman is so busy with his innumerable important types of religious and philanthropic work that he has never been active in Yenching affairs. I believe he is genuinely interested in the University, and he is always careful to acknowledge the communications we send him relative to Trustees meetings, and to send his apologies for his inability to attend. Without doubt the influence of his name as a member of the Yenching Board is of real value to the University. But this is about all he has been able to contribute thus far, and it is an open question whether we should urge him to accept a new term of service or should seek someone to replace him at the end of next year. Since he still has about eighteen months more to serve the question can probably be deferred until sometime next year.

Obviously there will be no early vacancy in the L.M.S. membership unless the Society elects someone else in place of Miss Burton, or one of your other three representatives presents his resignation. I am not sure, therefore, whether ^{there} is much point in discussing the suggestion that Dr. Warnshuis makes that if a vacancy occurs in the L.M.S. representation Mr. Alfred F. Eldridge would be an excellent man for the place. It might be said briefly, however, that, while everyone would heartily agree that Mr. Eldridge is eminently qualified for such a position, and could render extremely valuable service to the University if he would accept appointment, there is some doubt whether Mr. Eldridge would care to accept appointment, and even some uncertainty as to whether it would be wise to approach him with such a proposal.

In 1928 Mr. Eldridge was elected to membership on the Yenching Board of Trustees in the co-opted group. Dr. Stuart was so anxious to have him on the Board that one of the other warm friends of the University who was then a coopted Trustee presented his resignation in order to create a vacancy. However, Mr. Eldridge was so busy with his other duties that he was able to give very little time to Yenching. You will remember that during 1928 all of our Yenching Trustees were frequently urged to help Dr. Stuart in every way in raising a \$500,000 fund he was then seeking. Some of the Trustees had reason to believe that Mr. Eldridge felt we pressed him too hard in urging his assistance in this promotional work, and there was some fear that he felt his appointment on the Board was due to the hope that he might be persuaded to exert more influence on a wealthy friend for whom he is a financial adviser, and who, it is hoped, may some day give Yenching a substantial endowment. When Mr. Eldridge had served only about six months he presented his resignation, and insisted on its acceptance in spite of numerous pleas made to him to continue in office.

So far as I have been able to learn, Mr. Eldridge has not greatly modified the position he held at the time he presented his resignation early in 1929. I have had a brief conversation with Mr. McBrier, who is a good personal friend of Mr. Eldridge, but find that Mr. McBrier has little information as to Mr. Eldridge's personal attitude toward any return to the Yenching Board of Trustees. Mr. Wannamaker has been in fairly close touch with Mr. Eldridge and could express a good judgment as to the desirability from a promotional standpoint of having Mr. Eldridge back on the Yenching Board. Mr. Wannamaker is in Germany this month so I have not been able to discuss the matter with him. If you wish to send an in-

quiry to him his address is Werastrasse 13, Stuttgart, Germany. He may possibly be coming through London on his return to the States next month, and if so, I am sure he would be glad to come to your office and discuss the matter.

The chief danger we must avoid is that of further antagonizing Mr. Eldridge by giving him the impression that we are trying to retain his interest in the University purely in the hope of using his influence to secure gifts from his friends. We must also guard against any intimation of this present discussion reaching his ears unless we agree that we wish to invite him to rejoin the Yenching Board either as a L.M.S. representative or in some other capacity.

I returned to the office last week and have been struggling to settle down to routine work again. I had a most delightful week in London though it was sadly spoiled by the delay of the Berengaria which caused me to miss most of the Cheeloo meeting. I was happy to have the opportunity of seeing you on the few occasions when we met. We sincerely hope that you will find it possible to come to New York next year for the board meetings which will probably be held here sometime during the spring.


I am glad to hear that you got back safely. I only regret I had no opportunity of seeing more of you when you were in London.

My dear Mr. Hawkins:

Let me acknowledge receipt of your two letters of September 30.

Your first letter informs us of the reappointment of Miss Margaret Burton and yourself as Trustees of Yenching University. I will see that our records are corrected accordingly, and that these reappointments are reported to our Yenching Trustees. I know that all the Trustees will be gratified at the action of the London Missionary Society in continuing the two of you as their representatives on the Yenching Board.

We note also your comment as to the insurance rate of the policy recently secured by the Yenching Woman's College. I am bringing this comment to the attention of our Finance Committee and am also communicating it to the field. We sent the field last year the letter you wrote us on the subject of insurance, and I had understood that they had made investigations along the lines you proposed. Evidently they did not follow up the matter as they should.

I am glad to have a copy of your letter of September 30 addressed to the members of the Cheeloo staff with regard to the ruralized program Cheeloo is being asked to undertake. I am sure that this carefully written letter will do much to encourage support of this program by those on the Cheeloo campus who have been lukewarm or antagonistic. I have felt all along that most of the difficulty has been the result of lack of clarity in understanding what the ruralized program for Cheeloo really means, and what it seeks to accomplish.

We have been very much gratified to receive from Tsinan during the last fortnight very encouraging news as to the way in which the new year of work began in September. It seems that if the University can have fairly peaceful conditions under which to work this year, and can be relatively free from disturbing elements without and within from which it suffered last year, we may hope for a year of rehabilitation and substantial accomplishment.

We must have a meeting of our North American Section within the next few weeks. I will bring to the attention of that meeting your letter

addressed to the members of the Cheeloo staff.

I was very much gratified to receive yesterday from the Rockefeller Foundation information that the Foundation has renewed its appropriation toward the maintenance of the School of Medicine for the fiscal year 1931-32. At the request of the field authorities of the University the Foundation is stating its contribution as Gold \$10,000 plus Mex.\$20,000, rather than Mex.\$40,000 as has been the case during the last few years.


that the Minutes of the Board of Managers Meeting reached you in time for the Meeting of the Trustees, although I am afraid that this is somewhat doubtful.

I am enclosing herewith a letter we recently received from Dr. S. Parkes Cadman, tendering his resignation as a member of the Board of Trustees of Yenching University. I have called Dr. Cadman's attention to the fact that this resignation should be addressed to the London Missionary Society rather than to the Board of Trustees since his appointment was made by your Society.

I suppose that, under the circumstances no other course can be pursued except to accept Dr. Cadman's resignation. You would, no doubt, like to have suggestions from the Trustees as to possibilities in choosing a successor for Dr. Cadman. At the meeting of the Trustees on November 19 I informally mentioned this possibility to the Board and asked for suggestions. Thus far I have had no response. The matter is not particularly urgent but it is desirable that Dr. Cadman's successor be appointed in time to attend the annual meeting of the Yenching Board of Trustees next April.

If the London Missionary Society has anyone in mind either in Great Britain, or here in North America, who they think will represent them in a satisfactory manner and could attend at least occasional meetings of the Trustees, we hope you will proceed to elect such a representative in due course. However, if you have no prospective candidates in mind I shall be glad to continue inquiries here.



My dear Mr. Garside,

I thank you for your letter of the 2nd instant. It is very difficult for me to express any opinion as to the action of the Yenching Trustees on the question of the segregation of the School of Religion, as I did not have the opportunity of hearing the discussion which led to their action. I can understand their hesitation if the recommendation of the Field Board of Managers involved much extra expense. That might be a good reason for turning it down. But, on the merits, I am inclined to agree with the recommendation from the Field for the removal of the School of Religion to a site adjoining the University ~~and~~ Campus, and I think had I been present at the Trustees Meeting I should have voted for the acceptance of the recommendation, apart, of course, from the question of expense. What they propose seems to me to be the best course in all the circumstances. Moreover, I think in dealing with Yenching, the Trustees should, as far as possible, fall in with the proposals which come from Peiping, with the backing of Dr. Leighton Stuart and his Chinese associates. I have tremendous confidence in Dr. Stuart

and a keen appreciation of the sensitive susceptibilities of the Chinese connected with Yenching.

With regard to an L.M.S.Trustee in the place of Dr. Cadman, I have not had any brilliant inspiration up to the present. There is no immediate hurry for filling the post, and instead of bringing the matter before the China Committee on the 27th instant, I propose to defer it to the next Meeting on the 24th March, so as to give further time to hear from you on the subject. Has the A.B.C.F.M. any representative in New York who would be suitable?

My dear Mr. Hawkins:

Let me acknowledge receipt of your letter of January 12.

We warmly welcome your comments on the action of the Yenching Trustees in regard to the important question of the segregation of the School of Religion. I am extremely sorry that we were not able to communicate with you far enough in advance of the meeting to permit your sending your comments in time for presentation to the meeting of the Trustees. The question is both an important and a delicate one, and it is easy to see how serious difficulties might grow out of any decision the University might make.

It is quite true that the financial situation of the University is now such as to make it highly improbable that at any time in the near future sufficient funds could be found to carry out the segregation of the School of Religion as proposed by the University. On this ground alone the Trustees would probably have found it necessary to withhold their approval of the proposal.

However, most of our Trustees felt that the proposal also involved some very important principles which could not be side-stepped. The trend of the discussion at the meeting was that the Trustees felt that the Ministry of Education was so thoroughly unjustified in suggesting the segregation and removal of the School of Religion that it would mean a serious loss to the Christian character and prestige of the University for it to accede to such a proposal. The Trustees felt also that the same question was of such direct interest to other Christian Universities in China now seeking registration, such as Cheeollo and West China, where schools of religion are an integral part of the campus and could not be removed without great expenditure, that for Yenching to accept this proposal would put several of our other institutions in a very difficult position.

In taking the action they did, the Trustees invited the field to present further facts if it so desires, and indicated that the Trustees would be happy to go into the matter further if additional correspondence with the field, or further consideration of the matter, indicates that their decision was not the wisest one. If the question comes up again

for discussion I will see that your comments on the subject are presented to the Board. We certainly wish that you might find it possible to make a trip to New York sometime during the coming months so that you could be present at the annual meeting of the Yenching Trustees, or at some special meeting we might be able to call to fit in with your convenience. Both Yenching and Cheeloo would profit greatly by your presence at the meetings to be held here in New York this year.

We have not made any further progress in the direction of suggesting a suitable successor for Dr. Cadman. Dr. James L. Barton of the A.B.C.F.M. has just returned to New York after a prolonged visit to the Near East. I am sending him a note in regard to the matter to see if he can suggest any suitable representative.

I note that you are asking Dr. Barton for any suggestions for a new L.M.S. Trustee.





My dear Mr. Hawkins:

Let me acknowledge receipt of your note of March 3 to which you attach a copy of a letter you wrote Dr. Armstrong on the same date.

We are happy to learn that you and Mr. MacLennan will be available for a meeting of the Cheeloo Board of Governors during the week beginning September 20 as we have learned that this week will be much more convenient for Dr. Armstrong than would the preceding week. Also, the latter part of September is usually more satisfactory to the majority of our Governors than the early part of the month.

Preliminary inquiries indicate that September 22 will prove the most satisfactory date for the Cheeloo meeting, and I am at this time sending out inquiries to all members of our North American Section in regard to their availability on this date. If any serious obstacle to the meeting on September 22 should be encountered, September 25 appears to be the second choice, with September 21 a third choice.

As soon as I have heard from most of the members of our North American Section I will send you a more definite report.

Let me acknowledge also receipt of your letter of February 27 in which you comment on the suggestion of Mr. Hodgkin's name as one of the L.M.S. representatives on the Yenching Board of Trustees. We are pleased that this suggestion is so satisfactory to you. I know that Dr. Hodgkin would prove to be an unusually fine member of our Yenching Board of Trustees.

We are planning to hold the spring meeting of the Yenching Trustees on April 15. Dear Dr. Stuart,

I write to thank you for your letter of the 20th ultimo, which reached me on the 11th instant, and for the copy of your Report to the Board of Trustees to be considered at its forthcoming Annual Meeting. I am extremely sorry that I cannot be present at it, although I expect to be in New York in the Autumn, and possibly may have an opportunity of meeting the Trustees during my visit.

I very much appreciate your kindness in sending me a copy of the Report, which certainly raises most serious issues. Its perusal makes me regret all the more my inability to be present at the Annual Meeting, to share in the grave discussions which will then have to take place.

I am sure you will not expect me to comment on your Report in detail. It certainly discloses a very grave situation, which will call for most anxious thought on the part of the Trustees. May I say how warmly I appreciate the spirit in which the Report is written, and how sincerely I sympathise with you in the very heavy burden which you are carrying.

Having said this may I make one or two general observations?

(1) If Missionary Societies, owing to bad times, are unable to maintain their existing work, on account of deficiencies in men and money; they are forced to curtail their work, and it seems to me that the Yenching University must be subject to this same necessity; in other words, it must cut its coat according to the cloth available. Every Missionary Society I know of, on both sides of the Atlantic, is at present passing through a most difficult time financially, and the possibility of the Missionary Societies who are partners in Yenching doing more for the University than they have done in the past, is a very remote one, not from want of will but from want of means. There is, unfortunately, a tendency for Missionary Societies to regard cooperative work of the type of Yenching, as not so much its own work as that which it ~~is~~ carrying on alone, and I am sure that if the L.M.S. is to cut down, I shall have a great struggle to prevent our Directors from beginning by withdrawing from some of their Union enterprises. I know that there are members of our Finance Committee who, if they saw your Report, would say "By all means adopt the suggestion of closing the University. This would be a financial relief to us." And if this were done I am very much afraid it would be an extremely difficult thing to get back L.M.S. support when the University opened again.

(2) I want to be as frank with you as you have been in your Report. Speaking for the L.M.S., and I suspect for its American

partners, I would say that one of our main objects in cooperating in University work of this sort, is that it is necessary for the training of Christian leadership, and Missionary Societies are apt to think of that leadership in the terms of pastors and preachers for the Chinese Christian Churches. The one thing that troubled me more than anything else on my last visit to China, was the weak condition of Theological Colleges and their inability to provide a supply of well-trained Christian Church leaders, and I felt this more at Yenching than anywhere else, because of its very large theological staff, and its infinitesimal number of theological students. I dealt with the subject at length in my Report to our Directors. The same remarks apply to very nearly all the Theological Colleges in China today. To put it shortly, they are not delivering the goods. I fully appreciate the factors which enter into this matter, and especially the economic conditions which make it difficult for Chinese Christian Churches to offer adequate stipends. But the fact remains that Missionary Societies are profoundly disappointed with the out-put of Christian pastors in relation to the amount of the number of men, and the amount of money, they are putting into this department of the missionary enterprise.

(3) The only general criticism I would venture on your Report is that there seems to be an inadequate recognition of the economic conditions prevailing in America and Great Britain at the present time. It is not for want of will, or effort, that the financial

support of Yenching, and other similar institutions, is not adequate to their needs. The efforts that have been made in America, in recent years, to provide more adequate support for Yenching, are beyond praise, and although they have met with a wonderful amount of success, the total result of them has been insufficient to provide the finance for carrying on Yenching on the big scale on which its work has been planned.

There is much more one could say. I am deeply concerned at the number of resignations with which you are faced, and still more at the hint contained in the last sentence of your letter. Again let me say how warmly I sympathise with you in the great burden you are carrying. Personally I feel very strongly indeed that you ought not to be expected to return to America from time to time to raise money. I have always felt that this was radically wrong; you certainly have more than enough responsibility in Peiping.

Please forgive the candour of this letter, and excuse the dogmatism of hasty phrasing.

CONFERENCE OF MISSIONARY SOCIETIES IN GREAT BRITAIN & IRELAND

REPORT of China Committee on
proposals for the formation in
this country of an association
of Christian Universities in
China: for consideration of
the Standing Committee on
Friday, 13th March 1931.

At a recent meeting of the China Committee of the Conference of British Missionary Societies, suggestions were made for the formation of an association of Christian Universities in China, with a view to closer co-operation and co-ordination between societies engaged in Christian higher educational work in that field. The societies and institutions concerned are:

L.M.S.	have a share in	Yenching, Shantung, East China, Central China, Lingnan.
C.M.S.	in	Fukien, West China, Lingnan, East China.
W.M.M.S.	in	Shantung, Central China, Lingnan.
S.P.G.	in	Shantung.
B.M.S.	in	Shantung.
Friends	in	West China.
Presbyterians	in	Shantung.
Church of Scotland	in	Moukden Medical College.

At present the Shantung Christian University alone has a British section of the Board of Governors and an organisation for creating special interest in the work of that University.

Only a handful of specialists are at present familiar with the work of higher education in China, and it is thought that a good deal of interest could be aroused in that work in educational circles in this country. It was therefore suggested that an associated scheme should be formed to build up a constituency in this country specially interested in the work of higher education through which the institutions in China might be strengthened, their needs for personnel and finance advocated, and through which arrangements might be made for special visits of British educationalists to China; and generally for promoting interest in University Education in that field.

The China Committee felt that before such a scheme could be adopted they ought to be satisfied (a) of the soundness of the proposals;/

proposals; (b) that the necessary finance could be provided without making any appeal to the societies or throwing any burden on the co-operative budget; (c) that a suitable man to carry on the work could be found; and (d) that his services and the necessary finance were available for a sufficient period to work out a satisfactory experiment, which the Committee considered should not be for less than two years.

The whole matter was remitted to a Sub-committee which went very fully into the suggestion. They unanimously approved of the proposals for a Scheme, and were able to report that the necessary funds would be provided, and that a suitable man was available as Secretary. On their report the China Committee now beg to submit the following recommendations to the Standing Committee:

- (1) That there should be formed in this country an Associated Christian Universities in China Scheme, with headquarters at Edinburgh House for the purposes above set forth, for an experimental period of two years.
- (2) That the Scheme should be placed under the direction of the China Committee of the Conference of British Missionary Societies, who may act in their discretion through a sub-committee, and with power to co-opt for that special purpose.
- (3) That Mr Wm. G. Sewell, a missionary of the Friends' Service Council, recently a member of the staff of the West China University, Chengtu, be appointed full-time secretary of the scheme for a period of two years. Mr Sewell has expressed his deep interest in the proposals and his willingness to entertain an invitation should it be extended to him.
- (4) That the Standing Committee accept the offer of the Friends' Service Council to lend Mr Sewell for this purpose for a period of two years. The Friends' Service Council have expressed their willingness to pay Mr Sewell's full salary until 30th September of this year, and thereafter to bear a reasonable proportion thereof.
- (5) That a budget of £500 for the first year and £650 for the second year be approved of: these amounts being provided or guaranteed privately.
- (6) That the home organisation and secretarial staff of the Shantung Christian University be taken over by the new scheme and run as part thereof. It is proposed that the University should pay into the budget of the scheme the annual sum they now expend/

expend on their organisation in this country. The scheme has been fully considered by the British section of the Shantung Christian University Board and has been approved of by them.

(7) That the new scheme should make every effort to secure renewal of the subscriptions now given to the Shantung University, without any deduction in respect of expenses, but renewal of these subscriptions is to be in no way guaranteed by the new scheme. Any failure in the renewal of contributions to the Shantung University would not create any preferential charge against any funds which may be collected by the scheme.

(8) That subject to adjustment of details between the China Committee, the Friends' Service Council and Mr Sewell, the new scheme should be put into force as from 1st April next.

(9) That the thanks of the Standing Committee should be voted to the anonymous donor who has made the arrangement possible, and to the Friends' Service Council for the generous arrangement under which they have offered to lend Mr Sewell to the scheme for a period of two years.






