

My dear Mr. Stewart:

I enclose herewith confirmation of telegram sent you on Saturday with reference to your appointment. The Committee on Instruction has approved your appointment, and we are very glad that we were able to complete the process before it was necessary for you to start for Colorado.

There are two points to which the Committee felt you should give some attention before you go. One of these is the securing of some definite training in the process of teaching English to foreigners. You no doubt may feel that in stressing the requirements for technical ability, I may seem to have overlooked the fundamental missionary purpose which you have. This is not the case as I have been assured by others who have known you of this purpose on your part, but I have felt that your success in carrying out your purpose and ours would be really hindered if you should weaken the standard of the work for which you were responsible as an expression of your missionary interest, by lacking suitable preparation for it. I have noted errors in spelling in your letters and applications and have charged these errors to haste, but Professor Breece. will be very greatly disappointed if he does not have real help of a genuine effective kind in the teaching of English. This work is, I know, a matter of heavy drudgery, but it will bring you into contact with a large portion of the student body, and through it you have an opportunity to stimulate the skill and the usefulness of those who are to be the future leaders of China. I recognize the financial problem you have in securing this training, yet believe that a good deal can be done if you will, and that, in one way or another that you may find possible, either by a correspondence course or by special study of your own, guided by someone who is competent really to guide you aright, you can fit yourself better for this phase of your work. I suggest you follow this matter up by correspondence with Prof.Breece and secure his counsel.

The second point involved is the matter of your putting yourself in the best possible physical condition. While the report of the medical examiner is O.K., he has urged that you take some time

for recreation and good outdoor exercise in order to build up your reserves. You are going into a situation where some of the health factors are perhaps a little more negative than they are here and where there will be much hard work to be done while in Yenching. You may no doubt be able to as ociate yourself with athletic work which will help to keep you in trim while you are there. In planning your summer to provide for these two things as we earnestly hope you will, you can figure on not needing to leave Johnstown before the last week in July. If possible I will find out what steamer the Breeces are going to take and endeavor to put you on that boat.

You should have vaccination against smallpox and inoculation against typhoid and paretyphoid. Attention must be given to having your teeth in good order, preferably also having X-ray of the teeth. The cost of the inoculations and the matter of your teeth you will have to take care of as a personal item. Please advise us as to when you have completed these inoculations and vaccinations.

I enclose copies of our standard Travel Directions and of the Peking University salary schedule, and will send you the employment agreement for you to sign shortly.

Application blanks which you should fill out and return to me, and I will take care of the necessary endorsements. On these blanks you should apply under rule P. In putting down your denomination, do not put down "reking University", but "Methodist Episcopal". You will also note that you are giving your entire time to religious work and are supported by salary only. Please take care to fill out the blank completely and we will take care of the rest of the process and see that you have these certificates for your travel.

I want to congratulate you upon the appointment and the opportunity which lies before you, not only for furthering the cause of education, but for helping to make dominant in the eastern world the spirit and life of our Lord. There are many ways by which those who serve Him express their devotion to Him, ways which cannot always be forecast until the opportunity comes before one. The Trustees of Peking University, in making this appointment, expect you to maintain, both in your professional work and in your personal life, the high standard of those who have given themselves solely to His cause. We crave for you a long and satisfying experience in making known to others your own experience of fellowship with Him and the increasing enrichment of that experience as you share it with others.



Dear Dr. North:

You may be certain that I am very much pleased at the speedy confirmation of my Peking appointment, and that I am determined to fit myself for my responsibilities in the best possible manner. In you letter of yesterday,, you suggest that I take the course in Phonetics which is being given at Smith College. I agree that it is a course that I should take if possible, and had I known of it last week I could have done so. As it is now, I have taken a position here for six weeks and it would be unethical for me to give it up immediately. I am, however, taking up a study of Phonetics, and I will send for the text books which are recommended. I am also writing to Professor Breece for further suggestions.

As you know I am planning to be married before sailing, but that is not quite definite. This will probably mean that I will leave Johnstown about the fifteenth of July for Denver, which is the home of Miss McKlveen, altho she is teaching in Portland at present. I would appreciate it if you could make the necessary financial arrangements with this in mind. I might add that I do not wish this matter to be known by my friends at present because of the uncertainty.

You will find enclosed the western Clergy Rate Application blank. I already have the eastern certificates. Will you kindly send instructions regarding the shipping of freight? May I ask also if it is now necessary to have income tax receipts? I know that the law was repealed once-in 1923.

I will naturally follow your advise concerning exercise. It is my custom to play some tennis nearly every day. I do hope that I may be assigned to assist in athletics in Yenching as that has been a part of my regular work for four years.

THIS AGREEMENT, entered into by and between PEKING UNIVERSITY and MAXWELL S. STEWART, this and day of July, 1926

WITNESSETH:

That Peking University hereby agrees to and does employ MAXWELL S. STEWART for the position of teacher of English for a term of five years, upon the following schedule of salary and allowances:

- 1. Salary at the rate of Gold \$840. or Mexican \$1,680. per year, beginning on day of sailing;
- 2. An outfit allowance of Gold \$250.
- 3. Travel expenses from Johnstown, Pennsylvania, to Peking, China, by the most direct route and for the full five-year term, the University will also pay travel expenses from Peking, China, to the home address above;
- 4. Residential quarters at Haitien (Peking West), China;
- 5. Medical attendance for sickness without charge. One-half dental bills if incurred with prior consent;
- 6. In the case of life contract, a furlough of fourteen months including travel will be granted after the first five years, with travel expenses to and from his home in the United States of America.

The University, upon due notice in writing, may terminate this contract at any time, upon the payment of a sum equal to three months' salary from the date of said termination, and full travel expenses to the address given above, by the most direct route.

MAXWELL S. STEWART hereby accepts the said employment and the foregoing terms and conditions, and agrees, that if for any reason he resigns the position before the expiration of one-half the term of this contract, he will reimburse the University for the cutgoing and outfit expenses less such proportion of them as the time of actual service bears to one-half the full term of service as above set forth, and that in case he resigns before the completion of the contract, no payment shall be made by the University for travel expenses to the United States of America, except in case of his serious illness.


